## **INTRODUCTION AND WELCOME**

2. The meeting commenced at 7:05pm.
3. Chair welcomed the public to the Rotherhithe Community Council Meeting and outlined housekeeping matters relating to the venue.

## **APOLOGIES**

4. Apologies for lateness were received from Cllrs Hook, Porter and Yates.

## **NOTIFICATION OF ANY ITEMS OF BUSINESS WHICH THE CHAIR DEEMS URGENT**

5. Chair advised of the following late items to be considered:

- i) Revenue Programme pilot
- ii) Watchers Project Space

## **DISCLOSURE OF INTERESTS AND DISPENSATIONS**

6. There were none.

## **MINUTES OF PREVIOUS MEETINGS**

7. The following changes were agreed by Members:

Paragraph 54 should read, "...that the Watersports Centre operated..."

Paragraph 90 should read, "...that the algae on Surrey water was..."

Cllr Hunt was present in June, so should be deleted from the Apologies list.

A further change was needed concerning paragraphs 72 – 74 and this would be agreed at the next meeting in September 2004.

## **UPDATE ON ISSUES FROM PREVIOUS MEETINGS**

- 8. Gill Davies said that regarding the bicycle and trolley park - A meeting had been arranged to discuss the proposal.
- 9. Gill said that regarding the money for housing schemes - There was £425,000 to be divided between all the Housing area offices.
- 10. Jeremy from the community said that the algae at Surrey Water had not improved and that it was now smelling badly. Surrey Water was full of algae and green slime.  
  
Gill said that they were looking at treatment for the bore holes.  
  
Barry said that it looked like someone had thrown algae killer. He said that he'd been told someone would have a look but nothing had been done. He added that the fish were still in danger.
- 11. Chair said that she would follow that up.
- 12. John Hemmings thanked Chair for the letter to the Borough Commander on the re-opening of the police station. He requested that replies also be



published.

Chair said that she had received an acknowledgement.

John Hemmings said that the local press had been campaigning for a full-time police station in Camberwell. It was time to start talking to the Met. Police at the highest levels. He said the idea had huge support including the officers on the street and that an overall approach was needed for the borough.

13. Chair said we should wait and see first the response from the Borough Commander.
14. Cllr O'Brien (Executive Member for Housing and Community Safety) added that he had discussed the matter with someone who held different views. He said that he would pursue the matter on behalf of local residents.
15. David Meagher proposed that the community council organised a clean-up day. He said that if a volunteer day was organised he would send his staff down.
16. Chair said that she would look into that.
17. Cllr Neale asked if there were any developments with the Nike 10k run ?

Gill confirmed that the race was still going ahead as planned

## **UPDATE ON POLICING ISSUES**

*Inspector Johnson gave his report and invited questions*

18.
  - Since last month there had been no further reported flasher incidents in the area.
  - Four raids on the Silwood estate had resulted in closures and anti-social behaviour orders.
  - He reported that Albion Street traders were now on board.
  - Regarding motorbikes there was a no pursuit policy in the Met. Police due to the risks to riders and other road users. The Police Reform Act had given powers to issue warnings. Ten warnings had been issued and one vehicle seized. He asked residents to contact him if they were aware of problems.

- He said that if they get an address officers go and speak to the offender's parents. No-one had come back as a repeat offender.
- During the school holidays there would be education on how to ride motorbikes responsibly.
- Three PCs and three PCSOs were being trained for the peninsula. That was in addition to the beat officers and the community wardens there too.
- Joint patrols were planned with community wardens working with the police. Traffic officers would return to the Woodland. Also there would be police on bicycles. Traffic officers would operate around the loop with speed guns.
- Re dispersal orders. The police had strong powers to deal with youth disorder. The police were looking at dispersal orders for youths on the peninsula in the next few weeks with police holding powers where more than two were together.

*Inspector Johnson was very positive about the current situation.*

19. Cllr O'Brien asked about crack houses ?

Inspector Johnson said that twenty six had been closed since the start of the year. Southwark was now a top performing London borough. Perhaps only Westminster was out-performing us.

20. A member of the community said that their residents committee were trying to get in touch with Neighbourhood Watch.

Inspector Johnson said that it was strong in the south of the borough.

21. David Meagher said that the community council should invite the new supervisor to talk to a future meeting. Chair said that was a good idea.

### **CLEANER, GREENER, SAFER (CGS) PROGRAMME**

22. Chair explained that about 40 schemes had been put forward and Rotherhithe had a budget of £315,000. Some schemes not selected would go forward to next year's CGS file.

23. Chair said that the final list of 9 schemes were chosen under three criteria –

- i) Result of voting on Maps with stickers of residents at the June community council meeting,
- ii) Input of Ward councillors,
- iii) Geographical spread of schemes across the 3 wards.

24. Chair said that the 9 schemes on the approved list had been given an approximate cost. These were rough estimates and officers could revert to the reserved list in the event of some money being left over.

25. Chair explained that the CCTV schemes had revenue cost implications but Rotherhithe had revenue funding and some of those proposals may go forward.

*Chair invited questions*

26. John Hearn said that as a cyclist he was concerned about the opening of the park (Scheme no. 43) and the problems of youths during summer holidays. He said that they climb into the farm. John said that if it were to close it should be done in conjunction with people at the farm. Also he was in favour of opening up the path.

27. Chair said that the farm had been involved in consultation and that part of the cost of the scheme would be making sure that the farm was secure.

28. John Nosworthy asked about full consultation and the effects of revenues on local communities. He said few of the proposals were about lifestyle. He asked that it be taken into account and said he would ask further questions in the future.

29. Chair said that when the ideas were put forward there was not a great deal of consultation. Discussions took place about the implications of the schemes and an approved list had since been agreed.

30. Bart from the community said that regarding the lights proposal, they were never vandalised. He asked, why waste money on lights that are ok at the present time ?

Chair said that perhaps residents thought differently.

## **TOURISM**

*Lisa Holmes gave a presentation*

31. Lisa explained that the tourism strategy was currently being written and feedback on issues was being sought from residents.

She said tourism was established in the Bankside area and had grown with the Tate Modern developments. They were now trying to get further into Rotherhithe and the rest of Southwark.

The Tate Modern and the Millenium Bridge had changed the way people come into the area. Tourism brought in about £210 million and employed over 3,000 people.

The Tourism team had grown from one member last year to five currently. Lisa said that 84% of tourists were day visitors and they should be encouraged to stay longer and increase the benefit to the area.

The tourist centre had opened in March and welcomed 200-300 visitors per day. It provided a face to face service of useful information, leaflets and theatre tickets. It was open six days a week between 10am - 6pm. It employed two full-timers and from a pool of students and locals.

32. Bankside Shopping Guide was funded by the Bankside marketing group. They hoped to do a similar thing for Southwark attractions Southwark wide. Lisa said they were working with the YHA, Brunel and other groups.

There were 4 priorities for 2004-2009

1. Visitor management - Looking at signage, public realm improvements, tackling crime and grafitti, and illegal trading.
2. Promotion in the market – Marketing, trade shows, destination branding, website, publication and events.
3. Partnership Working and Tourism Development – Visit London, Visit Britain, London Development Agency.
4. Training and Employment – South Bank, Springboard.

Lisa said they were working with fashion and textile industries and aiming to

get more young people involved in Tourism.

*Lisa asked residents for their input on the issues*

33. John Hellings said that Southwark's London Dungeon, was London's number 3 attraction. He said that the river was the loveliest characteristic the area had. Surrey Docks Watersports Centre could do with sprucing up and that we could aim for a Rotherhithe regatta for rowing sculls. He said it would take a lot of co-ordination but could be linked to the Rotherhithe festival. Rotherhithe could be the new Henley-on-Thames.

34. Mrs Elliott queried whether tourists would come to the area as there were not enough toilets. She said something should be done about the lack of facilities.

Lisa Holmes agreed and said that a recommendation had been made on that point.

35. A member of the community said that they backed the idea of a Rotherhithe bridge and that they direct many people to a hotel they cannot find. They also supported the idea of a cable car to Canary Wharf.

36. Lisa said that the idea of a bridge from Rotherhithe to north of the tunnel was a good one. Also that they were looking at signs for hotels and attractions.

37. Gill Davies said that in terms of signage that had been discussed a few meetings ago and all signs had been identified in the area as part of a pilot. The plan was to now look for additional funding to expand the process to the rest of Rotherhithe (beyond the peninsula). The aim was to convey history and quality through signage.

38. Alan from the community said that there was a lot about Bankside but had anyone tried to push a wheelchair ? He said there were no steps or ramps and the handicapped cannot get anywhere.

Lisa said that they were working with the Cross River partnership and looking at the issue. With the Disability Discrimination Act coming into force all attractions need to be accessible.

39. David Meagher (YHA) said that he would like to be involved in the See Britain scheme.

40. John from the community said that as a cyclist he thought there was big potential for cycling tours. There was a lot of history around the docks and there should be leaflets on cycling around Rotherhithe.

Lisa said they were working with London bikes and they were putting together guides and ongoing tours.

41. Robert from the Brunel museum said he would like to lobby for a river pier for old Rotherhithe and that it would be a wonderful draw of people to the area. Also that it should be close to the Rotherhithe tube station and part of an integrated transport system.
42. Gill said that members recently agreed to expand watersports activities in the area and that she supported the idea of a regatta.
43. A member of the community said that they had heard the East London line would lead to the closure of a station and that if Rotherhithe was affected then the community council should protest vigorously.
44. Chair said that the community council had strongly resisted a station closure. Transport for London were considering expanding the East London line and expanding capacity. There was talk of Rotherhithe and Wapping closures on the grounds of safety for evacuations. Everyone in the area supported calls to block closure plans.

David Meagher said that meetings had taken place but he understood that it would stay open as others in London were smaller.

45. Chair said that she would report information on any proposed closures.
46. Sylvia from the community asked about wildlife in the area ?

Lisa said that they would find ways to protect the wildlife.

David said that the wildlife had not been put off by dragon boat racing in the past.

47. John from the community asked about The Angel pub on the river. He said that it used to be a nice pub but no more and that everyone was in favour of the owners doing it up. He also thanked the meeting on behalf of the Rotherhithe festival.
48. Barry from the community said he had dealings with London underground and they had given assurances against a closure. He said one part of getting the Jubilee line was that they would not close it.
49. A member of the community said that Surrey Docks Watersports Centre (SDWC) needed refurbishment and asked if a pool was part of a masterplan ?

Chair said that she was unaware of a pool at SDWC. At Canada Water it was part of a plan.

50. Gill said that Members had given officers a steer on a leisure centre including pool. A series of feasibility studies were being undertaken.

51. David said that the Angel pub was closed and covered in scaffolding.

## **REVENUE PROGRAMME PILOT**

*Donald Forde gave a presentation*

52. Donald explained that it was a new source of pilot funding for three areas Rotherhithe, Peckham and Dulwich. The Rotherhithe Community Fund was £296,000.

What does it mean ?

Proposing for each community council area:

- a major programme funding stream to support a few big project ideas (£100,000)
- a community initiatives grant scheme based on allocations of up to £5,000

A key issue:

Very much to the discretion of the Chairs / Community Councils how they want the process rolled out in their area.

What kind of criteria ?

- Would have gone through a sound appraisal to ensure project ideas could be delivered on the ground
- Not duplicating other funding such as Cleaner, Greener, Safer programme (CGS) or what the Council should be doing anyway
- Not leading to the appointment of permanent posts
- Can be spent in the current year
- Developed / agreed by the Community Council

How will the pilot be judged ?

- Inclusiveness: how all sections of the community have been actively involved
- Innovation: new ways in addressing important local priorities
- Management: getting things delivered on time and within budget
- Satisfaction: How happy people are with the process or end product

Some possible examples

- Providing additional support or equipment for youth activities
- One-off events celebrating the area and its people



- Small scale environmental improvements that were not eligible for CGS
- Sponsorship of community groups for things like Southwark in Bloom

53. Donald explained that Revenue was more about events and activities. Revenue was the other side of Capital. Also the money needed to be spent in the current financial year and should not cover things that the Council was already doing elsewhere.

54. Chair asked residents to read the circulated paper and that the item would be given further consideration at the meeting in September (28/9/04). Also that there could be a meeting in October dedicated to the programme and hopefully decisions on specific items in November.

*Residents were invited to speak to Donald in the break.*

## **WATCHERS PROJECT AT COLEMAN PROJECT SPACE**

*Nicoline van Harskamp gave a presentation*

55. Nicoline explained that she was the artist in residence at the Coleman Project. She had been asked to run a summer project that would result in an exhibition in September.

Nicoline was looking to produce 50 facts about Rotherhithe and Bermondsey. These could be anything – light, trivial or serious and they will be put in a publication. Nicoline asked people to look at the flyers and to speak to her if they had questions or contributions.

She said that there would be an introductory event on 14<sup>th</sup> August 2004 and more in the future.

## **BREAK – 20 MINUTES**

## **CANADA WATER SUPPLEMENTARY PLANNING GUIDANCE**

*Kate McKessar (Planning policy officer) updated residents*

56. Kate explained that in November 2002 the draft supplementary planning guide (SPG) had come up for public consultation. There would be a further period of six weeks formal consultation from October 2004. Canada Water was a key matter including protection of the Canada Water basin.

Kate invited people to take copies with them and call her team if they had any

comments. There would be an opportunity to put in a formal submission during the six weeks from October. She said that if anyone wanted more information they should put their name on the mailing list.

57. Tim Cutts said that the team's contact details were on the draft copies and that anyone who had made a submission on the prior draft had been sent a copy.
58. John Hellings said that he was one of two elected private residents. He said they were having their Annual General Meeting in September and asked that someone from the planning team come to the next available meeting of the Forum. He added that none had read the draft document yet so it was too early for comments.
59. Kate said the latest version was not the final one but it was 90% complete. Also that she would come to the meeting in September 2004.

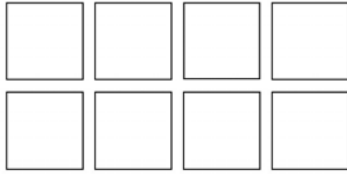

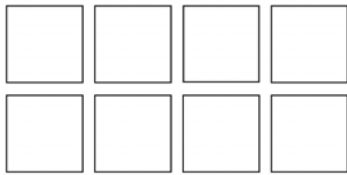

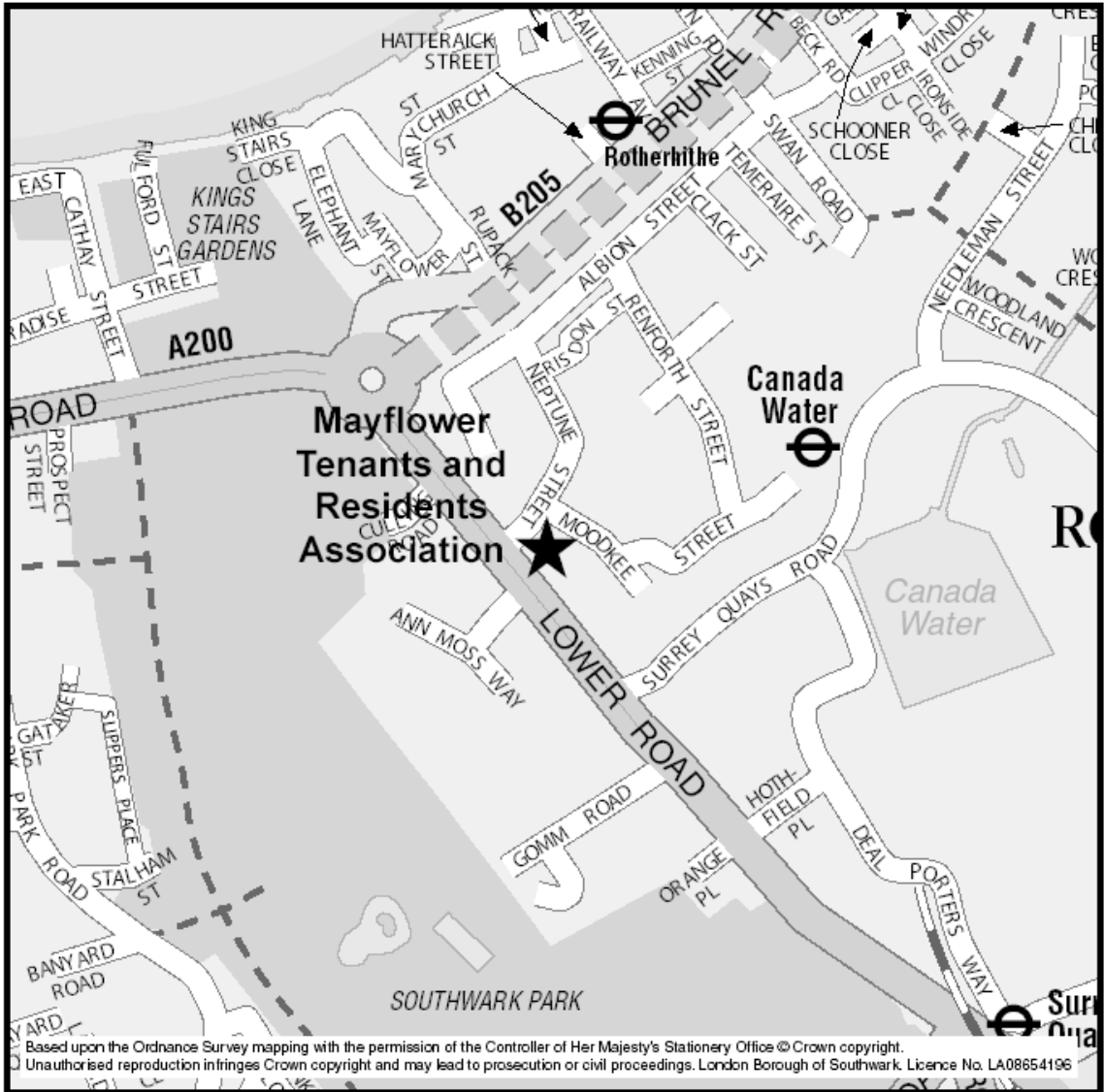
