# Modifications to the Unitary Development Plan (UDP) & Annual Monitoring report

Sarah Beuden, planning & regeneration policy officer gave a presentation on the modifications to the UDP and the annual report. She explained there is an emerging Southwark plan which provides the framework for all land use and development in the borough including the council's planning policies, which are used to determine planning permission. The plan will replace the 1995 UDP (the framework for all land use and development in the borough); as a result, the council has made modifications to it and consultation on these proposals from September 1 2006 to October 13 2006. Dave Swaby, licensing officer, provided a presentation on the new licensing legislation, which considers issues concerning late night cafes and other similar establishments. The council is currently reviewing their licensing policy and gambling law so they can define those areas that should be designated and the ones not suitable for these purposes. The presentation was given as a way of inviting comments from the public on the legislation.

### Southwark community games

Tim Hetherington from Parks and Sports gave a presentation on Southwark community games and how you can get involved. The games are a programme of year-round sports coaching and competition for young people between the ages of eight and 16 years. They take place in schools, after school and youth clubs, housing estates as well as parks and open spaces.

### It also creates

- new opportunities for young people to participate in sport
- new opportunities for a healthier lifestyle
- leadership amongst young people
- the opportunity for young people to excel at their own pace and at whatever level they choose

This year it has involved:

- 10 full-time, community sport coaches
- 8000 young people from the borough
- all Southwark schools
- sports events in Dulwich, Peckham Rye and Burgress parks
- working with numerous organisations, agencies and communities to make it happen

# Dulwich Hospital – heritage features, planning protection & demolition plan

Chris Bull from the Southwark NHS Primary Care Trust (PCT) spoke about the proposals for Dulwich Hospital and the development of a community hospital in Dulwich. This is being supported and funded by private and public partnership organisations. The PCT are also receiving advice to ensure they are consistent with planning law. He said there were no plans at present to demolish the chateau block and if there were any for this part of the site, the public would be fully consulted.
