## Community Wardens – Now patrolling the Newington Estate

The area and number of Community Warden patrols for the Walworth area has expanded to include the Newington Estate and more patrols on the Heygate and Browning estates. Recent success of their work has included helping the police close down a crack house, limiting the use of fireworks and breaking up groups of youths to help making the area a better place to live for all residents. Community Wardens are out in your community 14 hours a day, 7 days a week. Their success increases with information given by you. ## Police update

There will soon be three full Safer Neighbourhood Teams (SNT) in Walworth with the Newington SNT to be fully staffed by April 2006. Recent work of the SNTs includes a moped and small motorcycle initiative. The recent problems in Burgess Park have resulted in police taking the motorcycles off the offenders and this action by the police will continue throughout all areas of Walworth. The East Walworth SNT has been looking into the East Street Markets over the Christmas period. Their work has resulted in less pick pocketing reports and an increased detection of drug offences in the area.

## Traffic feedback - what you had to say

At the last Walworth Community Council meeting in November the transport department ran a workshop to get your opinions and ideas on improving traffic and transport around Walworth. You raised enforcement within the 20mph zones, vehicle speeds, parking and cycling on pavements. You thought more focus could also be placed on enforcement and education as a method of improving conditions for all including vehicles, cyclists and pedestrians.

### Key issues raised by residents of Walworth Community Council

- Cross River Tram is important to improve public transport choice within the area.
- Congestion on Camberwell Road/Walworth Road and New/Old Kent Road creating rat running through the area.
- Difficulty for people accessing bus stops, getting onto buses, poor pavement conditions, street clutter particularly on Walworth Road.
- Poor bus driver behaviour including not stopping directly at the bus stop, not giving enough time for passengers to get on and off the bus, and not facilitating disabled access to buses.
- Opportunities to make the area more permeable for cyclists, such as two-way streets for cyclists and secure cycle parking particularly near retail areas.

<b>Q5</b>	<b>Item 11 What powers do the Community Wardens have in relation to mini scooters?</b>



	The main responsibility is with the police but the Wardens gather information on individuals, give informal warnings and inform the drivers of their legal obligations and actions.
<b>Q6</b>	<b>Item 11 Will you consider the option of Community Wardens patrolling in smaller groups?</b>
	The present policy is for Wardens to patrol in pairs. We will try to split up patrolling where possible but there are safety issues that need to be considered.
<b>Q7</b>	<b>Item11 What parts of Newington Ward are being patrolled?</b>
	At this stage only the Newington Estate is being patrolled by Community Wardens.
<b>Q8</b>	<b>Item 12 Have the new licensing laws caused any problems?</b>
	The police informed they had not seen any evidence of increased poor behaviour linked to the new licensing laws.
<b>Q9</b>	<b>Can you please provide an update at the next meeting on public toilets?</b>
	The Chair agreed an update would be provided.

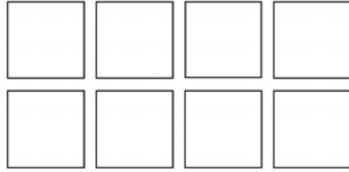

	<p>On Wednesday 4 January at the Walworth Community Council a request was logged to review the road markings on the East Street, SE17, one-way system to ensure they are clear to drivers.</p> <p>A site visit was carried out along East Street one-way system and at its junctions. The condition of the following road markings at each junction on East Street was noted to be in poor condition. The information has been passed to Steve Callaghan, Street Care Manager, for action.</p> <ul style="list-style-type: none"><li>• East Street - one-way arrow markings</li><li>• Walworth Place - junction and right turn markings</li><li>• King &amp; Queen Street - 'No Entry' markings and straight ahead arrow</li><li>• Brandon Street and Portland Street - junction markings.</li></ul>

**Public Toilet Provision in Walworth**

On 13<sup>th</sup> December 2005 the Toilet Review was approved by the Executive. This review outlines that:

- (i) All existing council public toilet facilities are more effectively used
- (ii) Resources provided by others provide part of an overall public toilet offer in Southwark
- (iii) All toilets that are not Disability Discrimination Act 1995 (DDA) compliant or subject to above, or do not have a near viable alternative, are closed or removed.
- (iv) Signposting is enhanced for all toilets (in accordance with British Toilet Association and Disabilities Discrimination Act recommendations) including mapping on the Southwark website.

The review concluded that public toilet provision in Southwark compared favourably with other London borough's, but was still not adequate, and set out a range of options for future provision.

As part of the review the available toilet facilities in council buildings, parks and private buildings were identified and investigated. This part of the review established that there are many facilities that are open to the public but are not advertised as toilet provision or adequately signposted. Signposting is going to be enhanced for all toilets.

**Briefing to Walworth Community Council, 8 February 2005.  
Amendment to Controlled Parking Zone E: Crampton Street and Amelia Street.**

The formal objection to the Traffic Management Order (6/10/05) detailing parking amendments in the above streets has been withdrawn. This relates to Parking Services report to Walworth Community Council, 23 November 2005.

In view of this withdrawal, we now intend to make (and advertise) the Traffic Management Order on 9 February 2005. The appropriate bay markings and sign plates will be installed shortly after the making of the Order.

It is noted that these bay amendments take place to assist during site development and parking provision will be maximised once works are complete.

Parking Services have been informed that the gateway to the remaining tenants in the Newington Industrial Estate is due to be relocated slightly north-westward. It should be noted that a further suspension of parking places opposite the new gateway may be required to assist entrance/egress of articulated vehicles. This will be carried out by way of 'yellow' parking suspension signs.
