RECOMMENDATION

1. That Council Assembly be recommended to increase the number of Independent Members on the Standards Committee from three to four.

BACKGROUND INFORMATION

- 2. Currently there are three Independent voting members on the Committee. The total membership is nine; made up of six councillors and the three independent members. At the beginning when the Committee was established, a case was made to have reserves for the Councillors but not for the independent members.
- 3. After operating for a year, the Committee have agreed that there may be a case for a fourth independent member.
- 4. The Standard Committee's terms of reference requires an independent member to be present for the committee to be quorate, increasing the number to four will cater for any absences.
- 5. Advertisements were placed in the South London Press and Southwark News. The timetable agreed in December 2002 for the recruitment was as follows:
 - Public advertisement, 10 February 2003 onwards
 - Deadline for applications, 5 March 2003
 - Short listing of candidates, 12 March 2003
 - Interviews, 26 March 2003
 - Report to Standards Committee, 23 April 2003
 - Report to Constitutional Council Assembly, 21 May 2003
- 6. Currently, five applications have been received and the Panel will recruit the agreed independent member or members on 26th March 2003.

KEY ISSUES FOR CONSIDERATION

7. If the Council Assembly agrees to a fourth independent member, the addition would be made during the approaching recruitment.

Legal Issues

8. Section 53(4) of the Local Government Act 2000 provides that a Standards Committee of a London borough council must include at least two members

of the authority and at least one person who is not a member or an officer of the authority or any other relevant authority. The Relevant Authorities (Standards Committee) Regulations 2001 specify that an authority must ensure that, where its Standards Committee has more than three members, at least 25% are independent members.

- 9. The Regulations specify that a person may not be appointed as an independent member of a standards committee unless the appointment is:
 - approved by a majority of the members of the authority;
 - advertised in one or more newspapers circulating in the area of the authority;
 - of a person who has submitted an application to the authority;
 - of a person who has not within the period of five years immediately preceding the date of the appointment been a member of the authority; and
 - of a person who is not a relative or close friend of a member or officer of the authority
- 10. The regulations stipulate that an independent member should be a person:
 - who has not within the period of five years immediately preceding the date of their appointment been a Member of the authority;
 - who is not a relative or close friend of a Member or Officer of the authority;
 - who is not a Member of Officer of any other local authority; and
 - who has no criminal convictions
