1. PRELIMINARY BUSINESS

1.1 ANNOUNCEMENTS FROM THE MAYOR, MEMBERS OF THE EXECUTIVE OR CHIEF EXECUTIVE

The Mayor reported that one current Councillor, Maggie Ambrose and two former Councillors, Graham Nash and Debbie Welch had died since the last meeting.

Councillor Ambrose had represented East Walworth Ward since May 2002 and had a long record of community service with the Heygate Tenants Association, the Elephant Links Community Forum and the Southwark Group of Tenants Organisations.

Former Councillor Debbie Welch had been a well known community advocate and was a former Deputy Leader of the Council and Liddle Ward representative.

Former Councillor Graham Nash had been a Bricklayers Ward member from 1990 to 2002 representing both the Liberal Democrat and Labour parties.

Councillors Denise Capstick, Ian Wingfield and Kim Humphreys paid tribute to Graham Nash.

Councillors Danny McCarthy, Tony Ritchie, Michelle Pearce and Aubyn Graham paid tribute to Debbie Welch.

Councillors Mick Barnard, Lorraine Zuleta, Catherine Bowman, Graham Neale, Demot McInerney and Kim Humphreys paid tribute to Maggie Ambrose.

All present observed a one-minute silence in memory of Maggie Ambrose, Debbie Welch and Graham Nash.

The Mayor also added his congratulations to two persons with Southwark connections who had been recognised in the New Year Honours List. Mrs Diane Crouch, a Teaching Assistant at Friary Primary School had received an OBE for services to education. Charles Edward Robson had been given an MBE for services to the local community.

4.1 **DEPUTATION REQUEST : BLACK AWARENESS GROUP** (see pages 2-3)

Council Assembly agreed to accept the deputation. Members were addressed by the deputation's spokesperson, Mr. Raymond Stevenson, following which Councillors Dominic Thorncroft, Vicky Naish, and Jonathan Hunt asked questions.

The Mayor indicated he would refer the points made by the delegation to Officers.

7.1 THE COUNCIL TAX BASE FOR 2004/05 (see pages 20 – 37)

The Mayor formally moved the recommendations contained within the report.

Councillor Michelle Pearce, seconded by Councillor Andy Simmons, moved Amendment A.

Following debate (Councillors Lorraine Zuleta, Dermot McInerney and Graham Neale), Amendment A was put to the vote and declared to be <u>lost.</u>

Councillor Toby Eckersley, seconded by Councillor Kim Humphreys, moved Amendment B. With the consent of the meeting the mover added the following text to his amendment:

"and that the figures in Paragraph 2 be amended accordingly".

Following debate (Councillors Nick Stanton and Michelle Pearce), Amendment B was put to the vote and declared to be <u>carried.</u>

The substantive motion was put to the vote and declared to be <u>carried</u>.

RESOLVED: 1. That the Council Tax collection rate for 2004/2005 be estimated at 97.5 % and that the figures in Paragraph 2 be amended accordingly.

2. That the formal resolution and calculations shown in Appendices D to H be approved and the Council Tax Base for 2004/2005 be set at:

For the parish of St. Mary Newington12,867.22For the parish of St. Saviour's1,065.10For the whole of the borough excluding the parishes of St. MaryNewington and St. Saviour's74,133.97For the whole borough88,066.29

3. That the "second homes discount" be reduced to the statutory minimum of 10% with effect from 1st April 2004.

4. That the long term void Council Tax discount be abolished with effect from 1st April 2004.

7.2 FREEDOM OF THE BOROUGH (see pages 38 - 42)

The Mayor formally moved the recommendations contained within the report.

Following debate (Councillors Kim Humphreys, David Hubber, Danny McCarthy, Aubyn Graham, Tony Ritchie, Alun Hayes and Kenny Mizzi), the motion was put to the vote and declared to be <u>carried.</u>

8.1 MOTION NO.1 – ALG SCRUTINY NETWORK (see page 44)

Councillor Kim Humphreys, seconded by Councillor David Bradbury, moved the motion.

Following debate (Councillors Eliza Mann and Ian Wingfield) the motion was put to the vote and declared to be <u>carried</u>.

RESOLVED: That the Leader of the Council be requested to support moves to formally establish the ALG Scrutiny Network as a committee of the ALG.

8.2 MOTION NO.2 – HEYGATE ESTATE (see pages 44-45 and Supplemental Agenda no.1)

Councillor Paul Bates, seconded by Councillor Ian Wingfield, moved the motion.

Councillor Catherine Bowman, seconded by Councillor Nick Stanton, moved Amendment A.

Following debate (Councillors Andy Simmons, Graham Neale, Peter John, James Gurling, Danny McCarthy, Michelle Pearce, Kim Humphreys, Beverley Bassom and Tony Ritchie), Amendment A was put to the vote and declared to be <u>carried</u>.

The substantive motion was put to the vote and declared to be <u>carried</u>.

RESOLVED: 1. That Council believes that regeneration of the entire Elephant and Castle area is vital for the economic success of Southwark, and that a successful masterplan will have London-wide implications in terms of economic and social development.

2. Council further believes that 30 years of neglect by previous administrations has left the fabric of the Heygate Estate in a deplorable condition.

3. Consequently, Council instructs officers to bring a report to Executive indicating how the plan to build new, local, high quality homes for Heygate tenants and residents can be expedited.

4. Council notes the unprecedented amount of consultation that has already been undertaken on the Heygate and instructs officers to report to the Executive how the Council can continue to ensure that residents are fully consulted on all relevant issues relating to provision of their new homes.

Councillor Mark Pursey, seconded by Councillor Nick Stanton, moved the motion.

Following debate (Councillors Jonathan Hunt, Danny McCarthy, Dermot McInerney, Kim Humphreys, David Hubber and Tony Ritchie), the motion was put to the vote and declared to be <u>carried</u>.

RESOLVED: 1. That Council notes with disapproval that the Leader of the Majority Opposition Group has been found by the Standards Board for England of using council resources for political gain.

2. Council notes that Cllr Wingfield was investigated by the Standards Board for two separate offences. In December 2002 he wrote to all Tenants and Residents Associations in Southwark at the council's expense. In the same month, Cllr Wingfield used Council resources to send a Brunswick Park 'Winter Report' to those living in his ward. Both mailings were designed to affect support for the Labour Group.

3. Council notes that the Members' Code of Conduct clearly prohibits members from using council resources for political purposes and that both investigations by the Standards Board found that "Cllr Wingfield therefore failed to comply with this protocol.....in breach of the code of conduct".

4. Council notes the advice of the District Auditor that "the most appropriate course of action ... could include seeking a voluntary repayment of the money spent by the Council..."

5. Council therefore calls on Cllr Wingfield to make a public apology to Southwark residents.

- **RESOLVED:** 1. That the Council is committed to high standards for its Street Wardens schemes and therefore welcomes the Government's invitation to Local Authorities to apply for its Wardens Quality Standards Award, which assesses organisational performance and plans relating to:
 - achieving the results the scheme has signed up to;
 - leadership of the scheme including a vision of the area's potential; and a strategy for its improvement;
 - management performance including communication and open decision making;
 - financial management;
 - staff management including training;
 - working with the community to ensure all benefit equally from warden support regardless of disability, race, religion, gender, sexuality or age.

2. To show its commitment to high standards, the Executive be requested to ensure that the London Borough of Southwark makes an application for the Wardens Quality Standards Award.

9.2 ADJOURNMENT DEBATE No.1 – COUNCILLOR TOBY ECKERSLEY (VILLAGE WARD)

Councillor Toby Eckersley sought assurances that consideration would be given to the amenity of local residents which he believed would be threatened by the holding of major events at the Herne Hill Velodrome.

The debate was responded to by the Deputy Leader of the Council, Councillor Caroline Pidgeon. She explained the annual Good Friday meeting was the only large scale event planned for the Velodrome. Although the stated intention was to increase user numbers, cycling was not a mass spectator sport and the range of new activities planned should not lead to a degradation of local amenities. She reported Herne Hill had already been ruled out as an Olympic 2012 venue on technical grounds.

9.3 ADJOURNMENT DEBATE No.2 – COUNCILLOR AUBYN GRAHAM (THE LANE WARD)

Councillor Aubyn Graham expressed his concern at the perceived shortage of arts venues in Southwark. He promoted the Peckham Wharf site as a suitable arts venue.

The debate was responded to by the Executive Member for Education and Culture, Councillor Bob Skelly. He said the Executive would be considering a report on arts provision in March, but he warned any new venture would have to pass stringent tests regarding its viability. He welcomed the new performance space at the Peckham Academy which would seat 300 people.

9.4 ADJOURNMENT DEBATE No.3 – COUNCILLOR DAVID BRADBURY (VILLAGE WARD)

Councillor David Bradbury outlined problems caused by the lack of short term parking outside the parade of shops at Herne Hill. He said the matter had been debated at the Dulwich Community Council but little progress had been made as it appeared conflicting advice was being offered by officers at the Boroughs of Lambeth and Southwark.

The debate was responded to by the Executive Member for Environment and

Transport, Councillor Richard Thomas. He stated the proximity of the site to the borough boundary had led to confusion but he knew that in the past year two Traffic Management Orders had been advertised there by the Borough of Lambeth. He indicated he would be prepared to investigate the matter further.
