COUNCIL PROCEDURE RULE 3.9: MEMBERS QUESTION TIME

In accordance with council assembly procedure rule 3.9 members' question time shall not exceed 45 minutes. During this time, members may not question any one executive member or committee chair for longer than fifteen minutes.

Members are limited to one question at each meeting.

Questions shall be taken in the following order; the leader, the deputy leader, the executive member for resources; the executive member for health and adult care; executive member for housing & community safety; executive member for regeneration & economic development; the executive member for communication & performance improvement, the executive member for equalities, culture and sport, the executive member for education and the executive member for environment and transport. The order of questions is rotated by the borough solicitor at every meeting (CAPR 3.9 (10) & (11)).

Executive members and committee chairs have discretion to refer a question to another executive member if this is appropriate.

Responses to members' questions will be circulated on yellow paper around the council chamber on the evening of the meeting.

The Mayor will ask the member asking the question if they wish to ask one supplemental question to the member to whom the first question was asked. The supplemental question must arise directly out of the original question or the reply. Therefore, questions to the leader or other executive members are not free ranging.

No question shall be asked on a matter concerning a planning or licensing application.

(**NOTE**: In accordance with council assembly procedure rule 3.9 (10) & (11) (prioritisation and rotation by the political groups) the order in which questions appear in this report may not necessarily be the order in which they are considered at the meeting).

1. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR LEWIS ROBINSON

In the light of previous problems on works at the town hall, would the leader publish a breakdown of the full costs of refurbishment of the council chamber and whether at present it is still expected to be in budget?

2. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR PETER JOHN

Do you agree with Simon Hughes' view of Southwark Police (as quoted in the Southwark News, (28\04\05) that "given the money that's spent on them and the pay they get, which is quite considerable, they are not terribly successful"?

3. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR JANE SALMON

It has been six months since the executive offered £25,000 to the former directors of Imperial Gardens towards the cost of formulating a legal claim against the council. Could he provide an update on the progress of this claim?

4. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR JONATHAN HUNT

Could the leader tell us what action he has taken as a result of the Ouseley Report, and what other measures he plans to take?

5. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR DAVID BRADBURY

Would the leader of the council please explain whether he is satisfied that the council's nominees to the board of Fusion Lifestyle are adequately protected and indemnified in the event of the service of legal proceedings against directors individually or collectively, with particular regard to the risks of personal injury litigation in respect of leisure centre operations?

6. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR ALISON MOISE

Could the leader please provide the name and job title of the lead council officer responsible for tackling anti-social behaviour in each ward of the borough?

7. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR JAMES GURLING

Anti-social behaviour orders (ASBOs) which name and shame individuals can be a highly effective way of reassuring the community. But in some cases, for example young people and vulnerable adults, naming the individual can have a detrimental effect on their rehabilitation. Are there any plans to issue guidelines about publicising ASBOs in Southwark?

8. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR TONY RITCHIE

Following my question in April 2004, could the leader please update me with current amount telephone costs recorded to each councillor since the last council elections in 2002. In addition could he also update me with the charges for the telephone costs for each individual group room for the same period?

The WC situated on Camberwell Green has rarely ever worked for longer than 24hours, which is cause of rising level of frustration amongst local residents. What is the cost to the council of repeated call-outs and repairs by the contractor in the last 12 months?

Furthermore, does the leader of the council believe this offers value for money and if not what does he suggest should be done to rectify the situation for my constituents?

Would he supply me with a copy of the council's strategy on public conveniences?

10. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR MARK PURSEY

How many ballot papers were cast in North Southwark and Bermondsey in the general election, what time was the declaration of the result and how does this compare with other constituencies where returning officers were not having to separate local and general election ballot papers?

11. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR SARAH WELFARE

Are you confident that all community council meetings are being held in venues compliant with the Disability Discrimination Act?

In light of the report in the Local Government Chronicle (09/06/05) that Southwark is likely to lose £20million of funding for children's social services would the deputy leader please comment on this threat and what she is doing to remove it?

Could the executive member confirm what additional resources central government will commit to the Aylesbury Estate to assist with the physical regeneration?
