RECOMMENDATION

 That the Executive receive the Final report of the Health and Social Care Scrutiny Sub-Committee on "Access to Primary Care" (attached at Appendix A), and the comments of Overview & Scrutiny Committee, and refers the report to Southwark Primary Care Trust for consideration.

BACKGROUND INFORMATION

- 2. The Health and Social Care Sub-Committee agreed to undertake an initial inquiry into access to primary care (with a focus on access to G.P. services) at its inaugural meeting in July 2002. This was undertaken over three meetings of the Sub-Committee and the final report agreed on 20 November 2002. Details of the evidence taken during the inquiry are contained in the Sub-Committee's report, attached at Appendix A.
- 3. On 9 December 2002 the Overview & Scrutiny Committee considered the Sub-Committee's final report. Members heard from the Executive Member for Health & Social Care, the Medical Director of Southwark Primary Care Trust and the Vice-Chair of the Health & Social Care Sub-Committee. OSC endorsed the report and agreed to refer it to the Executive and the Primary Care Trust with the following additional agreed comments, i.e.
 - (a) That the Primary Care Trust be asked to address the matter of access to primary care for working people;
 - (b) That the Executive be asked to ensure that this report is publicised, and the Council's Press Office be asked to assist.
 - (c) That the Primary Care Trust be asked to consider as a matter of priority access to primary care by black and minority ethnic people, people with disabilities, refugees and asylum seekers and homeless people.
 - (d) That the Primary Care Trust be asked to take steps to address provision of exit interviews for general practitioners, in line with the recent Audit Commission comments.
- 4. The final report of the Health & Social Care Scrutiny Sub-Committee on "Access to Primary Care" stands referred to the Executive.

ISSUES FOR CONSIDERATION

- 5. The final report contains a number of recommendations, summarised in paragraph 2.4 of the attached report.
- 6. The majority of the recommendations are directed at Southwark Primary Care Trust (P.C.T.), although some recommendations are also directed at the Council.
- 7. Members are asked to bear in mind that there is no specified timescale within which the Primary Care Trust is required to respond to the scrutiny report. However, the guidance that will accompany the health scrutiny regulations is expected to indicate that local authorities should expect to receive responses to scrutiny reports within eight weeks.
