#### **BACKGROUND INFORMATION**

- 2. At its meeting on 10 February 2003 the Finance and General Purposes Scrutiny Sub-Committee scheduled consideration of the Best Value Review of Roles and Responsibilities of, and Council Relations with, the Voluntary Sector including Grant Aid for its meeting on 22 April 2003. This review was included within the 2002/03 scheduled for Best Value Reviews.
- 3. At its meeting on 12 March officers provided the Sub-Committee with advice

that the process for undertaking the review had now changed following the agreement of a report by Executive on 11 March 2003. The new approach would be made up of two parallel processes:

- Work about relationships with the voluntary sector to take place through the COMPACT group;
- A fast track review of voluntary sector grant aid.
- 4. Officers have indicated that scrutiny will have an opportunity to look at the outcome of the fast track review before it is returned to the Executive for final consideration.
