# 1. <u>BUDGET SCRUTINY- REPORT OF FINANCE AND ECONOMIC DEVELOPMENT SCRUTINY: BUDGET MAKING PROCESS 2004/05.</u>

Scrutiny Officers handed out supplemental information about the Item [Report of Finance and Economic Development Scrutiny to the Overview and Scrutiny Committee on Scrutiny of the Budget Making Process for 2004/05]

The Chair [Cllr Humphreys] introduced the item and invited Cllr Eckersley to present to the Committee on the Item.

Cllr Eckersley thanked the Committee and went through the recommendations contained within the Report of Finance and Economic Development Scrutiny to the Overview and Scrutiny Committee on Scrutiny of the Budget Making Process for 2004/05 (1 (i)- (v)).

The Chair invited questions from the Committee.

Cllr Simmons directed his question to Mr. Keith Brown [Chief Financial Officer] and asked him what would be the implications of delaying the budget setting process?

Mr. Brown responded that legally the Council had until the 11<sup>th</sup> March to set the Council Tax levels, but that currently Southwark Council is at the front of the queue to issue Council Tax bills and start receiving Council tax and if they wished to keep this position, everything must be finalized by 25<sup>th</sup> February. If Southwark went beyond the 25<sup>th</sup> February there would be considerable loss of revenue in collecting Council Tax.

The Chair asked Mr. Brown to clarify the question of the queue.

Mr Brown reiterated that according to the Liberata timetable, Southwark is at the front of the queue to issue bills and collect Council Tax. However if they do not set Council Tax before the 25<sup>th</sup> February other Councils will have confirmed their Council Tax levels and will get given the position at the front of the queue.

Cllr Watson asked whether it was the first time a 'Challenge Panel'?

Mr. Brown responded that this was the first time they had been named a 'Challenge Panel', and that there were similar exercises held last year.

The Chair expressed concern with the fact that the Finance and Economic Development Scrutiny Sub – Committee did not receive requested information from the Schools Forum.

The Chair asked if the recommendations contained in the Report of Finance and Economic Development Scrutiny to the Overview and Scrutiny Committee on Scrutiny of the Budget Making Process for 2004/05 were a unanimous decision.

Cllr Eckersley replied that the recommendations were unanimous.
