Detailed drawings of the guard rails to be erected on the public highway (2 copies) shall be submitted to and approved by the Local Planning Authority before any work in connection with this permission is carried out and the development shall not be carried out otherwise than in accordance with any such approval given.

### Reason

In order that the Local Planning Authority may be satisfied as to the details of the hand rails in the interest of the appearance of the building in accordance with Policy E.2.4 'Safety and Security in the Environment' of the Southwark Unitary Development Plan and Policy 3.11 'Quality in Design' of the Southwark Plan [Revised Deposit Unitary Development Plan] March 2004.
