SOUTHWARK COUNCIL SPORTS FACILITIES

TERMS AND CONDITIONS OF USE

The following list of terms and conditions must be adhered to at all times. Failure to do so may lead to disqualification from use of Southwark Council's sports facilities.

The organisation to which a permit is issued or makes the booking will be held responsible for the behaviour of their members and supporters, the opposing organisation's members and their supporters.

- 2. The organisation issued with a permit will ensure that all terms and conditions, bylaws and relevant policies are made aware to opposing organisations, their supporters and visitors.
- 3. All bookings made are provisional only until payment has been received at least 14 days before the booking date.
- 4. Bookings not paid for 14 days before the booking date will be considered cancelled and that date will become available for hire again.
- 5. Bookings made less than 14 days before the booking date must be paid for within 24 hours. Failure to do so will be considered a cancellation and that date will become available for hire again.
- 6. In the event of damage to Southwark Council property, the organisation to which the permit is issued or made the booking will be held responsible.
- 7. Southwark Council will not be held liable for the theft, loss or damage to individuals and/or property that is left in the changing rooms, pavilions or any other are of Southwark Councils Parks.
- 8. No studded or bladed footwear will be worn on all weather pitch surfaces at any time.
- 9. Chewing gum is not permitted on all weather pitch surfaces at any time.
- 10. No glass bottled or glass containers will be allowed on any of the pitches at any time.
- 11. Smoking or naked flames are not permitted on any of the pitches at any time.
- 12. All litter must be disposed of in the bins provided.

- 13. Bicycles are not permitted in changing rooms, pavilions, pitch surfaces or sidelines.
- 14. Motorised vehicles are not permitted on parks property. Car parks where available must be used.
- 15. Footwear must not be cleaned in the changing room showers or sinks. Use the boot scrapers outside changing rooms and pavilions.
- 16. Studded and bladed footwear will not be permitted in reception, public toilets and café areas.
- 17. Food is not permitted onto all weather pitch surfaces.
- 18. Noise will be kept to a minimum when entering and leaving Southwark Council's sports facilities, out of respect for our neighbours.
- 19. The organisation shall not cause or allow Southwark Council's sports facilities to be used in any manner whatsoever that in the opinion of Southwark Council amounts to or involves treating any person less favourably on the basis of disability, race, colour, ethnic or national origins, sex, marital status, domestic circumstances, sexual orientation, age, class, ethical beliefs, basic skills, or trade union activity.
- 20. Verbal and physical abuse of staff and other users will not be tolerated at any time and may lead to prosecution and a disqualification of the organisation.
- 21. Southwark Council reserves the absolute right to terminate or cancel an agreement at any time in the event of any breech of these terms and conditions and parks bylaws without notice, reimbursement or any compensation to the organisation.
