# **Democracy Commission**

"That a Democracy Commission be established to consider the avenues of democratic engagement with the council for local residents.

"That the Democracy Commission be specifically tasked with fully reviewing how council assembly can be changed to increase democratic engagement with local people.

# **Deputy Cabinet Members**

"That a new role of Deputy Cabinet Member be established to work with Cabinet Members on specific tasks. That the role be given no special responsibility allowance or delegated powers and that Deputy Cabinet Members not be permitted to scrutinise any of their own Deputy Cabinet Member duties."

# **AMENDMENT C4**

# Call in at Overview and Scrutiny

"In the event that an overview and scrutiny committee of 11 members is established, in overview and scrutiny procedure rule 21.3 (Procedure to call-in a decision) in third line **delete** "three" and **insert** "four" and in rule 21.5 in second line **delete** "three" and **insert** "four". The revised rules to read:

- "21.3 During that period, the proper officer shall call-in a decision for scrutiny if so requested by the chair or vice-chair of the overview and scrutiny committee, plus four [delete "three"] members of the committee, including education co-optees for the purpose of education decisions only.
- "21.5 In the event that the chair or vice-chair of overview and scrutiny decides not to support a call-in request received within deadline and signed by four [delete "three"] members of the committee, they are required to set out their reasons in writing, and this letter will be circulated to members and other interested stakeholders.

**Note**: In accordance with Article 1.5(a), any proposed changes to the constitution require prior consideration by the constitutional steering panel. The panel is scheduled to meet on 18 May 2010. Any recommendation on Amendment C4 will be reported to the annual meeting of council assembly.
