# **9.2 – MOTION 2: LABOUR'S BROKEN ELECTION PLEDGES** (see pages 105 - 107 of the main agenda)

#### **Delete** all and **insert**:

Council assembly notes that since the elections in May Labour has, in line with its manifesto:

- Signed a deal guaranteeing a minimum level of affordable housing at Elephant & Castle and made progress on the swimming pool and demolition of the shopping centre
- Saved Nursery Row Park and Brayards Green in line with our commitment to value green spaces
- Cut special responsibility allowances (SRAs) by the same amount that they were increased by the last administration
- Put in place tough new restrictions on consultancy spending
- Started a budget consultation as part of our commitment to open up the budgeting process
- Made every fire risk assessment publicly available
- Hired a new housing director for the new housing department
- Started to pilot our dedicated line for social care queries
- Extended CCTV coverage
- Consulted on our new charter of rights for people who need social care
- Worked with other boroughs to see what savings can be achieved through cooperative working.

Council assembly notes that in the coming months Labour will, in line with its manifesto, at the very least:

- Set out how we will make every home warm, dry and safe
- Open two air quality monitoring stations
- Launch the teen pregnancy commission
- Publish news on the violent crime strategy
- Continue to consult on the budget, in spite of the coalition government's cuts.

Council assembly notes that in contrast to this record of achievement, the last Liberal Democrat council administration left office with at least 50 of its election pledges unfulfilled.

Council assembly further notes the Liberal Democrats significant broken manifesto promises since entering a coalition government with the Tories, not least on:

- the scale and speed of spending cuts
- the hike in the level of VAT
- the hike in tuition fees, which every Liberal Democrat MP pledged to oppose.

Council assembly calls on the cabinet to continue to meet its election obligations, despite the Tory/Liberal Democrat cuts.

# **10 – LATE MOTION: POLICE NUMBERS IN SOUTHWARK** (see pages 109 - 110 of the main agenda)

### **Delete** paragraphs 3, 4, 5 and 6 and **insert**:

- 3. Council assembly notes, according to Metropolitan Police Authority (MPA) figures, in August 2010 there are more than 14,250 civilian staff working for the Met, including 991.2 (FTE) in the information directorate, 1,718.1 in human resources and 643.98 in resources. In addition there are more than 750 police officers assigned to back-office tasks.
- 4. Council assembly also notes the campaign for 1,000 police officers in Southwark began in 2002 has been consistently supported by Simon Hughes and the borough's other MPs, councillors of all parties (including supporting the recent all party letter to Home Secretary, Teresa May) and that eight years later Southwark has a police complement of 945 officers – despite Labour being in government for all this time.
- 5. Council assembly understands while budget cuts are regrettable, recognises they are inevitable given the state of the public finances after 13 years of Labour government financial incompetence, which means the UK has the largest peacetime budget deficit, a national debt higher than Greece and Spain (and in the EU only lower than Ireland) equivalent to £22,400 for every person in the country with interest payments running at a total of £42.9 billion per year, more than the country spends on its own defence.
- 6. Council assembly recognises that day-to-day responsibility for operational budgets of the Metropolitan Police lies with Mayor Boris Johnson and the MPA and believes he should prioritise cutting back the Met's back office bureaucracy while focusing available resources on front line policing, including fulfilling all parties' longstanding commitment to provide a 1,000 police officers for Southwark.

### RECOMMENDATION

1. That council assembly considers whether or not to hear a late deputation from Southwark Trades Council (see paragraph 5 below).

### **BACKGROUND INFORMATION**

- 2. The Mayor has been notified of the late deputation request. In accordance with council assembly procedure rules, it will be for council assembly on the evening to decide whether or not to suspend the relevant procedures rules. In this instance, council assembly would need to suspend council assembly procedure rule 2.6(7) (deadline for receipt of deputations) and procedure rule 2.6(4) (scope of deputations referral to the relevant decision making body).
- 3. When considering whether to hear the deputation request, council assembly can decide to:
  - Receive the deputation at this meeting or a future meeting; or
  - That the deputation not be received; or
  - Refer the deputation to the most appropriate committee/sub-committee.
- 4. A deputation shall consist of no more than six people, including its spokesperson. Only one member of the deputation shall be allowed to address the meeting for no longer than 5 minutes. After this time members may ask questions of the deputation for up to 5 minutes. At the conclusion of the questions, the deputation will be shown to the public gallery where they may listen to the remainder of the open section of the meeting.

### **KEY ISSUES FOR CONSIDERATION**

### **Southwark Trades Council**

5. A deputation request has been received from Southwark Trades Council. The trades council state the subject matter is "to speak in support of retaining public services and public sector jobs in the face of central government proposals to slash budgets. We will also be giving a trades council reaction to the results of the comprehensive spending review."

### **REASONS FOR URGENCY**

6. The Southwark Trades Council met on 14 October 2010 to request a deputation. This was after the agenda despatch date.

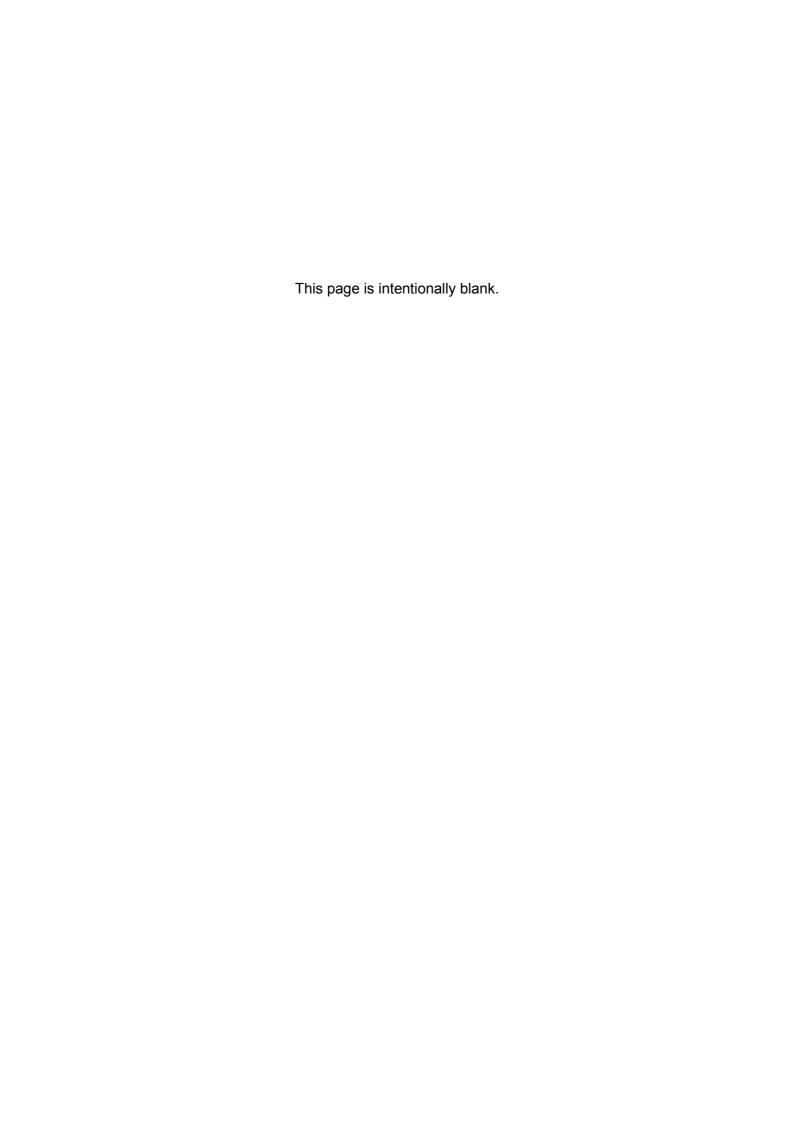
