Foreword - Councillor Ian Wingfield, Chair of Overview and Scrutiny Committee

In line with the Council's Constitution, I present this report to the annual meeting of Council Assembly.

The new municipal term has brought new issues as well as new members to OSC. We started with the Central London Bus review and ended with a review of the decision-making process over Maydew House. We also called in the Centre for Governance & Scrutiny (CGS) to review the Southwark scrutiny process and we will be considering their recommendations at out next meeting. All our discussions have resulted in timely and relevant recommendations that I am pleased to say the Cabinet has accepted in their entirety. As ever the Budget discussions took up a vast bulk of our work and especially so given the extra financial challenges we were presented with this year, but also the Cost-of-Living Crisis affecting so many of our residents. We also focused on the performance of the Council's Delivery Plan and the Climate Emergency Plan performance against its SMART targets.

I would like to take this opportunity to thank cabinet members, senior officers, partners, other agencies and the public for attending meeting after meeting. Your contributions to the scrutiny process have been invaluable and has enabled overview and scrutiny committee and the commissions to obtain a greater understanding of the issues we have been looking at. I would also like to express thanks to my scrutiny colleagues who have always asked interesting and searching questions of a high standard throughout the year.

The recommendations of the Centre for Governance and Scrutiny will allow the Council the opportunity to improve our scrutiny function, where improvements can be made. A key element will be the 'balancing' role of scrutiny with Cabinet and taking a more pro-active role in supporting policy development / pre-decision scrutiny, along with a consideration of changes to the 'call-in' process. The council will also be looking at how scrutiny can increase the involvement of the public and community organisations.

I recommend this report to Council Assembly.

RECOMMENDATION

1. That council assembly note the scrutiny activity for the 2022/23 municipal year as detailed in paragraphs 6 – 50 of the report.

BACKGROUND INFORMATION

- The council's scrutiny function provides a critical challenge to delivery of public services in Southwark through power to make inquiry into matters of local concern. The scrutiny function is undertaken by the council's overview and scrutiny committee and its commissions and can take a number of forms including.
 - Reviews into individual topics
 - 'Call in' scrutiny of executive decisions taken before they are implemented
 - Call to account of officers on receipt of a petition of 500 or more signatures from the general public
 - Interviews with individual cabinet members and senior officers.
- 3. The overview and scrutiny committee and its commissions have specific functions in respect of policy development and review, health and wellbeing, scrutiny of decisions and performance of the council in relation to policy objectives. The committee and its commission may make recommendations to the cabinet and/or council assembly arising from the outcome of a scrutiny process.
- 4. The scrutiny function is significant and wide ranging detail of its specific functions and terms of reference are set out in Appendix 1 of the report.
- 5. Section 2, Article 5 of the Council Constitution requires the overview and scrutiny committee to report annually to council assembly on the workings of the overall scrutiny function. The committee may make recommendations for future work programmes and amended working methods if appropriate. Section 6.1(h) of the overview and scrutiny committee procedure rules (terms of reference) requires overview and scrutiny committee to report annually to all councilors on the previous year's scrutiny activity. This report sets out the activity of the overview and scrutiny committee and its commissions for the 2022/23 year.

Activity

- 7. The overview and scrutiny committee's main area of focus this year was the Cost of Living Crisis.
- 8. The committee scrutinised the proposals of Transport for London in respect of the Central London Bus Review, received briefings from the cabinet member for Communities, Equalities and Finance on the council's response to the Cost of Living Crisis, and also heard from partner agencies and the voluntary sector in respect of this matter. Heard from the chief executive and officers on the council delivery plan 2022 2026, and Climate Emergency Plan in relation to performance against SMART targets.
- 9. The committee also received briefings on the latest position in respect of the council's digital strategy and customer access, support provided to Southwark LGBTQ+ communities, and an update on the implementation of the council's Equalities, Diversity and Inclusion Framework.
- 10. The overview and scrutiny committee held its annual budget scrutiny meeting which involved interviews with cabinet member portfolio holders and chief officers on the proposed council budget for 2023/24.

- 11. The committee considered one call-in during the 2022/23 year, which related to Abbeyfield Estate (Maydew House).
- 12. The overview and scrutiny committee met nine times its first meeting of the new municipal year held in May 2022.

- 13. The education and local economy scrutiny commission's main areas of focus for 2022/23 were mitigating falling pupil numbers in schools, and impact of the cost of living crisis on businesses.
- 14. Mitigating falling pupil numbers throughout the year the commission received various briefings and reports and heard from council officers, the cabinet member for Children, Young People and Schools, head teachers, the Director of Education for the Church of England Diocese, a GLA representative in relation to the School Rolls projections service and the National Association of Head Teachers.
- 15. Impact of the cost of living crisis on businesses throughout the year the commission received various briefings and reports and heard from council officers, local businesses, several Business Improvement Districts, Black Business Network, the chief executive of Renaisi (the leading accountable body for the Local Access Partnership) and East Street Market traders.
- 16. Following the evidence gathering sessions the commission formulated its draft recommendations for consideration by cabinet. The recommendations are available online in draft form and are available to view here see item 8. The final version of the recommendations and accompanying reports are due to be submitted to cabinet for consideration in June 2023.

- 17. In addition to the main areas of focus, the commission also received information on the Southwark Safeguarding Children Partnership and held interviews with the cabinet member for Children, Young People and Schools and the cabinet member for Jobs, Business and Town Centres in respect of matters within their portfolio responsibility.
- 18. The commission met six times its first meeting held in July 2022.

- 19. The environment scrutiny commission's main areas of focus for 2022/23 was Climate Emergency Finance, Sustainable Freight, and Resident Participation Framework.
- 20. Climate Emergency Finance the commission heard from the co-founder of Abundance, in relation to Community Municipal Bonds, Local Climate Bonds and Climate Emergency transition, the Head of Partnerships, and Programme Director on Green Finance, the Director of 3Ci on pathways to net zero, and briefings from council officers.
- 21. Sustainable Freight throughout the year, the commission received various briefings and reports and heard from council officers, the Cabinet Member for Leisure, Parks, Streets and Clean Air, the managing director of Peddle My Wheels, in connection with the OurBike scheme.
- 22. Resident Participation Framework the commission heard from 'We Walworth' in relation a model for thriving neighbourhoods, council officers on the climate emergency citizens jury, with a focus on the community engagement process, the Resident Involvement Manager, the Cabinet Member for Council Homes and Homelessness, the Deputy Cabinet Member for Diversity, Chairs of the Tenants Forum and Home Owner Forum.

- 23. The commission also undertook a mini review into streamlining planning applications for retrofit and renewable energy, hearing from various council officers. The commission made a number of recommendations to cabinet.
- 24. The commission also received a briefing from council officers and the cabinet member for communities, equalities and finance on progress relating to the Pension Fund divestment to make the council's pension fund zero carbon by 2030, and external representatives on the Carbon Tracker Initiative, around Pension Fund Divestment & Energy Transition.
- 25. The commission held interviews with the Cabinet Member for Climate Emergency and Sustainable Development, and Cabinet Member for Leisure Parks, Streets and Clean Air on various matters contained within their portfolio responsibility.
- 26. Following the evidence gathering sessions, the commission formulated its recommendations and draft reports. - 29. Care Contributions the commission received briefings and information relating to care charges. The commission heard from the Director of Adult Social Care, Carers, and the Southwark Disablement Association.
- 30. Access to Medical Appointments throughout the year the commission received reports and briefings on issues relating to medical appointments. The commission heard from the NHS Chief Operating Officer for Partnership Southwark, Directors of the North and South Southwark

Primary Care Networks in respect of GP Appointments, Healthwatch Southwark, SLaM Advisory group, Partnership Southwark Project Manager, Live Well Mental Health Clinical & Care Professional leads, CCPL advisory Group.

35. The housing and community safety scrutiny commission's main areas of focus for 2022/23 were Housing Repairs Service, Council Leaseholders, Empty Homes, Violence Against Women and Girls (VAWG), Hate Crime and Domestic Abuse.

Housing

36. The Scrutiny commission looked at ongoing issues residents were facing with the repairs services; reviewed the council's transparency and access for the audit of account of repair works in respect of council leaseholders and reviewed progress on reducing empty homes within the borough.

Community Safety

- 37. The commission reviewed council service providers, MET Police and local partners progress on matters pertaining to community safety with a focus on Violence Against Women and Girls (VAWG), Hate Crime (gender-related) and Domestic Abuse within the borough.
- 38. Housing Repairs Service Throughout the year the commission received various briefings and reports from the cabinet member for council homes and homelessness and council officers,
- 39. Council Leaseholder Charges The commission heard from the Chief Executive of the Leaseholders Association of Southwark, and the Chair of the Homeowners Area Forum on the impact of the cost of living crisis on leaseholders.
- 40. Empty Homes The commission received a report from council officers on progress on empty homes, and heard from the Cabinet Member for Council Homes and Homelessness.
- 41. Violence Against Women and Girls, Hate Crime and Domestic Abuse Throughout the year the commission received various briefings and reports and heard from the Chief Inspector in charge of the Safer Neighbourhood Teams.
- 42. Following the evidence gathering sessions, the commission formulated its draft recommendations. A copy of the commission's draft recommendations are available to view here see item 7. Final versions of the commission's report and recommendations are due to be submitted to cabinet for consideration in June 2023.

Other areas

- 43. The commission received reports on housing allocation statistics and overcrowding, and council support for resident-led housing meetings.
- 44. The commission held interviews with the Borough Fire Commander for the Southwark Fire Brigade on key fire safety issues, and the Borough Police Commander for Southwark in relation to trust and visibility of policing in the community. The commission also held interviews with the Cabinet Member for Council Homes and Homelessness, and the Cabinet Member for Community Safety in respect of areas within their portfolio responsibility.

45. The commission met five times - its first meeting held in July 2022.

Joint Health Overview and Scrutiny Committees (JHOSC)

46. There is provision in the constitution for the council to form a joint health overview and scrutiny committee (JHOSC) with other local authorities to consider a consultation on a proposal for substantial development of or variation to the health service affecting each council's area. Detailed below are the current JHOSCs that relate to Southwark.

South East London Joint Health Overview and Scrutiny Committee (JHOSC)

- 47. Southwark is part of the 'South East London Joint Health Overview and Scrutiny Committee', which consists of councillor representatives from Bexley, Bromley, Lambeth, Lewisham, Royal Borough of Greenwich and Southwark. The JHOSC role is to scrutinise health services across South East London, in particular the work of the South East London Integrated Care Board to ensure that improved, safe and sustainable health services are delivered across the region.
- 48. The JHOSC is currently administered by Bromley Council. The JHOSC has held one informal meeting.

Southwark Scrutiny Improvement Review

49. As indicated in the previous year's annual report, the council enlisted the Centre for Governance and Scrutiny to undertake a scrutiny improvement review of the council's scrutiny function. A copy of the Centre for Governance and Scrutiny review findings can be viewed here. The overview and scrutiny committee is due to consider which recommendations the council should adopt at its meeting in June 2023.

Scrutiny activity for 2023/24

50. The overview and scrutiny committee did not give an indication of the areas the committee and its commissions should focus on in 2022/23 municipal year. It will be for the overview and scrutiny committee to agree the 2023/24 work programmes for the committee and commissions.

Resource implications

Support to the scrutiny function

- 51. The scrutiny function is supported by the scrutiny team, which sits within the Governance and Assurance Department under the direct responsibility of the Assistant Chief Executive for Governance and Assurance. The team currently consists of the head of scrutiny, and two full time scrutiny officers.
- 52. Additional resources to further support the scrutiny function are under consideration.

APPENDIX 1

SCRUTINY FUNCTIONS AND TERMS OF REFERENCE

(Relevant extracts from the council constitution)

Part 2 - Articles

Article 5 - Overview and scrutiny committee and commissions

5.1 The council will appoint an overview and scrutiny committee to discharge the functions conferred by section 9A of the Local Government Act 2000. The overview and scrutiny committee will appoint commissions and determine their terms of reference.

The overview and scrutiny committee will also discharge those functions of the council relating to the scrutiny of the health service contained in the Local Authority (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013, except where a function is reserved to the council.

Where an NHS body or health service provider consults the council and another authority or authorities about a proposal for a substantial development of or variation to the health service affecting each council's area, the overview and scrutiny committee will appoint a joint overview and scrutiny committee with the other authority or authorities for the purposes of that consultation.

- 5.2 Within their terms of reference, the overview and scrutiny committee and its commissions will:
 - a) review and/or scrutinise decisions made or actions taken in connection with the discharge of any of the council's functions
 - b) make reports and/or recommendations to council assembly and/or the cabinet in connection with the discharge of any functions
 - c) consider any matter affecting the area or its inhabitants.
- 5.3 For the purpose of this constitution, scrutiny commissions are considered as subcommittees

5.4 Specific functions

1. Policy development and review

Overview and scrutiny committee and its commissions may:

- a) assist council assembly and the cabinet in the development of its budget and policy framework by in-depth analysis of policy issues
- b) conduct research, community and other consultation in the analysis of policy issues and possible options
- c) consider and implement mechanisms to encourage and enhance community participation in the development of policy options

- d) question members of the cabinet and chief officers about their views on issues and proposals affecting the area
- e) liaise with other external organisations operating in the area, whether national, regional or local, to ensure that the interests of local people are enhanced by collaborative working.

2. Health and wellbeing

Overview and scrutiny committee and its commissions must acknowledge, and respond to, a referral of a matter for review and scrutiny received from a local Healthwatch organisation.

Overview and scrutiny committee and its commissions may:

- a) review and scrutinise the work of the Health and Wellbeing Board
- review and scrutinise any matter relating to the planning, provision and operation of the health service in its area (but in doing so it must invite comments from interested parties and consider information provided by a Local Healthwatch organisation or contractor)
- c) make reports and recommendations to a NHS body or health service provider and the council on any matter it has scrutinised
- d) consider consultations from a NHS body or health service provider and to make comments
- e) question members or employees of a NHS body or health service provider.

3. **Scrutiny**

Overview and scrutiny committee and its commissions may:

- review and scrutinise the decisions made by and performance of the cabinet and council officers both in relation to individual decisions and over time
- b) review and scrutinise the performance of the council in relation to its policy objectives, performance targets and/or particular service areas
- c) consider referrals from members on any of the functions of the committee
- question members of the cabinet and chief officers and relevant partner authorities about their decisions and performance, whether generally in comparison with local area agreements, service plans and targets over a period of time, or in relation to particular decisions, initiatives or projects
- e) make recommendations to the cabinet and/or council assembly arising from the outcome of the scrutiny process or refer entire reports

produced as the result of the scrutiny process to be debated and noted at council assembly

- f) give notice of its recommendations to the cabinet and/or council assembly and publish recommendations
- g) give notice of its recommendations to the relevant partner authority
- review and scrutinise the performance of other public bodies in the area and invite reports from them by requesting them to address the overview and scrutiny committee/sub-committee and local people about their activities and performance
- i) question and gather evidence from any person (with their consent).

4. Crime and disorder

Overview and scrutiny committee and its commissions may:

- a) act as the crime and disorder committee within the meaning of section 19 of the Police and Justice Act 2006
- review or scrutinise decisions made, or other action taken, in connection with the discharge by the responsible authorities of their crime and disorder functions
- c) make reports or recommendations to the local authority with respect to the discharge of those functions
- d) make recommendations to the cabinet and/or council assembly with respect to any matter which is a local crime and disorder matter in relation to a member of the authority
- e) consider any crime and disorder matters referred by any member of the council.

5. Annual report

The overview and scrutiny committee will report annually to council assembly on the workings of the overall scrutiny function, and may make recommendations for future work programmes and amended working methods if appropriate.

Overview and Scrutiny Committee Procedure Rules

5. General terms of reference of all scrutiny committees/commissions

- 5.1 Within their terms of reference, all scrutiny committees/commissions will:
 - a) review and scrutinise decisions made or actions taken in connection with the discharge of any of the council's functions

- b) review and scrutinise the decisions made by and performance of the cabinet and council officers both in relation to individual decisions and over time in areas covered by its terms of reference
- c) review and scrutinise the performance of the council in relation to its policy objectives, performance targets and/or particular service areas
- d) question members of the cabinet and officers about their decisions and performance, whether generally in comparison with service plans and targets over a period of time, or in relation to particular decisions, initiatives or projects and about their views on issues and proposals affecting the area
- e) assist council assembly and the cabinet in the development of its budget and policy framework by in-depth analysis of policy issues
- f) make reports and recommendations to the cabinet and or council assembly arising from the outcome of the scrutiny process
- g) consider any matter affecting the area or its inhabitants
- h) liaise with other external organisations operating in the area, whether national, regional or local, to ensure that the interests of local people are enhanced by collaborative working
- i) review and scrutinise the performance of other public bodies in the area and invite reports from them by requesting them to address the scrutiny committee and local people about their activities and performance
- j) conduct research and consultation on the analysis of policy issues and possible options
- k) question and gather evidence from any other person (with their consent)
- consider and implement mechanisms to encourage and enhance community participation in the scrutiny process and in the development of policy options
- m) conclude inquiries promptly and normally within six months.
- 5.2 The overview and scrutiny committee, or one of its commissions shall be responsible for scrutinising the crime and disorder function.

6. Terms of reference of the overview and scrutiny committee

- 6.1 The terms of reference of the overview and scrutiny committee will be:
 - a) to appoint commissions, agreeing the size, composition and terms of reference and to appoint chairs and vice chairs
 - b) to agree the annual work programme for OSC and the commissions
 - c) to consider requests from the cabinet and/or council assembly for scrutiny reviews

- d) to exercise the right to call-in for reconsideration of executive decisions made but not yet implemented
- e) to arrange for relevant functions in respect of health scrutiny to be exercised by an overview and scrutiny committee of another local authority where the council considers that another local authority would be better placed to undertake those relevant functions, and that local authority agrees to exercise those functions
- f) if appropriate, to appoint a joint overview and scrutiny committee with two or more local authorities and arrange for the relevant functions of those authorities to be exercised by the joint committee
- g) to periodically review overview and scrutiny procedures to ensure that the function is operating effectively
- h) to report annually to all councillors on the previous year's scrutiny activity
- i) to scrutinise matters in respect of:
 - the council's policy and budget framework
 - regeneration
 - human resources and the council's role as an employer and corporate practice generally
 - customer access issues, including digital strategy, information technology and communications
 - the council's equalities and diversity programmes.

Terms of reference of a joint overview and scrutiny committee appointed to consider proposals relating to the health service

- 7.1 Where the council is required to form a joint overview and scrutiny committee with another authority or authorities to consider a consultation on a proposal for substantial development of or variation to the health service affecting each council's area, it will be for each appointing authority to adopt terms of reference and procedure rules as they consider appropriate.
- 7.2 The joint overview and scrutiny committee may:
 - only consider the relevant matter
 - make comments on the proposal
 - require relevant information or require an employee or member of a NHS body or health service provider to attend and answer questions.
- 7.3 When establishing a joint overview and scrutiny committee, the appointing local authorities will determine whether the power of referral to the Secretary of State in relation to a relevant proposal should be made by the Joint Committee or by the local authorities themselves. If the power is retained by the local authorities it may then be delegated to the overview and scrutiny committee or one of its commissions.
- 7.4 The joint overview and scrutiny committee will meet for such a period as is necessary to consider the consultation and make reports and recommendations.
