#### RECOMMENDATION

#### **BACKGROUND INFORMATION**

After this time cabinet members may ask questions of the deputation for up to five minutes. At the conclusion of the questions, the deputation will be shown to the public area where they may listen to the remainder of the open section of the meeting.

5. The deadline for receipt of deputation requests for this cabinet meeting was midnight 16 July 2024. The request was received before this constitutional deadline.

## Deputation request from AGE UK as part of the London Loos campaign

- 6. The deputation is made by AGE UK who coordinate the Loos for Southwark group as part of the London Loos campaign. 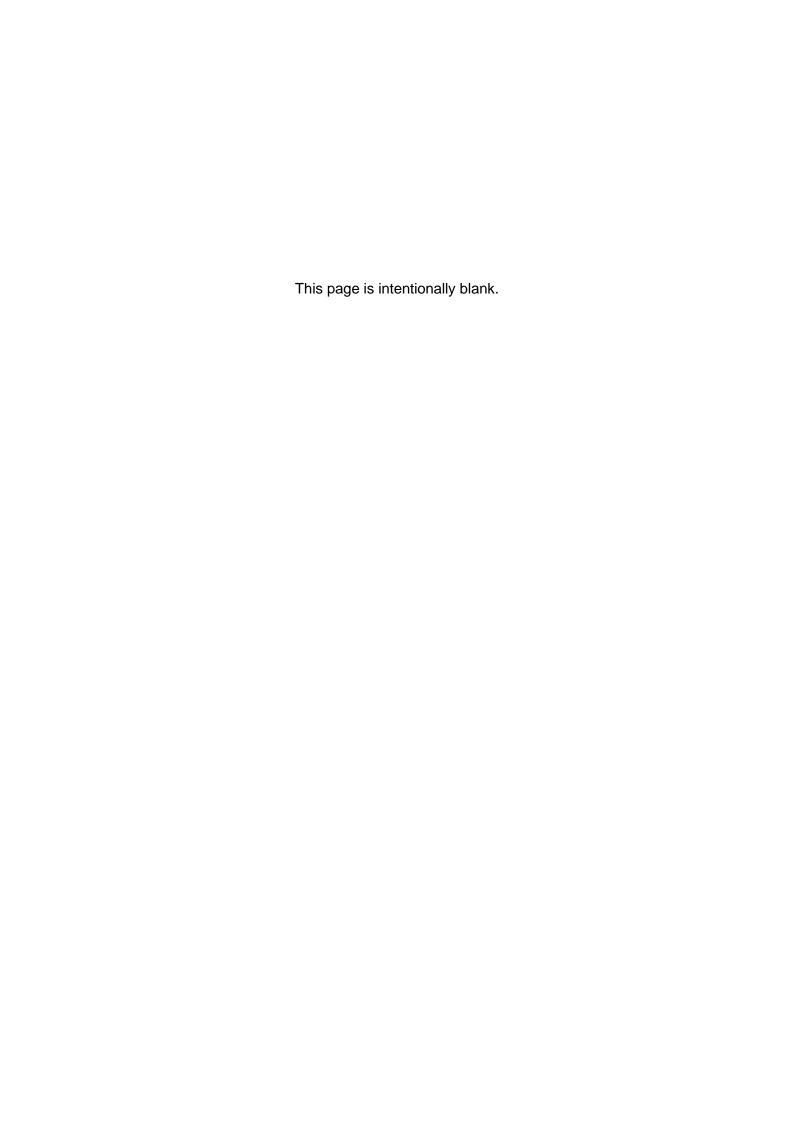
