BACKGROUND INFORMATION

Introduction

1. The council assembly business panel agreed that the theme for council assembly in November 2024 should be "The climate emergency in Southwark: a fair transition to net zero."

Community evidence on the theme

- 2. The deadline for community evidence was 11.59pm, 14 November 2024.
- 3. The following requests have been received by the deadline for consideration by this meeting and they are listed in the order received below.
- 4. Which community evidence shall be considered and the length of each submission will be established by way of a programme motion at the start of council assembly. Community evidence shall be conducted under the existing rules for public participation.
- 5. If the community evidence is not dealt with by council assembly, the matter shall be referred without debate to the relevant cabinet member who shall, after consideration, respond with an open reply to the sender.

Submissions

1. SE1 Solar

The community evidence requests states:

"Liam will explain the history and purpose of SE1 Solar (which emerged from Tenant Management Organisation Leathermarket JMB following a presentation by Cllr Dennis at the end of COVID). SE1 Solar aims to use revenues from rooftop solar on council estates to fit fuel poverty on the estates.

He will explain where we are now (just starting work with nearly £200,000 of seed funding from LB Southwark, Mayor of London, Greater South East Net Zero Hub, Centrica Energy for Tomorrow and UK Power Networks/Community Energy South).

He will explain the principal barriers to success that we are trying to overcome - the viability of rooftop solar on central London blocks of flats (solar PV is only usually viable when a single user in the building uses most of the electricity generated - we have to sell to multiple users or single large users not in the building via the grid) combined with the cost of a licence to sell to residents (around £1million).

Our feasibility work has identified several potential business models for rooftop solar on estates including Virtual Power Purchase Agreements, microgrids, and direct wire to large consumers. We are investigating the longer term challenges of energy storage and distribution network capability. At the same time, we are already supporting residents in fuel poverty with energy efficiency advice and products. We are working in partnership with community groups across London to gather best practice.

We will discuss our productive relationship with the council to jointly bid for funds e.g. the Mayor's Zero Carbon Accelerator and to solve the challenges of grid connection, rooftop leases and planning permission."

2. JoyRiders

The community evidence requests states:

"JoyRiders are nominated for two London Cycling Campaigns (LCC) awards. I would like to give a short summary of our project in Burgess Park and its outcomes, and share a case study or two."

3. Southwark Climate Collective

The community evidence requests states:

"In 2024, Southwark Climate Collective has supported over 140 SMEs in the borough to decarbonise their business. The project gives bespoke, one-to-one support for businesses across four programme streams: energy, waste, freight and supply chains. The project is funded by UKSPF working in partnership with Southwark Council, local BIDs and business forums."

4. Ryan Matthews-Robinson

The community evidence requests states:

"I will be talking about how Black people in Southwark are disproportionately affected by air pollution and how our Clean Air For The Ends campaign is engaging young Black people to fight for climate justice."

5. Community Cycleworks

The community evidence requests states:

"Community Cycleworks would like to address the council to share a short presentation on our partnership work with Southwark Council's 'Streets for People' Project, and some of our impact and participant data with the audience.

Our projects are teaching, supporting and empowering local people to repair their own bikes, with many participants from marginalised backgrounds who would typically not be able to access mainstream bike shops.

These projects have been recognised favourably by Will Norman, London's Walking and Cycling Commissioner and the honourable Mayor of Southwark Cllr Naima Ali."

ITEM 3.2: THEMED DEBATE – THE CLIMATE EMERGENCY IN SOUTHWARK: A FAIR TRANSITION TO NET ZERO

AMENDMENT A

Proposed by: Councillor Graham Neale

Insert after 3.a

b. That despite promising change, the new Labour government has continued with previously approved oil and gas licenses, and are pushing for carbon capture technology rather than focusing on reducing reliance on fossil fuels.

Insert after 3.d.vi

- vii. But that the Green Buildings Fund failed to deliver projects at pace, until the recent release of the full amount of money following Liberal Democrat calls to do so in last year's alternative budget which Labour voted down.
- viii. Well documented issues with district heating systems, leading to energy use three times expected compared to traditional gas boilers, at both an environmental and financial cost.
- ix. It took three years to ban the approval of fossil fuel reliant homes since declaring a climate emergency, approving 5000 of those homes in that time

- ii. But the Green Finance Initiative, whilst welcome (and was agreed to in a Liberal Democrat motion in 2023), is not ambitious enough, and the speed at which the target was met demonstrates that the appetite is there to go far further.
- iii. More transparency and detail is needed on exactly how the money raised through the GFI is spent, to ensure that maximum value is gained

- vi. Southwark has consistently failed to increase its recycling rate, dropping by 3.4% in 2022/2023, and the only reason food waste recycling is being rolled out is due to national legislative change, despite previous suggestions from the Liberal Democrats. Some residents are already reporting problems with the implementation of the food waste recycling points.
- vii. Action on flytipping and litter which has an ecological impact is not enforced enough in Southwark, with the council managing to fine less than 3% of cases

- n. Introduce an additional advertising policy prohibiting high carbon use products, as Hackney has done
- o. Be far more ambitious on Green Finance, so that a genuinely transformative amount of money can be raised
- p. Introduce more transparency and scrutiny of how Green Finance is spent so that both residents and investors can have confidence that the money is spent in a way that is genuinely good value
- Mandate that public buildings publicly display energy usage and EPC ratings
- r. Tackle the blight of flytipping by introducing community skips
- s. Set an ambition to become not just carbon neutral, but net positive by investing in solar panels, heat pumps, and other sources of renewable energy that we can sell to the grid, with residents taking a cut. Specifically, the council should work with TfL to explore using heat pumps to extract heat from the tube tunnels running under our borough cooling the overheating tube network and providing efficient heat to homes and commercial units.
- t. Welcome Max Wilkinson MPs "Sunshine Bill" that would legally mandate solar panels as standard on all new homes but lead the

- way in Southwark by ensuring all new homes, especially its own Council homes, have photovoltaic generation.
- Set the highest standards for green homes, such that every new home in Southwark is built to at least Grade Four of the Sustainable Homes Code.
- v. Convene a standing Citizens Assembly to oversee and scrutinise Southwark's climate policy
- w. Explicitly commit not to use gas in any new council buildings

 - Continue to work with our voluntary and community sector partners to sign up those who are eligible for pension credit to claim their Winter Fuel Payment before 21 December 2024 deadline.

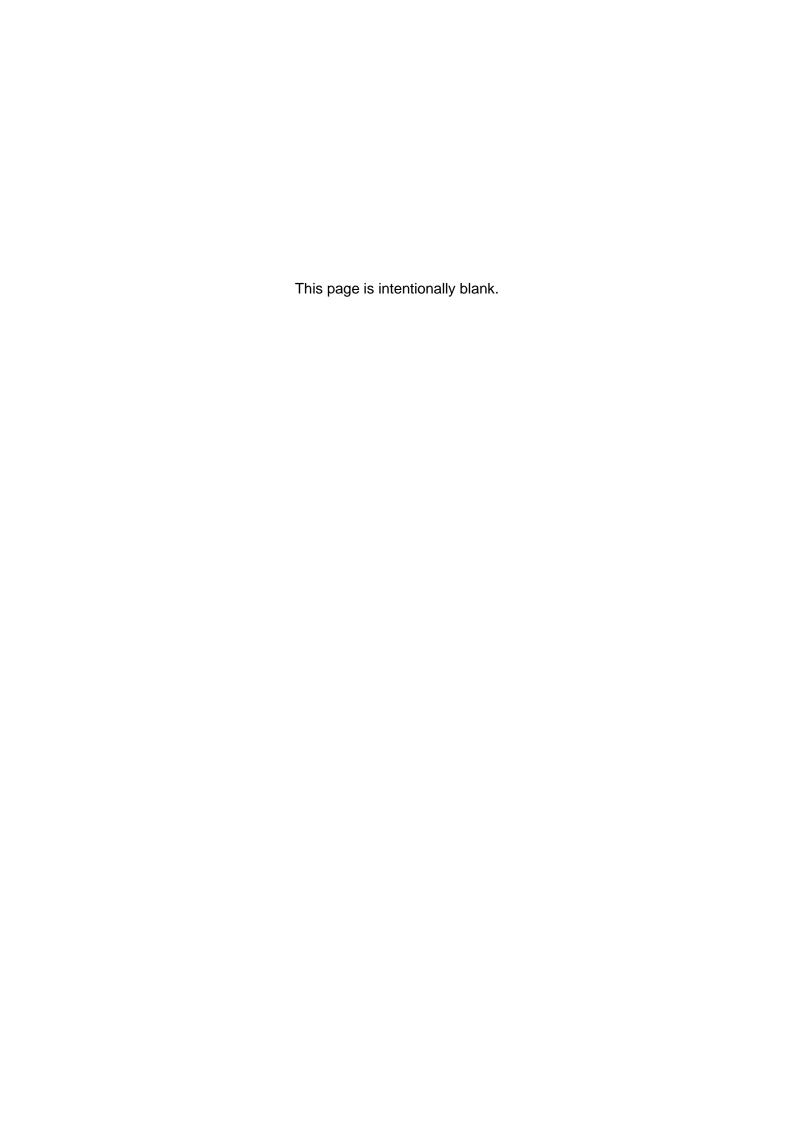
Delete 3.a-b, and **replace** with:

- 3. Council Assembly further recognises:
 - a. Existing work Southwark Council has embarked on to play its role in tackling the climate and nature crises since declaring a climate emergency in 2019 reducing emissions year on year.
 - b. This administration's success in restoring nature by expanding the borough's green spaces, including 30 parks which have been awarded Green Flag status for the 5th year running, planting thousands of trees to reach 100,000 trees on council land, and encouraging greater biodiversity through initiatives such as the

biodiversity fund.

Delete 4.a-d, and **replace** with:

- 4. Therefore, Council Assembly asks Cabinet to:
 - a. Continue the hard work in combatting the climate emergency in Southwark and reversing the depletion of the natural environment, including reducing emissions year on year and expanding the borough's green spaces plantings tens of thousands of new trees and increasing biodiversity across Southwark.
 - b. Support the new Labour government in its record-breaking ambitions to tackle the climate and nature crisis, reducing the country's carbon emissions by 81% by 2035 based on 1990 levels, and working with our communities to restore the natural world.
