RECOMMENDATION

1. That cabinet considers whether or not to hear the late deputation request from Hajia Saidat Oketunde to highlight the positive impact of key initiatives from Southwark Council.

BACKGROUND INFORMATION

2. When considering whether to hear deputation requests, cabinet can decide:
 - To receive the deputation at this meeting or a future meeting; or
 - That the deputation not be received (if the matter is not dealt with by cabinet, the matter shall be referred without debate to the relevant cabinet member who shall after consideration, respond with an open reply to the sender); or
 - To refer the deputation to the most appropriate committee/sub-committee.
3. A deputation shall consist of no more than six people, including its spokesperson. Only one member of the deputation shall be allowed to address the meeting for no longer than five minutes. After this time cabinet members may ask questions of the deputation for up to five minutes. At the conclusion of the questions, the deputation will be shown to the public area where they may listen to the remainder of the open section of the meeting.

KEY ISSUES FOR CONSIDERATION

4. The deadline for receipt of deputation requests for this cabinet meeting was midnight 29 January 2025. The request was received after this constitutional deadline.

Deputation request from Hajia Saidat Oketunde

"I would like to attend the cabinet meeting tomorrow to share feedback received from residents and to express gratitude to our local councillors for their continued support.

I would like to highlight the positive impact of key initiatives, including:

- Summer, Easter, and Winter Programmes– Providing free healthy food for lower-income families.
