- 3. The following deputation requests have been received by the deadline for consideration by this meeting and they are listed in the order received below:
  - 1. Southwark Group of Tenants (SGTO)
  - 2. Southwark Legal Advice Network
  - 3. Cambridge House
  - 4. Southwark Trades Council
- 4. The details for the deputations on the themed debate are set out in this report. The details of the other deputation are set out in item 4.

### Procedure at the meeting

- 5. The council assembly procedure rule 2.6 (11) states that no more than three deputations shall be considered at any one meeting, and deputations shall be considered in the order of receipt. However the meeting can decide to suspend this rule in order to hear more or vary the order.
- 6. When considering whether to hear the deputation request, council assembly can decide:
  - to receive the deputation at this meeting or a future meeting; or
  - that the deputation not be received; or
  - to refer the deputation to the most appropriate committee/sub-committee.
- 7. A deputation shall consist of no more than six people, including its spokesperson. One member of the deputation shall be allowed to address the meeting for no longer than 5 minutes. The deputation spokesperson or any member of the deputation nominated by him or her shall be invited to ask a question of the leader or relevant cabinet member. After this time councillors

may ask questions of the deputation for up to 5 minutes. At the conclusion of the questions, the deputation will be shown to the public seating area where they may listen to the remainder of the open section of the meeting.

### **KEY ISSUES FOR CONSIDERATION**

#### Deputation requests on the themed debate

8. The following deputation requests were the first three requests received on the theme. The deputations are listed in order of receipt.

#### 1. Deputation from SGTO

The deputation request states:

"We wish to hand in a petition which is concerned with the rules of the so called bedroom tax, we are campaigning for the council not to evict tenants who fall into arrears purely due to the extra cost of the under occupancy rules."

#### 2. Deputation from Southwark Legal Advice Network

This deputation request states:

"We wish

- To inform members of the impact so far on the people we see
- To ask the council how they will respond to tenants who have accrued rent arrears due to welfare reform
- To request that the council's anti-poverty strategies address the needs of larger families affected by the benefit cap."

#### 3. Deputation from Cambridge House

The deputation states:

"We wish to address the council assembly to raise awareness of the work we are doing to combat the impact of welfare reform. Cambridge House is having to provide additional services to increasing numbers of existing beneficiaries. Added to this, there are demands for services to address the needs of new beneficiaries, emerging as austerity measures, welfare and legal reforms affect local communities.

One new initiative is the user-led youth empowerment programme which aims to enable the voices of young people to be heard, influence decisions which affect their lives and shape the future of civil society. This project has been developed by young people in response to the increasing number of deaths from street violence and gang culture, and the fear that increasing poverty resulting from welfare reform will exacerbate the situation. Initiated and led by Southwark residents and workers, the project aims to kick-start a coalition of outreach work across London which will be known as 'One Big Community' and is a true example of what can be achieved with energy, belief and understanding of young people within London and an example of what can be achieved in the face of welfare reform with adequate support and funding.

Our deputation will give a brief overview of our work in light of the relevant welfare reform debate as well as provide an introduction to some of the inspiring young people with whom we are working with."

### 4. Deputation from Southwark Trades Council

The deputation states:

"The subject we wish to speak on is Social Security Reforms, to the debate on a 'fairer future'."

#### Including themed debate on welfare reform

**WEDNESDAY 10 JULY 2013** 

#### **SOME COMMUNITY VIEWS**

• I am a taxpayer and council tax payer living in SE1.

I support the coalition government's reforms of welfare – but these reforms barely scratch the surface of the welfare monster originally intended as a safety net for working people. Not a way of living. Work already done to lift the tax threshold eventually to £10k is progress.

The London living wage should also be introduced in tandem with these reforms to make business share some of the burden from the taxpayer. HMRC also needs to toughen up on some cosy relationships with big business to make them pay their tax.

- The British State has created an entire class of people who are utterly dependent upon the state the incentives to compel people to work and pay their way in society are not strong enough. Southwark Council's own data shows us that the majority of residents in social housing are out of work. As long as their rent is paid for by the Council via housing benefit, this situation will not change. It's called human nature.
- Southwark also has one of the UK's worst and shameful records of Council Tax collection - I would suggest that as a Council you focus your efforts on improving this dire record. Recently, the BBC reported that four Southwark councillors had received summons for late payment of Southwark Council tax.
- Welfare also means that money is diverted from productive, wealth-creating, growth-creating activities such as building housing, schools and transport improvements. Such projects will help people back into work a virtuous circle. Housing benefit also ends up in the pockets of private landlords, when the state should be spending this money on housing a crazy situation.
- The way in which Council Housing is allocated also distorts the socio-economic make-up of this borough into two extremes – the very rich who can afford to live in luxury riverside developments granted consent by Southwark council with zero onsite affordable housing – contrasting with Council housing which is only allocated to the poorest. There is no space for anyone in the middle.
- There aren't enough jobs.

Jobs don't pay enough to afford living costs in the UK – that goes double for London.

There is a national housing crisis caused by chronic undersupply and multiple housing booms, happily stoked by governments of all stripes.

The social security spend always goes up in a recession, and Conservative governments always try to use these figure as normative to build sympathy for their argument – i.e. the infantile Shirkers vs. Strivers talking point.

While I salute those who are trying to engage with these issues, these questions in my opinion go far beyond the scope of local councillors. If I have a point of view to feed into the meeting, it's that our local councillors should do what they can to ensure the public is informed. Otherwise you just get the same recycled ignorance that passes for debate on this issue.

- ... As for local communities, I would like to see the Council document the real day-today impact of "benefit reform" on the lives of people in Southwark and report that back to Government.
- I work with people who have physical and mental health disabilities including older people and fear for their future where they do not have income other than benefits to rely on. Accurate and timely information rather than propaganda is needed for these and other affected groups and their carers so they can respond so my question is what efforts are being made by central and local government to access people wherever they are and who maybe can't for example, get out to meetings? What follow up will there be of isolated people who may not now be able to pay for essential services like home care to at least check if they are alive? What efforts are being made to maintain supportive communities and for vulnerable people as cuts close centres and neighbourhoods in SE1 change.
- Good luck Southwark council, please do focus your attention on the people in need, supporting them as best as possible and highlighting their plight with Government and the media.
- Given the demographics of the country and the borough the issue is what is affordable. I have sympathies with both sides of the arguments but what is debatable is what is affordable except within a small band and that is where the subsidy comes from...quite simply local council gets money from central government... that is subsidy in any form and how it is shared out is definitely up for discussion...but it is limited to what it is and no more.

We could discuss the merits of contribution from different (income) groups ad infinitum but it is what we have to spend that is finite and needs to be understood better by all...unless we want to dismantle the whole social system we currently have?

Regarding information on the reform of welfare assistance:

- If you mean information on the impact these cuts are having then all I can say is that
  without my addiction to talk radio, i.e. LBC radio 5 etc, I wouldn't have a clue about
  the plight of those undergoing these reforms, you get to listen to some very upsetting
  calls and suicidal callers.
- Strangely just hearing that Moneybox Live is going to be about Welfare Benefit changes (cuts) today!

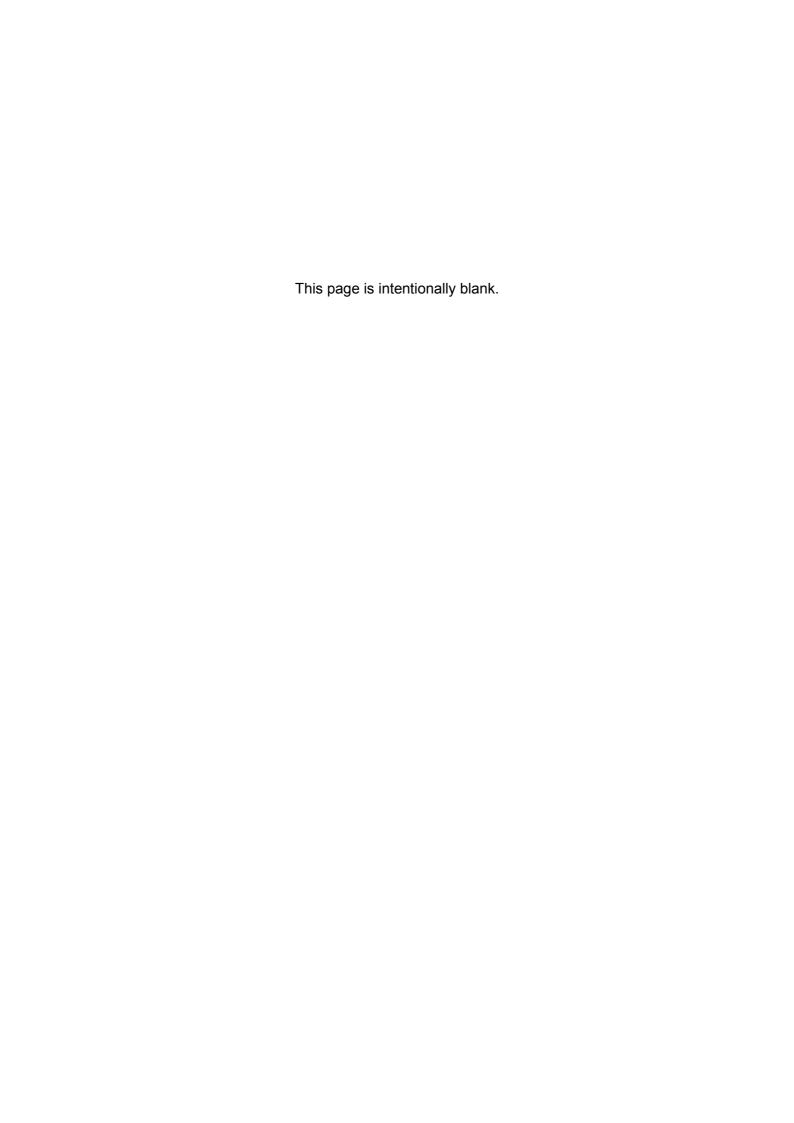
