UPDATE

Harris Federation Free Schools

2. The Education Funding Agency has acquired the former police station on Lordship Lane. This will become the permanent site for the Harris East Dulwich Free School.
3. Officers understand that the federation intends to open in September 2014 with two reception classes on a temporary site yet to be confirmed.
4. The new round of free schools given pre-opening approval in late January 2014 included a Harris Federation 2 form entry primary free school in Nunhead. The school has approval to open in September 2015.
5. A temporary and a permanent site are being sought by the EFA on behalf of the Harris Federation.
