

Q1	Mrs Palmer submitted the following public questions: Is there anything the Community Council could do to help improve community relations between ethnic minorities and the host nation? The BNP feeds off misunderstandings.
A1	Chair: This could be considered as a separate agenda item for a future DCC meeting.
	Cllr Mitchell: East Dulwich Community centre meet up for a wide range of activities and urged people to come along to attend the 'Mark of Faith ' day taking place shortly.
Q2	It is dangerous attempting to cross the road at the junction of East Dulwich Grove and Lordship Lane. Could traffic lights be placed there?
A2	Cllr Mitchell: ED Cllrs considered traffic lights at the crossing of East Dulwich – but are of the view that traffic lights would not help that junction. We might have to look at other possibilities having discussed this with officers in traffic. As long as traffic is forced to turn left in East Dulwich then the junction is manageable in their view.
Q3	Melbourne Grove / Bassano Street overhanging branches are a health and safety hazard.
A3	Cllr Mitchell agreed to speak to Mrs Palmer directly about this issue.
Q4	Melbourne Grove/junction with Colwell Rd. Cars speeding unaware of the curve in the road at that junction are dangerous?
A 4	Cllr Mitchell: Looking at various options - i.e. installing a second pedestrian crossing along Lordship Lane (near Somerfields) which he thinks is needed
Q5	Do small children and school children need to be taught kerb drill?
A5	Cllr Mitchell agreed to speak to Mrs Palmer directly about this issue.

Changes to the funding of local transport improvements

Briefing note prepared for Dulwich Community Council

June 2009

1. Introduction

Each year, the council bids for money from Transport for London to deliver local transport improvements. The council's transport planning team have attended Dulwich community council in previous years to get ideas for local transport improvements, however these have had to fit into Transport for London's strict criteria in order to be considered and there was little opportunity to recognise local priorities.

2. What is changing?

Next financial year (2010/11), the system used to allocate this funding is fundamentally changing. Aimed at making the process fairer and less bureaucratic, the overall allocation for each London borough will now be decided by a formula based on criteria including population, road safety, accessibility and air quality. This means that the council, together with the community will have much more say in deciding what schemes get funded and the timescales for delivery.

Under the new funding calculation, the council has been allocated the £3,349,000 for 2010/11; the sum is likely to be similar over the next three years, allowing us to plan scheme delivery over multiple years. This does not include the maintenance or the area based scheme allocation.

The three new programme areas are:

- Corridors These are schemes on key routes that address issues such as congestion, bus journey time and road safety
- Neighbourhoods Schemes to improve local areas, including traffic calming, public realm and reduction of street clutter
- Smarter Travel The promotion of active travel modes (walking and cycling) and public transport, including the involvement of schools and work places.

3. What does this mean for Dulwich Community Council?

We have been working to identify potential projects for consideration by each of the community councils. These projects have been developed through the creation of an evidence base and the identification of those areas with the greatest need and/or opportunity for improvement.

The following is a list of some of the evidence used for the Dulwich Community Council area:

- Key walking and cycling routes
- Community audit of Lordship Lane
- Demographics (car ownership, levels of deprivation)
- Collision and casualty information
- Community project bank and Cleaner Greener Safer schemes
- Correspondence
- Input from community council meetings and local councillors
- Dulwich Going Greener report from the Dulwich Society

4. Proposed schemes for prioritisation

From the evidence base we have identified five potential schemes within the Dulwich Community Council area. As funding is limited, delivery of these projects would depend on local and boroughwide priorities.

4.1 Lordship Lane (From The Plough to Overhill Road)

This proposal will address pedestrian accessibility and road safety along the length of Lordship Lane from The Plough to Overhill Road. It will take into account the recommendations made in the community street audit and provide better crossing facilities and improve safety at the junctions.

4.2 Grove Vale

This proposal will improve pedestrian accessibility, address vehicle speeds and improve the public realm, particularly around the station. It would include a review of crossings, including the dogleg crossing near Coplestone Road and a study into the provision of pedestrian facilities at the north end of Lordship Lane. The refurbishment of the rail bridge and improvements to lighting are also included as options.

4.3 Crystal Palace Parade

This is primarily a safety scheme and will address safety concerns at the mini roundabout and further south, near the bus station. A safety study has been carried out and the scheme would implement the recommendations contained in the report. In addition to this, the scheme would seek to improve access to the park and from the Kingswood estate.

4.4 Gallery Road

Gallery Road has a history of high vehicle speeds and the council has received a number of pieces of correspondence relating to pedestrian safety and severance. Pending approval for inclusion as pilot location, it is proposed to use an average speed camera to enforce a new 20mph speed limit on this stretch of road. The scheme would also implement the recommendations contained within the Dulwich Going Greener report.

4.5 Bus 42 extension

The council is investigating whether the money could be used to fund an extension of the number 42 bus to Sainsbury's. Council officers are in the process of engaging TfL so that we can better understand the costs that would be incurred. The funding of this may mean that no other major schemes could be delivered if an ongoing commitment to paying for the extension of this service was made through this funding stream.

5. Boroughwide initiatives

In addition to these area specific proposals, we are also developing a package of measures that could be applied across the borough. For example, we are putting together proposals for the travel to school programme and for the provision of cycle training.

6. Next steps

The council is asking that the local community consider the proposed schemes and prioritise them in order of importance. This will help plan our delivery programme for the next three years. Officers will be attending Dulwich community council to discuss the process and go through the proposals in more details. We will be asking that people prioritise the proposed schemes and comment on any other priorities for consideration.




Figure 1 – Proposed scheme locations

Funding transport improvements – the new local implementation plan process.

An overview of the new Lip funding arrangements June 2009

Introduction

The local implementation plan (Lip) sets out how the council works with partners to coordinate and improve its transport infrastructure and services in the borough. Each council in London is required to prepare a Lip to detail how the authority will assist in delivering the Mayors Transport Strategy. Southwark's Lip was adopted in 2006 and will be replaced with a new plan from 2011/12.

The Lip annual progress report (Apr) is the process by which boroughs report on progress and apply for funding to Transport for London (TfL) to implement measures identified in the lip. This document describes significant changes to the funding allocation process for the year 2010/11.

The new funding process aims to reduce bureaucracy and make the system more flexible, transparent, fair and equitable. The process will now be streamlined and much of the allocation boroughs receive will be calculated based on a formula that will replace the previous bidding process.

The greater freedom these changes bring places greater responsibility on the council to identify and prioritise the transport improvements it wishes to see implemented in Southwark.

The new funding process

In May 2009, TfL issued the new guidance for borough funding in 2010/11. This 'transition' year will see significant changes to the Lip funding process prior to the development of the second round of Lips due in 2011/12.

Until now, the projects funded and therefore delivered in Southwark have been strictly regulated by TfL. Each year the council would bid for funds across a complex system of categories. An outcome of this was that there was little opportunity to respond to local needs and community concerns and subsequently requests that did not fit this rigid system were sometimes rejected.

The new system for funding allocation recognises that, within the bounds of the Mayor of London's overarching strategy, it is up to the boroughs to decide how they wish to target their funding. From this overall level of funding boroughs are then asked to put together a programme of projects and to submit these to TfL for confirmation. There will be more scope to develop projects over several years with confirmed funding.

The new funding categories

For 2010/11 there will be just five Lip funded programmes compared to more than 20 previously including;

Maintenance and Bridges	No change	Boroughs receive an allocation commensurate with the condition of their principal roads and any bridges within their area.
Area Based Schemes (large scale streetscape improvement projects)	Minor change	Schemes will continue to be submitted outside of the Lip process via the existing 'step approach', except for smaller schemes under £250,000 in total value where this will no longer be required.
Corridors	Major change	Consolidation of previous categories into one programme. Focus on safety, traffic flows, buses, cycling and walking along key routes. Funding allocated by new formula.
Neighbourhoods	Major change	Consolidation of previous categories into one programme. Focus on traffic speed, parking and better street design in local areas. Funding allocated by new formula.
Smarter Travel	Major change	Consolidation of previous categories into one programme. Focus on travel to schools, hospitals and businesses as well as wider road safety education, training and promotional activities. Funding allocated by new formula.

The new funding formula

For the Corridors, Neighbourhoods and Smarter travel programmes, a formula has been applied to the available budget across London. The essential criteria contained in the formula are: bus performance, road casualties, vehicle delay, CO_2 emissions, population and indices of multiple deprivation. In addition, each borough has been allocated £100K discretionary funding to spend as it sees fit.

The result of this calculation is the following allocation for Southwark for 2010/11:

Corridors	£1,615K
Neighbourhoods	£1,261K
Smarter Travel	£373K
Discretionary funding	£100K
Area based schemes	TBC
Maintenance and bridges	TBC

Now that the funding and guidance has been confirmed, boroughs will develop 'packages' of schemes that match the allocation provided in the above programmes. The total value of these packages may not exceed the overall TfL allocation for the council, but the amount in each programme may be increased or decreased by up to 20%.

The approval procedure

Although the process of bidding for funds has been discontinued, the council is still required to submit the projects or 'packages' of work it chooses to take forward to TfL for 'confirmation'. Each package must demonstrate how it meets or deviates from the Mayor's transport strategy (statement of intent until the new strategy is published). Each package must be costed for each year up to a maximum of 3 years.

Developing project proposals

The new funding process provides an opportunity to ask the community which projects they wish to prioritise. These priorities will then need to be balanced against the need to deliver the council's borough wide objectives before a final list of project packages is submitted to TfL.

A brief summary of the development and consultation process is set out below:

- The executive member for environment will oversee the project selection and prioritisation process. They will provide oversight of the whole process and approve the final scheme list prior to submission to the full executive.
- Officers will use available data (collisions, traffic flows and speeds, walking and cycling routes, previous correspondence and project proposals such as project bank ideas, CGS submissions, community council requests etc) to identify possible schemes according to need / opportunity.
- Each community council will be consulted and asked to give feedback on proposed schemes in their area as well as to suggest any other schemes that have not been covered.
- Key external stakeholders and interest groups will be asked to give their views and proposals.
- The full executive will be asked to ratify the final programme of projects prior to submission to TfL.

A local Plan for Dulwich: Proposals for Village ward, by Dulwich Going Greener and the Dulwich Society

Objectives

To make the ward cleaner, greener and safer; and To contribute to healthier living and the local and wider environment

Means

1. Make it pleasanter and safer to walk rather than drive

For instance:

- safer vehicle speeds: extend the 20 mph zones to cover the whole ward; and enforce the speed limit, using the new average speed cameras when available, starting with Gallery Road, and the handheld cameras described by the police at the Community Council meeting on September 22;
- (2) improve the quality of the footways, by concentrating repairs and renewals on them, and using paviours rather than asphalt, if necessary at the expense of the carriageways;
- (3) make it safe to walk along Gallery Road, by clearing back the vegetation; by the raised table and crossing suggested in 4(1) below
- (4) convert existing zebra crossings to the newly authorised wider "tiger" crossings where appropriate, for instance the crossing of College Road from Dulwich Park to the Picture Gallery;

- (5) extend the use of entry treatments (as at the North end of Stradella Road) so that pedestrians can walk more easily and safely;
- (6) give more footways the protection and visual enhancement of traditional Dulwich white posts and chains, for instance parts of the footways on Court Lane, Red Post Hill and the South Circular;
- (7) provide safer pedestrian crossings or refuges in the shopping areas, for instance at the Herne Hill end of Half Moon Lane;
- (8) widen footways, for instance on the west side of Dulwich Village;
- (9) narrow the mouths of roads with excessively wide splays to help pedestrians, especially those with walking difficulties (as already done for Woodwarde Road at Calton Avenue), for instance the outlet of Woodwarde Road onto Eynella Road and the outlet of Casino Avenue onto Herne Hill.
- (10) require new vehicle crossovers of footways to conform to Streetscape Design Guidance, to protect pedestrians, especially children; and restore footways at abandoned crossovers.
- (11) (jointly with Lambeth Council) implement the approved changes at Herne Hill junction, to improve pedestrian access to Brockwell Park and yield other benefits. (This is now in progress)
- (12) (jointly with East Dulwich ward) implement changes at the "Plough" junction as recommended in the Lordship Lane Community Street Audit

2. Make it pleasanter and safer to cycle

For instance

- reinforce the proposed extended and better-enforced 20 mph speed limits by measures to protect cyclists at danger spots e.g. Dulwich Village;
- (2) advance stop lines for cyclists at all traffic signalised junctions;
- (3) increase Sheffield racks for cycle parking across the ward, e.g. at the corner of Dulwich Village and Calton Avenue, outside the Post Office in Norwood Road, inside Dulwich Park.
- (4) reallocate road space in problem roads, e.g. Turney Road, to reduce speeds and help cyclists
- (5) a cycle hire scheme, as the London Mayor is doing in central London, and now proposes for outer boroughs.

3. Make the area more permeable for walking and cycling

For instance

- (1) open daytime access to the Velodrome site and the Kings College playing fields to provide a pedestrian and cycle route from opposite Giant Arches Road in Burbage Road to Dulwich Village (thus providing a safe route for pupils at the Infants School, Dulwich Hamlet School and, slightly further afield, Alleyns, JAGS and Herne Hill School);
- (2) provide a pedestrian gate at the western end of Dulwich Park to give convenient access during park opening times to the residents of Dekker, Dovercourt, Desenfans and other nearby roads including Court Lane;

- (3) make or improve cycle routes in Dulwich's green areas, for instance a route from West Dulwich station northward beside the railway line, then turning into Turney Road, and thence through the sports fields to Giant Arches Road and thus to Burbage Road;
- (4) consider a traditional churchyard path along the south side of the old graveyard in line with tradition at old graveyards elsewhere
- (5) (in association with the Dulwich Estates) open the Gallery Road end of the path between College Road and Gallery Road ("Grove Lane"/"Lovers' Lane") to cycles, buggies and wheelchairs; (Now done)
- (6) (jointly with South Camberwell ward) re-open the tunnel under the railway connecting the proposed Community Hospital and the homes of East Dulwich with the schools, shops and homes north of the railway.

4. Additional measures to make it safe to walk and cycle to school For instance:

- (1) a raised pedestrian crossing of Gallery Road between DCPS Nursery and Belair Park and a raised table opposite the western end of Grove Lane; (Now done)
- (2) an all-pedestrian phase at the traffic signals at the junction of College Road and the South Circular;
- (3) shared use by pupils up to the age of 12 of the footway on the east side of Dulwich Village.

5. Make public transport better

For instance

- continue to press for extension of the 42 bus route (which terminates at present in Red Post Hill) to Sainsbury's Dog Kennel Hill, thus providing a direct connection between King's College Hospital and the new Community Hospital in east Dulwich;
- (2) resist Southern's intention to reduce services through North and East Dulwich stations from December 2008; (Now a fait accompli)
- (3) put seats, shelters and indicators of when the next buses are due at all bus stops
- (4) (jointly with College ward) get Network Rail to make West Dulwich station more accessible to buggies, wheelchairs and cycles, by gently sloping ramps
- 6. Reduce the need to own one or more cars, by pressing Southwark Council to conclude arrangements with a car club operator for a Dulwich Car Club

7. Make the street environment more inviting

For instance

- (1) continue de-cluttering;
- (2) tree planting, for instance in the build-out at the junction of Village Way and Half Moon Lane.
- (3) enforce against car parking on footways.

For instance

- (1) (jointly with schools) support Walk to School Week, Walk on Wednesdays, provision of Sheffield rack cycle parking inside school premises, and other promotional initiatives;
- (2) (jointly with South Camberwell ward and Sainsbury's) promote use of the newish path between Greendale and Sainsbury's Dog Kennel Hill for "green shopping" from Dulwich Village and elsewhere, and give the path an official name.
- **9. Make full use of the Velodrome site** (both around and within the track) for sports, training, allotments and other uses consistent with its Metropolitan Open Land status.
- **10. Improve the design of College Road** from College Gate of Dulwich Park to the South Circular (possibly by chicane-style layout) to improve car parking for the Gallery at peak times and slow traffic at other times. Widen the footpath outside Pickwick Cottage.

RECOMMENDATION(S)

1. It is recommended that the local parking schemes detailed in the appendices to this report are approved for implementation subject to the outcome of any necessary statutory procedures.

BACKGROUND INFORMATION

- 2. This report presents proposals for a number of local parking amendment schemes, which are matters reserved to Community Council for decision.
- 3. The origins and reasons for the proposals are discussed in the main body of the report.

KEY ISSUES FOR CONSIDERATION

Glengarry Road (0910_Q1_003)

- 4. The network development team received an email from Cllr Eckersley in March 2009 asking if officers could review the current parking arrangements for short-term parkers outside the parade of shops in Dulwich Grove.
- 5. An officer carried out a site inspection at the location to identify a possible location for a time restricted free bay to create turnover in parking spaces.
- 6. It was noted from the site inspection that it would not be possible to install a bay in Dulwich Grove due to the existing 'at any time' waiting restrictions and bus stop. However, it was noted that there is scope to install a bay in Glengarry Road by the junction of Dulwich Grove.
- 7. It is therefore proposed to install a 10 meter time restricted free bay in Glengarry Road operating Mon Fri, 8.30am 6.30pm, with a maximum stay of 30 minutes (appendix 1).

Gilkes Place (0910_Q1_008)

8. The network development team received an email from a resident in March 2009 concerning vehicle and pedestrian safety at the Gilkes Place and Dulwich Village junction. The concern raised was that motorists were parking in Gilkes Place very close or at the junction with Dulwich Village resulting in pedestrians having to negotiate their way around parked cars.

- 9. Parking adjacent to a dropped kerb (or raised carriageway) that has been installed to assist pedestrians crossing is a parking contravention in its own right and there is no requirement for the highway authority to indicate this with any road markings (yellow lines, etc.)
- 10. In view of the preceding paragraph it would usual practice to alert the parking operations team to increase parking enforcement. However, there has also been a request made by the chemist in Dulwich Village for a destination blue badge (disabled) bay to assist those disabled customers wanting to visit.
- 11. A site inspection was carried out by an engineer to look at both issues.
- 12. It was noted that vehicles were parking close to the junction, obscuring pedestrian visibility. It was also noted that the current, informal arrangement of echelon parking would prevent a bay being installed directly outside the chemists.
- 13. Based upon officer observations, it is proposed that a destination disabled bay be installed in Gilkes Place close to its junction with Dulwich Village (but at a sufficient distance so as not to obscure sight lines). This bay would operate 'at any time' but would have a 4 hour maximum stay to encourage turnover of space to assist visitors this maximum stay period is consistent for destination bays across Southwark (and many other London authorities).
- 14. It is further recommended that 'at any time' waiting restrictions are installed in Gilkes Place at the junction of Dulwich Village. These are considered necessary, despite the notes in paragraph 9, because of the proposed disabled bay. It is envisaged that the presence of a designated parking bay would otherwise further encourage parking close or at the junction. It would be necessary to install the waiting restriction on both sides of the road (for a distance that did not exceed the length of the entry table) to ensure clarity to the motorist.
- 15. The proposals are detailed in appendix 2.

Howletts Road (0910_Q1_031)

- 16. The network development were contacted by Cllr Crookshank Hilton in April 2009, regarding the time restricted free bay located in Howletts Road, by the junction of Half Moon Lane.
- 17. The bay falls within the Herne Hill (HH) CPZ and operates Mon Fri, 8.30am 6.30pm, with a maximum stay of 30 minutes, creating a turnover in parking for the shops located on Half Moon Lane.
- 18. At present the bay measures approximately 8 meters in length making it difficult to park two vehicles within the bay.
- 19. It is therefore proposed to extend the bay by 2 meters, as shown in appendix 3, so as to provide sufficient space for two vehicles.

Grove Vale (0910_Q1_062)

20. It was brought to network development's attention by parking operations, that vehicles were parking during the day on the single yellow line in Grove Vale, this was causing obstruction and congestion, particularly buses. A site inspection

noted that upright signage for the single yellow line was missing, therefore making the restriction unenforceable in this non-CPZ area.

- 21. An initial response would be for one of maintenance to reinstate the missing signs. However, the signs have been reported as missing on a considerable number of occasions and it is believed that this is deliberate vandalism to prevent enforcement taking place. Parking operations also reported that civil enforcement officers (CEOs) have previously reported 'code red' (a report that the CEO is experiencing a verbal or physical threat to their own safety) on a number of occasions.
- 22. Officers have carried out a review of the existing restrictions and parking layout. It is recommended that three (two on the Dulwich side) small lengths of single yellow lines (that operate 8.30-6.30 Mon-Sat) are upgraded to double yellow lines (that will operate at any time). This is recommended for two reasons: primarily to assist vehicular flow particularly buses on Grove Vale (part of Southwark's strategic road network) but also to allow continued enforcement and prevent future sign theft as the double yellow lines do not need any upright sign.
- 23. It is therefore proposed to install three sections of double yellow lines in Grove Vale as shown in appendix 4.

Glengarry Road (0910_Q1_023)

- 24. An application has been received by the network operations team for the installation of a disabled persons (blue badge) parking bay. The applicant met the necessary criteria for an origin, disabled persons parking bay.
- 25. The network development team has subsequently carried out a site visit to evaluate the network and ascertain the appropriate location for the disabled bay.
- 26. It is recommended that this disabled bay be installed in Glengarry Road outside No.7 (appendix 5).

Upland Road (0910_Q1_045)

- 27. An application has been received by the network operations team for the installation of a disabled persons (blue badge) parking bay. The applicant met the necessary criteria for an origin, disabled persons parking bay.
- 28. The network development team has subsequently carried out a site visit to evaluate the network and ascertain the appropriate location for the disabled bay.
- 29. It is recommended that this disabled bay be installed in Upland Road outside No.291 (appendix 6).

Nutfield Road (0910_Q1_051)

- 30. An application has been received by the network operations team for the installation of a disabled persons (blue badge) parking bay. The applicant met the necessary criteria for an origin, disabled persons parking bay.
- 31. The network development team has subsequently carried out a site visit to evaluate the network and ascertain the appropriate location for the disabled bay.

32. It is recommended that this disabled bay be installed in Nutfield Road outside No.6 (appendix 7).

Seeley Drive (0910_Q1_054)

- 33. An application has been received by the network operations team for the installation of a disabled persons (blue badge) parking bay. The applicant met the necessary criteria for an origin, disabled persons parking bay.
- 34. The network development team has subsequently carried out a site visit to evaluate the network and ascertain the appropriate location for the disabled bay.
- 35. It is recommended that this disabled bay be installed in Seeley Drive Road outside Sawyer House (appendix 8).

Lordship Lane No. 429 (previously referred as 430) (0809_Q4_021)

- 36. A previous report to Dulwich community council (3 June 2009) sought approval for a bay to be installed outside No. 431 Lordship Lane.
- 37. At that meeting members deferred their decision asking that officers write explaining their rational for this disabled bay.
- 38. Unfortunately a typographic error was made in the report's title and should have read as "Lordship Lane No.429 (0809Q4021)" not "Lordship Lane No.430 (0809Q4021)". This report conflicted with the appended drawing that was issued at that meeting.
- 39. It is noted that there is already a disabled bay outside the applicant's property, No.429 (see appendix 9), this is in use by the neighboring property.
- 40. Network development propose to install the new disabled bay adjacent to the existing disabled bay, outside No.431, as this the closest location to the applicants address.
- 41. Please accept our apologies for any confusion on this issue and we recommend that you approve the bay for No. 429 Lordship Lane to be installed outside No. 431 Lordship Lane, subject to statutory consultation.

Lordship Lane No.473 (0809_Q4_019)

- 42. A previous report to Dulwich community council (3 June 2009) sought approval for a bay to be installed on Lordship Lane opposite Sunderland Court.
- 43. At that meeting members deferred their decision asking that officers investigate if the bay could be installed in Sunderland Court (a private road) and whether further negotiations could take place with the landowner.
- 44. Discussions are still ongoing between the council, applicant and landowner in regard to this matter and further details will be provided to a future community council meeting.

POLICY IMPLICATIONS

- 45. The recommendations contained within this report are consistent with the polices of the PEP and associated Local Implementation Plan (LIP)
- 46. The proposals will support the council's equalities and human rights policies and will promote social inclusion by:
 - providing improved access for emergency vehicles, refuge vehicles, residents and visitors;
 - improving sight lines for all road users; and
 - improving junction and pedestrian safety, especially those with limited mobility or visual impairment
 - provide origin and destination disabled bays to assist residents with mobility impairments

COMMUNITY IMPACT STATEMENT

47. The policies within the Parking and Enforcement Plan are upheld within this report have been subject to an Equality Impact Assessment (EqIA).

RESOURCE IMPLICATIONS

48. All costs arising from implementing the proposals, as set out in the report, will be fully contained within the existing local parking amendment budget.

CONSULTATION

- 49. No informal consultation has been carried out.
- 50. Should the community council approve the item, statutory consultation will take place as part of the making of the traffic management order. A proposal notice will be erected in proximity to the site location and a press notice will be published in the Southwark News and London Gazette. If there are objections a further report will be re-submitted to the community council for determination.
- 51. The road network and parking manager has been consulted on the proposals and has no objections.
- 52. No consultation or comment has been sought from the borough solicitor & secretary or the chief finance officer.
