##### **6.2 292 WALWORTH ROAD, LONDON, SE17 2TE**

**Resolved:**

That the appeal against non-determination is contested by the Council on the following grounds:

1. The proposal, due to the proximity of the building at ground floor to the neighbouring former police station, will create an undue sense of enclosure which will be overbearing and create an adverse impact on outlook to the residential properties in this neighbouring building, harmful to their residential amenities and quality of life, thereby contrary to Policies 3.1 'Environmental Effects' and 3.2 'Protection of Amenity' of the Southwark Plan (2007)
2. Given the position of this site on an historic route, the fact that it has remained undeveloped, and its immediate proximity to the Walworth Village Archaeological Priority Zone, and the high potential for this development to impact on any archaeological remains; the lack of an archaeological evaluation prior to submission of the application prevents adequate consideration of this matter. In the absence of which the Council cannot conclude that the proposal will not give rise to harm to archaeological remains and heritage assets, contrary to Policy 3.19 'Archaeology' of the Southwark Plan (2007) and PPS5 'Planning for the Historic Environment' 2010.
