1. INTRODUCTION AND WELCOME

The chair welcomed members of the public, councillors and officers to the community council meeting.

2. APOLOGIES

Councillors Andy Simmons and Lewis Robinson submitted their apologies for lateness.

4. ITEMS OF BUSINESS THAT THE CHAIR DEEMS URGENT

5. MINUTES FROM THE PREVIOUS MEETING

7. CHAIR'S ANNOUNCEMENTS

The chair announced:

There would be a multi cultural film screening of and discussion about the Mosque: The Story of Islam in Southwark on Saturday 2 April 2011 between 5pm – 8pm.

There would be a Council Assembly meeting on 6 April 2011. Part of that meeting would consider a document called the future for Southwark developing our plan for the Borough. 8. DRAFT AIR QUALITY STRATEGY AND ACTION PLAN

Bill Leggasick, Principal Environment Officer presented this item.

Air quality affects us all in our daily lives and we breath in pollution from a variety of sources which cause health effects. As part of reviewing and assessing air pollution the process which identifies all pollutant concentration objectives were met in Southwark with the exception of NO₂ (nitrogen dioxide) and PM₁₀ (particulate matters) dust particles. The air quality map in 2002 shows high levels around Elephant and Castle and Camberwell. This is being addressed through the Council's air quality strategy and improvement plan which is now being updated. The London Mayor has also come out with their air quality strategy emphasising the importance of reducing emissions from vehicular transport and protect public health and monitor air quality.

The main objectives to improve air quality:

- To tackle carbon emissions transport sources i.e. pollution coming out of diesel engines.
- To protect public health and monitor air quality.
- To reduce emissions from new development.

9. COMMUNITY SAFETY UPDATES - VILLAGE WARD UPDATE

Sergeant Jeff Jenkinson from the Police safer neighbourhood team responsible for Village ward presented this item.

Sgt Jenkinson outlined the work which the team did in December 2010 with regards to neighbourhood policing and operations which were done in conjunction with Lambeth Police. He also reported on the priorities that was discussed at the police ward panel meeting on 28 January 2011 which includes:

- Robbery
- School dispersals
- Night patrol, burglary
- Crime prevention and
- anti social behaviour.

The Sergeant spoke about the crime figures, 54 were reported last year and vehicle crime was on the increase which the SNTs are currently addressing.

The safer neighbourhoods teams' consultation took place in January 2011 whereby the chief inspector Rob Harper spoke at all the ward panels; feedback and updates would be given at the June community council.

The meeting were also informed on other policing matters such as long term crime, mental health issues, community sentences and police monitoring.

The SNT has a problem solving process which gets recognition as a London wide scheme.

There is a regular youth and policing meeting at Herne Hill Baptist Church to discuss issues young people have concerns about and officers from fire arms unit, territorial army and other groups are invited to the meeting.

Sgt Jenkinson responded to questions on the main elements of crime i.e. motor vehicle crime or malicious damage.

The safer neighbourhood panel took place on 9 March 2011 at St Barnabus Church.

10. VILLAGE WARD FOCUS

This part of the meeting was a theme on Village ward which covered:

Welcome introduction from the Dulwich Picture Gallery

The Director of Learning and Public Affairs from the Picture Gallery was present to welcome those present at the meeting. She spoke about the history of the Gallery and that it was celebrating the 200th anniversary of opening, 1811 – 2011. Galleries around the world have modeled the Picture Gallery and it hosts series of events and provides community support by holding a number of educational activities for older people like arts and craft classes, work in partnership with local GPs for those who prefer not to attend a day centre. The Gallery offers support to local people by running a programme called 'urban group' on local housing estates to keep young people off the streets and to ensure they stay creative.

A lot of the programmes are possible due to overwhelming support they have received, they also rely on donations. On average around 120,000 visitors attend the Gallery daily many are local school children.

The representative spoke briefly about the Norman Rockwell's America exhibition which was on show at the Gallery.

Dulwich Festival 2011, Dulwich Fayre on 15 May 2011

Representatives from the Dulwich Festival were present to outline that the festival has been running since 1993 which consists of arts, artists and local performers. During the festival part of The Village. The representatives are looking for volunteers and stewards on the day and they hope to receive the necessary licenses to host the event. It is fully supported by the local residents and Councillors which would also host a community council event. For details of the events please refer to website: http://www.dulwichfestival.co.uk

Presentation from the Director of the Dulwich Helpline

Barbara Scott, Director of the Dulwich Helpline presented this item and spoke about her role and the main aim of the project which is to help older people to ensure they are less lonely and support them in their living environment.

There are twenty two activity groups every week like gardening projects and other similar activities. The project also helps with minor decorations and tasks in the home.

Barbara talked about the intergenerational work with local Schools, technology classes, e.g. mobile and email which is very popular. She said it is very important to break down barriers and to help social cohesion. Social interaction promotes good mental health for the older age group. They recruit local people to help with the classes and day to day running of the office.

The project receives local donations and funding from the Council and Primary Care Trust to help with running costs. They also organise fund raising events and are always looking for volunteers to help Dulwich Helpline. More information is available on the website: http://www.dulwich-helpline.org.uk

Mark Evison Foundation

Margaret Evison was present to talk about the Mark Evison Foundation set up in memory of Lieutenant Mark Evison. He was a British army officer who died from a gun shot wound whilst serving in Afghanistan. His school friends are trustees and have helped raise a quarter of million pounds. The aim of the foundation is to create grants to fund the dreams and adventures of disadvantaged youths. Save the Velodrome Campaign

Hillary Peachey, leader of the Velodrome Campaign was in attendance and spoke about the Herne Hill Velodrome which sits on Burbage Road. The campaign started six months ago, it is a non profit organisation which were awarded charity status and has received a lot of support. However more support and finances is needed to keep securing its development and progress.

The campaign has been formed to save a former Olympic stadium from closure. The Herne Hill Velodrome is the oldest cycling track in the country and the home of the 1948 Olympic Cycling Championships. But now it faces closure due to deterioration and lack of funding. The trustees would like to recruit more volunteers and to establish as much support as possible. Meetings are held regularly in the local area.

Hillary responded to questions from those in attendance.

Village Ward Councillor

Councillor Robin Crookshank Hilton was present to talk about support for local groups in the area and said she was most proud of the Millwall Community Football scheme. Representatives from the football scheme were also available to highlight what they had achieved i.e. received their coaching certificates and how they would like young people to become involved in order to keep them off the streets. There are sessions that take place every Saturday at JAGS (James Allen Girls' School) that has football facilities and astro turf pitch. Any group between the ages of 15 – 19 years of age could attend no matter what their gender.

The chair thanked the representatives for attending and contributing to the meeting.

11. VILLAGE WARD FOCUS CONT.. AFTER BREAK

John Major, chief executive from the Dulwich Estate introduced his item with a power point presentation..

A summary of this presentation is attached to the minutes.

John Major responded to questions which covered topics: Tree works, solar panels,

maintaining the streetscape in general and its relationship with the Dulwich Society.

He also listened to the concerns expressed by local residents about looking after community facilities, the increased cost of rates and rent, shortage of allotments in the area and the possibility of changing small areas of playing fields into allotments.

The chair thanked John Major for his presentation and responding to questions..

12. PUBLIC QUESTION TIME

Q1: How much money has been spent on the alterations at the roundabout end of Burbage Road, which were wrongly aligned and have been dug up and realigned. Residents in Burbage Road were not consulted and there has been a massive waste of tax payers money. A pedestrian who crosses the Dulwich Village Road is blocked on the bank side. As well as being inoperable it is also in the wrong place?

A1: Chair requests that a response from officers be given at the next meeting.

Q2: We have heard this evening of the various works that are made possible by volunteers and grants from the Council. Does the PELO Sports Club in Burbage Road receive any help?

A2: Chair requests that a response from officers be given at the next meeting.

Q3: The Transport Plan draft of December 2010 on 20mph streets, cycle lanes are not be provided or removed; what action does the Council propose to take to ensure drivers obey the 20mph limits e.g. in College Road?

A3: The 20mph zones are self enforcing design with speed humps whereas those that are not 20mph zone are police enforcing.

Alleyn's College of God's Gift at Dulwich

Edward Alleyn, successful actor/manager and entrepreneur bought the Manor of Dulwich in 1605 for £500 and later created a charitable foundation, endowing it with his estate.

Construction of his College and Almshouses began in 1613 and Christ's Chapel of God's Gift was consecrated on 1 September 1616 by the Archbishop of Canterbury.

On 21 June 1619, Alleyn's College of God's Gift at Dulwich was formally established with letters patent granted by King James 1:

"to found and establish a college in Dulwich to endure and remain for ever".



Alleyn's College of God's Gift at Dulwich



Almshouses The Chapel The Old College



Beneficiaries

Alleyn (who had no children) died in 1626 leaving an endowment for a Master, a Warden (both to be of the name of 'Alleyn'), four fellows, twelve poor scholars and six poor brethren and six poor sisters

Beneficiaries were chosen from the four parishes with which Alleyn was associated:

St Botolph's Bishopsgate, where he was born

St Saviour's Southwark, where he lived and had been Churchwarden

St Giles Cripplegate, where his Fortune Theatre was situated and

The Parish of Camberwell where his Manor lay

Out of Alleyn's College for twelve poor scholars, three Dulwich schools evolved:

James Allen's Girls' School (1,070)

Dulwich College (1,617)

Alleyn's School (1,198)

(2010 pupil numbers in brackets - 3,885 in total)



Beneficiaries

The six poor brothers and six poor sisters originally lived in almshouses built on either side of the Chapel. **The Dulwich Almshouse Charity** continues today in accordance with the Founder's wishes:





Beneficiaries today

Following a reorganisation in 1995 with new Charity Schemes approved by the Charity Commission, the Foundation's name changed from *Alleyn's College of God's Gift at Dulwich* to *The Dulwich Estate* and the Charity's Beneficiaries were redefined:

Christ's Chapel

The Dulwich Almshouse Charity

Schools:

Dulwich College

James Allen's Girls' School

Alleyn's School

The Central Foundation Schools of London

St Olave's & St Saviour's Schools' Foundation

Beneficiaries' entitlement from the Charity: the annual net income - £5. 4 million for 2009/10

The Board's objective: to manage the assets in the best interests of all the Beneficiaries.



Constitution & Governance

The Estate is subject to Charity Law and its constitution is set out in the Scheme approved by the Charity Commission on 31 July 1995

It is governed by a Board comprising 14 "competent persons" nominated by:

- 1 The Lord Archbishop of Canterbury
- 1 The President of the Royal Institution of Chartered Surveyors
- 1 St Olave's and St Saviour's Schools Foundation
- 1 Central Foundation Schools of London
- 1 The Dulwich Almshouse Charity
- 2 Dulwich College
- 2 Alleyn's School
- 2 James Allen's Girls' School
- 3 Co-opted

Trustees serve two terms of 5 years – unremunerated and cannot benefit from the Charity

Unincorporated body – Trustees **unlimited liability** (jointly and severally)!!



The Estate

The Charity's main asset (in addition to a stockmarket portfolio and property outside Dulwich) is its Estate in Dulwich, covering some 1,500 acres.





Management of property stock

The Estate seeks to proactively manages its stock of property in Dulwich:

- Buildings well maintained cyclical programme for repairs
- Both commercial premises and residential property well presented
- Opportunity taken to improve stock when vacated, recent examples: 96 Park Hall Road (formerly Oddbins) & 24 Half Moon Lane (formerly Lloyds TSB)

Plans in hand for conversion of Crown & Greyhound to provide hotel accommodation on upper floors

Development of former dairy site in Croxted Road

The Trustees are bound by Charity Law to manage the assets of the Charity in the best interests of its **Beneficiaries** and not necessarily the community or residents:

The Charity cannot 'engineer' the mix of shops or services provided from its properties which is a product of market forces; the Estate cannot subsidise certain businesses (however the Post Office is treated as a special case).

The Estate will, where possible, work with its tenants to achieve their objectives, e.g., the Velodrome – deal struck with British Cycling to enable track to be resurfaced and working with the *Save the Herne Hill Velodrome Campaign*.



Why Dulwich remains a green and pleasant oasis in South London

Post Leasehold Reform Act 1967 control over development is effected through a **Scheme of Management** (established in 1974): freeholders of former leasehold residential property require consent before making changes to the external appearance of property or any works to trees. This applies to some 3,950 freeholders living within the boundaries of the estate.

No 'permitted development' under the Scheme – Scheme can override local authority consent.

The Trustees of the Estate are Managers of the Scheme and the rights and powers conferred are "for the purpose of enabling them to preserve the amenities of the Estate for the common benefit".

Applications for change are decided on their impact on amenity, in particular, that of immediate neighbours:

Managers' publish *Policy Guidelines* to assist freeholders in understanding what will, generally, be permitted.

Maintain 'streetscape'. Liaison with local amenity group, The Dulwich Society.

Consultation process – Advisory Committee and neighbours.

Where there are objections, applications decided by Scheme of Management Committee.

Why Dulwich remains a green and pleasant oasis in South London

Not a bar to development but the Managers encourage quality architecture and design.



The Scheme, a non-charitable activity, cost neutral to the Charity. Costs of operation recovered through an Annual Charge to freeholders (apportioned according to Council Tax bandings): for 2009/10 this ranged £37.36 for Band A to £112.10 for properties in Band B.

Rationale for the Estate to continue the operation of Scheme of Management: this preserves and enhances the value of the Charity's own property holdings.

Scheme gives rise to misconception: The Dulwich Estate exists for the 'good of Dulwich': not so, the Charity exists for its Beneficiaries.

RECOMMENDATION

- 1. It is recommended that the following local parking amendments, detailed in the appendices to this report, are approved for implementation subject to the outcome of any necessary statutory procedures:
 - Holmdene Avenue Install one disabled persons (blue badge) parking bay
 - Heber Road Install one disabled persons (blue badge) parking bay
 - Green Dale Install at any time waiting restrictions
 - Allyen Park Install waiting restriction (Mon-Fri 8-10am 3-5pm)

BACKGROUND INFORMATION

- 2. This report presents proposals for a number of local parking amendments, which are reserved to the Community Council for decision under Part 3H of the constitution.
- 3. The origins and reasons for the proposals are discussed in the main body of the report.

KEY ISSUES FOR CONSIDERATION

Origin disabled bays - Holmdene Avenue and Heber Road

- 4. Two applications have been received by the network operations team for the installation of a disabled persons (blue badge) parking bay. In each case, the applicant met the necessary criteria for an origin, disabled persons parking bay.
- 5. The network development team has subsequently carried out a site visit to evaluate the road network and carried out consultation with each applicant to ascertain the appropriate location for each disabled bay.
- 6. It is therefore recommended that disabled bays be installed at the following locations, see appendices for detailed design:

Green Dale - 1011Q4010

- 7. On 10 February 2011a network development engineer along with two officers from the parking operations team were invited by Councilor Crookshank Hilton to a site meeting in Green Dale to discuss concerns raised about dangerous and inconsiderate parking during the school run.
- 8. Whilst at this site meeting it was noted that parents were parking and waiting for their children, this commenced approximately 30 minutes before the children leave the school.
- 9. The significant number of vehicles picking up or dropping off children results in some motorists using the junction entrance to the housing estate to park. Other vehicles were observed parked in a dangerous or, at least, inconsiderate manner.
- 10. During the site visit the council's enforcement contractor (APCOA) had sent two civil enforcement officers (CEO's) to enforce the area outside the school.
- 11. At the north-western end of Green Dale, where it joins with the housing estate road, there are a considerable number of existing road markings: double yellow lines, a hatched yellow box and the wording 'keep clear' some of which are on the public highway and some on housing estate land. The mix of road markings all construe the same message (no parking) but the absence of a consistent delivery means that motorists may not get a clear message; as well as being an intrusive amount of road paint.
- 12. It is proposed that the yellow box junction markings and keep clear wording are removed from the estate road and double yellow lines are installed. These will be tied into the double yellow lines on the public highway.
- 13. It is noted that the removal of the yellow, hatched box on the estate could lead to some motorists thinking it is now acceptable to park in the middle of the junction such is the width of the road at this point (adjacent to the estate road) and this may well be the reason the yellow box was initially installed. However, it would still be a civil parking offence to park in that location (due to the presence of the yellow lines along the kerb). Additionally, yellow box markings would no longer be permitted to be installed in such locations.
- 14. Network development have discussed this issue with the estates parking contract manager, who agrees that the restrictions on both the estate road and the public highway should match and has agreed that once this is completed that duel enforcement can take place.
- 15. It is recommended that, as shown in Appendix 3, that at any time waiting restriction are installed to protect the entrance to the estate and to provide a turning head for vehicles to exit from the cul-de-sac of Green Dale.

Allyen Park - 1011Q4003

16. Network development were invited to a site meeting held on Allyen Park along with

- officers from parking operations, transport planning, Transport for London, local ward member and local residents to discuss parking and junction safety issues.
- 17. The main purpose of the meeting was to discuss issues relating to the Transport for London Road Network (TLRN) also known as the red route, which are not matters for this report.
- 18. However, local residents did raise concern about property access/egress and traffic flow in Allyen Park. The area of particular concern was in Alleyn Park between its junction with Dulwich Common and the existing width restriction, approximately adjacent to No.107 Alleyn Park.
- 19. It can be observed that this area correlates with a marginal reduction in the width of the carriageway.
- 20. All residential properties in this stretch have off-street parking and are situated opposite Dulwich College playing fields.
- 21. Allyen Park is uncontrolled and vehicles park along the eastern side during the day, however when this kerbspace is exceeded, vehicles park on the western side which reduces the highway width preventing two vehicles to pass one another.
- 22. The residents state that when vehicles are parking both sides of the road the obstruction results in drivers sounding their vehicle horns and arguing with each other.
- 23. The proposal favored by those at the site meeting was the introduction of split waiting restriction preventing parking in the morning and afternoon. This is proposed to discourage commuters, improve traffic flow and access to residential properties.
- 24. It is recommended that, as shown in Appendix 4, that a split waiting restriction, operating Monday to Friday 8 to 10am and 3 to 5pm, is installed to improve traffic flow, protect access to residential properties and prevent commuter parking.

POLICY IMPLICATIONS

- 25. The recommendations contained within this report are consistent with the polices of the Parking Enforcement Plan and associated Local Implementation Plan (LIP)
- 26. The proposals will support the council's equalities and human rights policies and will promote social inclusion by:
 - Providing improved access for emergency vehicles, refuge vehicles, residents and visitors
 - Improving sight lines for all road users
 - Improving junction and pedestrian safety, especially those with limited mobility or visual impairment; and
 - Provide origin disabled bays to assist residents with mobility impairments

COMMUNITY IMPACT STATEMENT

27. The policies within the Parking and Enforcement Plan are upheld within this report have been subject to an Equality Impact Assessment (EqIA).

RESOURCE IMPLICATIONS

28. All costs arising from implementing the proposals, as set out in the report, will be fully contained within the existing local parking amendment budget.

CONSULTATION

- 29. No informal (public) consultation has been carried out. Where consultation with stakeholders has been completed, this is described within the main body of the report.
- 30. Should the community council approve the item(s), statutory consultation will take place as part of the making of the traffic management order. A proposal notice will be erected in proximity to the site location and a press notice will be published in the Southwark News and London Gazette. If there are objections a further report will be re-submitted to the community council for determination.
- 31. The road network and parking manager has been consulted on the proposals and has no objections.
- 32. No consultation or comment has been sought from the Strategic Director of Communities Law and Governance.






