### 1. INTRODUCTION AND WELCOME

The chair welcomed everyone to the meeting and asked councillors and officers to introduce themselves.

### 2. APOLOGIES

Apologies for absence were received from Councillor Mark Glover and apologies for lateness from Councillor Gavin Edwards.

### 3. DISCLOSURE OF MEMBERS' INTERESTS AND DISPENSATIONS

Councillors declared interests in the following agenda item:

Agenda item 15, School Governor Nominations

Councillor Renata Hamvas, Personal and Non Prejudicial, as the councillor's children attended the school which the school governor nomination related to.

### 4. ITEMS OF BUSINESS THAT THE CHAIR DEEMS URGENT

The chair announced that she had accepted agenda item 16 local parking amendments, as a late and urgent item as a decision had to been taken for implementation in the current quarter.

### 5. MINUTES

### **RESOLVED:**

That the minutes of the meeting held on 10 November 2011 be agreed as a correct record of that meeting, and signed by the chair.

### 6. UPDATES FROM PREVIOUS MEETINGS

The updates received from the previous meeting were noted, including responses received after the agenda was published.

### 7. DEPUTATIONS/PETITIONS (IF ANY)

There were none.

### 8. COMMUNITY ANNOUNCEMENTS

The following community announcements were made.

Civic awards – Peter Frost from Southwark's civic association explained that the awards recognised anyone who had done good work in the borough. Application forms could be requested from the clerk or forms could be completed on line at the civic association's website. There would be an awards ceremony in May and the closing date for applications was the end of January.

**Supporting choices web pages** - James McConnell outlined that new adult social care web pages had been developed to help people live well and safe in the borough. The aim was for people to find all the information they needed to meet their needs in one place. The site had been user tested by a variety of audiences and was very accessible. People could use the site for things like finding out about community events or finding a volunteer for maintenance. If people were unsure about using the internet there were free internet courses available at local libraries.

Linda Upton from the SNT announced that Charlie Griggs had been appointed as Borough Commander.

### 9. **RECYCLING**

Ian McGeough from Veolia spoke about the new waste management facility off the Old Kent Road which was replacing Manor Place. The facility was now operational and people could use the facility to recycle the same materials as Manor Place and pick up compost bins and wormeries. The facility also sorts recycling materials for the borough.

Councillor Rowenna Davis asked Ian what was the most irritating item that ends up in recycle bins. Ian responded that it was nappies. Councillor Rowenna asked what time the facility would be open to purchase compost bins and drop off bulky waste. Ian stated that the facility was open from 8am to 6pm 7 days a week.

lan took questions from the floor. A resident asked if there were any plans to recycle polystyrene in Southwark as he had heard that it could be used as a building material. Ian stated there were currently no plans as there was little value in this but as things developed that may change in the future. Another resident asked if the plant was functioning to capacity and if there were plans to extend to other boroughs. Ian stated at the moment it wasn't at capacity as the facility had only recently opened. Further questions were asked on whether small things such as mobile phone chargers could be recycled and whether there were plans to extend food waste recycle to residents who used the clear bags. Ian responded that small electrical goods could be recycled but were collected as part of the bulky waste collection. There was a plan to trial food waste recycling services in some housing estates and Ian asked for people to get in touch if they were interested in taking part in a pilot scheme.

Councillor Althea Smith asked about how this would work on estates in terms of brown bin provisions when there were currently issues with waste collection on some housing estates. Ian agreed that they needed to make sure the services residents received were up to scratch and encouraged residents to get in touch if there were any issues on their estate.

lan explained that wood could be recycled. Some materials would be resold to be reused if they were not recyclable. If they were not reusable then they would go to landfill as waste.

### 10. RECYCLED TEENAGERS

Carl Campbell, introduced the recycled teenagers who were a group of pensioners who danced as part of an active and healthy lifestyle. The group had received recognition on national TV on the Paul O'Grady Show and Carl showed a film of their performance. Carl then led the group in a performance asking councillors and meeting attendees to get involved.

The chair thanked the recycled teenagers for their energetic performance and encouraged people to get in touch with Carl if they were interested in joining the group.

### 11. SOUTHWARK'S BUDGET 2012/12

Councillor Richard Livingstone, cabinet member for finance, resources and community safety, outlined the budget process for 2012/13. Overall the council had a budget of about £1.6 billion, around £320 million of that was considered in terms of spending as the other elements were restricted or ring-fenced. There had been massive cuts in the public sector and it was expected that these would last 6 years rather than the four initially outlined by central government. Local government was one of the areas hit the hardest by the cuts and Southwark sought savings of around 28% over the next three years. Southwark was reliant on government funding for about three quarters of its spending and around one quarter came from council tax.

The cabinet aimed to keep some money to freeze council tax and aimed to ensure all primary school children received free healthy school meals. Cllr Livingstone explained that last year Southwark had introduced a pay increase to its lowest paid employees and that it was hoped in 2012/13 the London Living wage could be introduced to those who worked indirectly for the council such as contractors. £1million was going to be used to set up a community restoration fund to provide facilities for young people and to help small businesses affected by the disturbances. The cabinet also aimed to introduce a Cleaner, Greener, Safer revenue fund to community councils.

In response to questions from the floor Cllr Livingstone explained that growth items in the budget were areas which required additional funding for example the youth fund or free school meals. There were benefits to providing free school meals across the board rather than asking parents to contribute. Firstly, Southwark had an obesity problem and the meals were healthy as well as free. Also, by providing across the board it de-stigmatised the receipt of free school meals.

Councillor Renata Hamvas added that there was nothing to stop parents contributing to schools in other ways for example by giving a donation to school events. She stated that she took part in some of the parent feedback groups and there was lots of anecdotal evidence from parents relating to the benefits of free school meals.

Cllr Livingstone was asked about concessionary fares and would they continue to be provided. He explained that they hoped to continue the service but there were new pressures to absorb as fares went up so did the cost to the council. There were also pressures for other boroughs without the level of public transport use as in Southwark to contribute less to the scheme.

In response to questions on the transition fund and partnerships with the voluntary sector Cllr Livingstone explained that the council was considering how best to work with the voluntary sector in order to maximise resources, the council would give organisations three months notice if they planned to reduce their funding in order to give them time to plan ahead, the transition fund was available for organisations to apply for in order to help them adapt to change. Cllr Livingstone welcomed new ideas on partnership with the voluntary sector. The council were looking at if services could be set up as social enterprises and if there were opportunities to work with other London Borough's to deliver services in a better way.

Cllr Mills asked about the youth restoration fund and Cllr Livingstone explained that around

half of that would be available for youth facilities and that the council would work with bodies in the voluntary sector involved in youth provisions to work out a criteria for that funding. Residents suggested that the council look beyond youth organisations in establishing the fund as other groups also had ideas, for example grandparents.

A resident asked about the level of council tax Southwark expected to collect. Southwark had brought services in house to improve the rate of collection and it was expected that around 96% would be collected as more people move into the borough more would be collected from council tax but this would increase pressure on services.

In response to further questions Cllr Livingstone explained that it was not clear what level the GLA element of council tax would be set at. Adult social care was one of the biggest elements of the council's budget and the council were working to keep some housing shelters open compared to other boroughs which had closed all of theirs. The council was also working with other organisations such as the police and immigration services identifying that the Olympics may add pressures.

### 12. PUBLIC QUESTION TIME

A resident asked about traffic issues on Astbury Road which had been raised at several meetings previously, producing photographs of lorries getting stuck on the road. Councillors responded that the issue had been raised with TfL on numerous occasions and they had promised to undertake a traffic survey which had not yet been done. The issue had been raised with Harriet Harman and Val Shawcross, councillors urged residents to keep the pressure on TfL to complete the survey.

Councillors were asked about plans for the Golden Jubilee and the Olympics and what the impact would be on the borough. Councillors responded that they hoped a legacy would be built from the Olympics and funding had been made available to local groups for that purpose. There would also be cultural events in the borough around the Olympics and the Southbank would be dressed. There would of course be additional costs associated with more visitors to the borough.

# Proposed works at Camberwell Old Cemetery

# February 2012

Like many other Council's Southwark is running short of space within its cemeteries. In April 2011 the council decided to undertake a programme of works in the borough's existing cemeteries to ensure that it can continue to provide a burial space for residents, while at the same time seeking views about the long terms options available to it.

Since then we have created over 300 new burial plots in Camberwell Old Cemetery and Camberwell New Cemetery, providing enough burial space for nearly two years.

The next step involves re-use of an area of over 7,000 square metres at Camberwell Old Cemetery, Forest Hill Road, SE22 that has previously been used for public burials (shown on the plan overleaf).

The intention is to raise ground levels by up to one metre through topping up with extra soil. The added depth will allow for new burials at this location. The works will include-

- Clearance of scrub and trees and fallen trees and stumps as part of planned maintenance in January.
- A new temporary entrance for construction vehicles and site hoarding at Wood Vale
- Delivery and distribution of approx. 4640 cubic metres of soil to the area
- New foot paths including a new path for the Green Chain Walk
- Grass turfing to create new lawns
- Planting of new trees and shrubs
- Removal of trees in poor condition
- Installation of gravel memorial strips

The works will be subject to a formal planning application in March 2012.

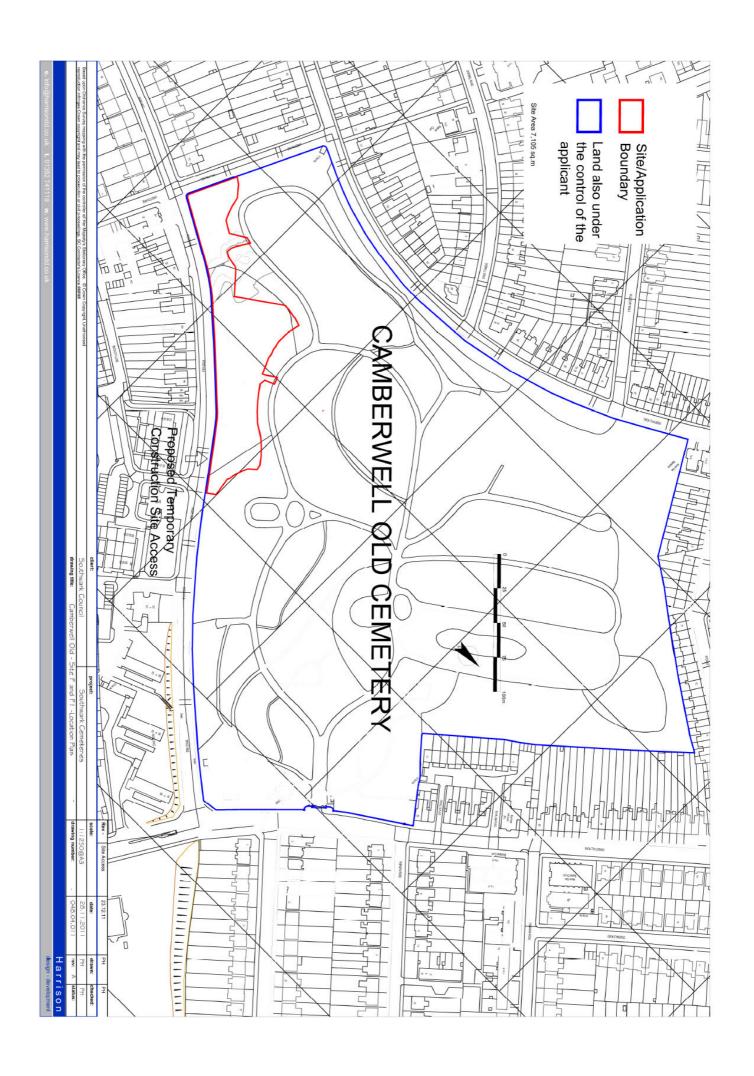

### **Camberwell Old Cemetery**

### FAQ sheet - Proposed New Burial Space

### 1. How many trees are proposed to be felled?

20 small/immature/+14 medium/larger trees to be felled (generally selected as being those with the poorest condition/form)

97 trees (feathered/standard/extra heavy standard trees to be planted by way of replacements)

# 2. Is the proposed removal of trees and shrubs likely to have a major impact on visual amenity?

No major adverse impact - change will be evident along the boundary of Wood Vale but significant numbers of the more mature /larger trees would be carefully retained within the layout. With the removal of trees along the boundary (notably young self seeded ash) views into the cemetery will be more readily available (initially) but in those views the extensive tree cover within site and within the remainder of the cemetery will dominate the view. Extensive boundary planting is proposed including feathered and extra-heavy standard trees along the boundary as succession planting.

# 3. Approximately how many lorries will be required to deliver 4640 cubic metres of soil?

Approximately 420 to 480 lorries

4. Will the delivery route for the lorries be restricted to Forest Hill Road and a short section of Wood Vale to ensure that residents are not inconvenienced by numerous lorries travelling along residential streets?

Approach via - A205/B218(B238Honor Oak Park Road)B238 (Forest Hill Road)/Woodvale- Right hand turn into site

Egress Left hand turn out of site, then converse of approach route.

Envisaged most deliveries will enter site forward but at completion deliveries will necessarily reverse into site.

# 5. What restrictions will the council place on the times and days of the soil deliveries?

Anticipated 25 lorry movements daily (24 in, 24 out) over 5.5 days per week 7.30am to 4.30pm (7.30am to 12noon Sat) over 4 week period (average turnaround time of 20minutes per delivery)

# 6. What steps will the council take to minimise problems with dust from the soil deliveries?

Soils will be relatively heavy (clay) and therefore dust from site not envisaged a major problem.

All soil delivery wagons should be sheeted.

In periods of dry weather contractor required to use dust suppression measures including but not limited to wetting of dust generating soils/materials at point of delivery/after delivery,

Dust nuisance most often arises as a consequence of poor control of mud-on-road (see below)

# 7. How will the inevitable spillage and mud on the road/temporary pavements be dealt with?

Contractor therefore to ensure mud on road is minimised to the Highway authorities approval (Southwark) and contractor is required as a minimum (but not limited to) provide the following:

- -temporary wheel wash hard standing /holding area within the site of minimum 6mx10m type bound surface
- -mobile wheel washing (high pressure hose) on site to clean each and every lorry exiting
- -hardstanding maintained/cleaned continuously throughout delivery period
- -regular (min twice daily) wheel washing throughout critical delivery periods along Wood Vale

### 8. How long will the works last?

Advance tree felling (Southwark Council) – 1- week

Entrance (Southwark Council) 3 weeks

Main Contract-12 weeks

Site set up/ clearance /tree felling- 2- weeks

Import and place of bulk soil materials- 4 weeks

Memorial Rafts and footpaths - 3 weeks

Seeding, turfing and softworks 3 weeks

### 9. When are the works proposed to start?

Main works - to be confirmed but anticipated to be June/ July 2012

### 10. What is the law that enables such work to be undertaken?

It is possible to re-use common graves by making up the soil level on top of the area of graves in order to provide the appropriate depth for new burials. This prevents the disturbance of human remains.

# 11. Where does this work sit in terms of the overall Council cemetery strategy?

In April 2011 Cabinet approved the delivery of three short term options in Camberwell New and Old cemeteries to provide burial space to address the immediate problem of lack of burial space in the Borough. This proposal is one of the three short term options identified and no decision has been made on any longer term options yet.

#### RECOMMENDATION

1. That the Nunhead and Peckham Rye Community Council allocates £30,000 of the Cleaner, Greener, Safer (CGS) revenue fund 2012 -13. The projects to be considered for allocation are set out in Appendix 1.

### **BACKGROUND INFORMATION**

- 2. A Cleaner, Greener, Safer revenue fund 2012 -13 consisting of £210,000 across the borough, with an allocation of £10,000 per ward, has been introduced as part of the budget strategy agreed at the council assembly meeting on 29 February 2012.
- 3. The aim of this fund is to give community councils decision making powers over significant amounts of revenue funding that they can allocate to meet locally determined priorities. It is anticipated that the availability of the Revenue Fund will enhance and complement the effectiveness of the Capital Fund.
- 4. On 1 March 2012 the Leader of the Council delegated the executive function to each community council to take the Cleaner, Greener, Safer Revenue Funding decisions in their areas. This decision is currently subjected to call in.

### **KEY ISSUES FOR CONSIDERATION**

- 5. The community councils will use the criteria set out below for the allocation of this funding.
  - a. Proposals that make an improvement to an area on the basis of making it cleaner, greener or safer or a combination.
  - b. CGS applications from the capital round which were ruled out because they were revenue applications.
  - c. The revenue fund could be used to meet the revenue costs associated with a CGS capital award.

- d. A Community Council may choose to allocate some or all of their revenue resources to their CGS capital allocations.
- e. Subject to the availability of resources, the revenue fund may be used to buy services from the council.
- 6. While the allocation is based on £10,000 per ward a community council can if it chooses decide to aggregate all or part of the funding and spend more than £10,000 per ward.
- 7. Community councils will be free to indicate whether they would like expenditure to be an ongoing commitment over more than one financial year or spending over a fixed timescale for a one-off project. Commitments will be subject to final agreement of the council budget and a decision by each community council on an annual basis.
- 8. As with any executive decision taken by community councils this is subject to the council's existing scrutiny arrangements.

### **Delivery**

 Once the community council has made their selections by the method of their choice they will be designed and delivered as soon as possible in 2012/13. Any under spends or projected overspends will be reported back to community council for resolution or reallocation.

### **Community Impact Statement**

- 10. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
- 11. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The Cleaner Greener Safer programme is an important tool in achieving community participation.
- 12. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been given to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decisions that need to:
  - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct:
  - b. Advance of equality of opportunity between persons who share a relevant protected characteristic and those who do not share it
  - c. Foster good relations between those who share a relevant characteristic and those that do not share it.

Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.

### **Resource implications**

13. The total cost of the CGS Revenue Fund is part of the Budget process for 2012/13 agreed by Council Assembly. Any costs incurred in implementing this fund will be met within existing resources.

### **Policy implications**

14. The CGS Revenue Fund is fully aligned with the council's policies toward sustainability, regeneration and community engagement.

#### Consultation

15. Decisions will reflect longstanding ward priorities and may be complementary to the decisions made in the CGS Capital fund allocation. In this first year of the scheme consultation will take place at the Community Council meetings and will therefore be an integral part of the decision making process. In future years consultation will be a key part of developing and identifying projects for funding and considering whether to proceed with indicative expenditure.

### **Legal Implications**

- 16. The Local Government Act 2000 [as amended] ('the Act') gives the leader the power to delegate any executive function to whoever lawfully can undertake the function. The allocation of the Cleaner, Greener, Safer revenue fund ('CGS) is an executive function.
- 17. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the leader.
- 18. In allocating funding under the CGS community councils must have regard to the council's equality duties set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties have been considered in the body of the report at paragraphs [12] of the Community Impact Statement.

### **RECOMMENDATION**

1. To approve the allocation of funds for the 2012-13 Cleaner Greener Safer programme in the Nunhead and Peckham Rye Community Council area from the list of applications set out in Appendix 1.

### **BACKGROUND INFORMATION**

- 2. The Council's Cleaner Greener Safer programme has been running since 2003.
- 3. In the first seven years of the CGS programme £21,503,000 has been allocated to community councils leading to 1,111 projects being approved.
- 4. In the Nunhead and Peckham Rye Community Council area £2,720,000 has been allocated to 171 projects, 156 of which have been completed to date.
- 5. Examples of the types of projects that have been funded include:
  - Parks, community gardens, landscaping, tree planting and wildlife areas.
  - Children's playgrounds, youth facilities, ball courts and cycle tracks.
  - Lighting, security measures, pavements, streets, and tackling 'grot spots'.
- 6. There was no new funding allocated for CGS in 2011/12, in part due to other pressures on the Council's capital budgets and also to allow a backlog of approved or outstanding projects from previous years to be delivered.

### **KEY ISSUES FOR CONSIDERATION**

- 7. There is £238,326 for the 2012/13 CGS programme and £32,000 unallocated funding from previous years, giving an overall budget of £270,326 for new projects in the Nunhead and Peckham Rye Community Council area.
- 8. Eligible proposals must bring about a permanent improvement and make an area cleaner, greener or safer.
- 9. Proposals with revenue costs, including salaries or computer equipment, feasibility studies, costs for events, festivals, workshops or other one-off events are not eligible. CCTV proposals, internal improvements to housing property, works on schools where there is no access to the general public are also not eligible. Works on private property are not eligible unless there is a long-term guarantee of public access or a demonstrable public benefit.

10. This year, the application form invited expressions of interest for the applicants to deliver projects themselves. A due diligence exercise to ensure that this is both practical and realistic has been undertaken as part of the feasibility process. In such cases, the council would give the funding allocation to the applicant in the form of a capital grant, with appropriate conditions attached.

### **Policy implications**

11. The Cleaner Green Safer programme is fully aligned with the council's policies around sustainability, regeneration and community engagement.

### **Community impact statement**

- 12. The roles and functions of community councils include the promotion of involvement of local people in the democratic process and taking decision-making closer to local people. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
- 13. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The Cleaner Greener Safer programme is an important tool in achieving community participation.
- 14. All ideas for CGS projects come directly from the local community via a simple project nomination form. Specific schemes will then be agreed by community councils and will reflect local needs and priorities.

### **Resource implications**

- 15. The funding for the 2012/13 CGS programme was approved by the cabinet and is part of the council's overall capital programme.
- 16. All direct project management costs (including salaries) will be capitalised as part of the project costs. Where projects are awarded as a grant, the community council award will include a project management fee which will not be included in the grant award letter.
- 17. CGS projects must be completed within two years of award of funding. Projects that are unlikely to be completed within two years will be reported to community council and available budgets may be reallocated to other projects.
- 18. After the defects and liability period, or three year maintenance period in the case of planting works, all future maintenance is assumed by the asset owner, for example Housing, Parks, Highways, or in some cases external asset owners.

### Consultation

19. All Cleaner Greener Safer projects require consultation with stakeholders, including the project applicant, local residents, Tenants and Residents Associations and local community groups where appropriate.

### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

### Strategic Director of Communities, Law & Governance

- 20. This report is recommending that the Nunhead and Peckham Rye Community Council approve the allocation of funds to the individual projects specified at appendix 1. The power for this function is derived from Part 3H paragraph 13 of the Constitution which states that Community Councils have the power of "approval of the allocation of funds to cleaner, greener, safer capital schemes of a local nature, using the resources identified by the cabinet".
- 21. The Cabinet Member for Transport Environment and Recycling has already noted the allocation of the Cleaner Greener Safer funds in October 2011 by exercising his powers under Part 3D paragraph 2 of the Constitution, therefore this is the next constitutional step in the process.
- 22. Community council members also have powers under paragraph 14 of Part 3H of the constitution to oversee and take responsibility for the development and implementation of the local schemes.

### Finance Director (NR/F&R/1/3/12)

- 23. This report recommends approval of the allocation of funds for the 2012-13 Cleaner Greener Safer programme in the Nunhead and Peckham Rye Community Council area from the list of applications set out in appendix 1.
- 24. The Finance Director notes the resource implications contained within the report, and confirms that the capital funding for the CGS programme has been approved as part of the overall council capital programme.
- 25. Officer time to effect the recommendation will be contained within existing budgeted revenue resources.
