#### RECOMMENDATION

1. That the licensing sub-committee considers an application made by Brick House Artisan Bread and Pastry Ltd to vary the premises licence granted under the Licensing Act 2003 in respect of the premises known as: Brick House Artisan Bread and Pastry Ltd, 1 Zenoria Street, London SE22 8HP.

#### 2. Notes:

- The application seeks to vary the premises licence held under current legislation in respect of the premises known as: Brick House Artisan Bread and Pastry Ltd, 1 Zenoria Street, London SE22 8HP, under section 34 of the Licensing Act 2003. Existing permitted licensable activities are not under consideration at this meeting. The variation application is subject to representations submitted by responsible authorities and / or other persons and is therefore referred to the sub-committee for determination.
- Paragraphs 9 to 13 of this report provide a summary of the application under consideration by the sub-committee. A copy of the full application is attached as Appendix B. A map showing the location of the premises is attached as Appendix F.
- Paragraphs 15 to 17 of this report deal with the representations submitted in respect of the application. (Copies of the representations and related correspondence are attached in Appendices C & D).

#### **BACKGROUND INFORMATION**

#### The Licensing Act 2003

- 3. The Licensing Act 2003 received royal assent on 10 July 2003. The Act provides a licensing regime for:
  - The sale of and supply of alcohol
  - The provision of regulated entertainment
  - The provision of late night refreshment.
- 4. Within Southwark, this council wholly administers the licensing responsibility.
- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:

- The prevention of crime and disorder
- The promotion of public safety
- The prevention of nuisance
- The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to:
  - The Act itself
  - The guidance to the act issued under Section 182 of the Act
  - Secondary regulations issued under the Act
  - The Licensing authority's own statement of licensing policy
  - The application, including the operating schedule submitted as part of the application
  - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other interested parties within the local community may make representations on any part of the application where relevant to the four licensing objectives.

#### **KEY ISSUES FOR CONSIDERATION**

#### The current premises licence

- 8. The current premises licence issued in respect of the premises known as Brick House Artisan Bread and Pastry Ltd, 1 Zenoria Street, London SE22 8HP was issued on 28 August 2015 and allows the following licensable activities:
  - The sale of alcohol to be consumed on the premises:

Tuesday to Friday between 11:00 and 16:00 Saturday between 11:00 and 17:00 Sunday between 11:00 and 16:30

Opening hours:

Tuesday to Friday between 08:00 and 16:30 Saturday between 08:00 and 18:00 Sunday between 08:00 and 17:00

A copy of the existing premises licence is attached as Appendix A.

#### The variation application

- On 6 October 2016 Brick House Artisan Bread and Pastry Ltd applied under section 34 of the Licensing Act 2003 to this council to vary the premises licence issued in respect of the premises known as Brick House Artisan Bread and Pastry Ltd, 1 Zenoria Street, London SE22 8HP.
- 10. The application is summarised as follows:
  - To allow off-sales at the premises

• To amend the opening hours of the premises and the hours permitted for the sale of alcohol at the premises to:

Monday between 00:00 and 00:00 (24 hours)

Tuesday to Friday between 08:00 and 16:00 Saturday between 08:00 and 17:00 Sunday between 09:00 and 17:00

- 11. The premises licence application form provides the applicant's operating schedule. Part M sets out the proposed operational control measures in full, with reference to the four licensing objectives as stated in the Licensing Act 2003. Should An amended premises licence be issued in respect of the application the information provided in part M of the operating schedule will form the basis of conditions that will be included in the licence.
- 12. N.B. Further to the above, the applicant contacted the Licensing Unit to inform that the application is only to allow the addition of off sales at the premises during the existing hours and that there is to be no change to the operating days or times.
- 13. A copy of the application and related correspondence are attached to this report as Appendix B.

#### **Designated premises supervisor**

14. The designated premises supervisor (DPS) under the existing premises licence is Sharmin Jackson.

#### Representations from responsible authorities

15. The Metropolitan Police Service submitted a representation which suggested control measures to be included in the application and which the Metropolitan Police Service proposed should become conditions of any licence issued subsequent to the application. The applicant agreed to the inclusion of the suggested control measures into the application and the Metropolitan Police Service withdrew their representation. A copy of the Metropolitan Police Service's representation and related correspondence is attached as Appendix C.

#### Representations from other persons

- 16. A local ward councillor and one local resident submitted representations objecting to the application. The local ward councillor and local resident have been informed of the amendment to the application (i.e. that the application is solely to allow off sales of alcohol at the premises) and have been invited to provide any further comments they have in regards to the application. At this time their representations remain outstanding and must be considered by the licensing sub-committee.
- 17. Copies of the local ward councillor and local resident's representations and related correspondence are attached as Appendix D

#### Conciliation

18. The applicant was sent copies of the representations received and subsequently contacted the Licensing Unit to correct the application. Objectors to the application were informed of the corrections made to the application and were invited to provide

- any further comments they may have. At this time the objector's representations remain outstanding and must be considered by the licensing sub-committee.
- 19. The applicant agreed to the inclusion of control measures as suggested by the Metropolitan Police Service into the application and the Metropolitan Police Service withdrew their representation.

#### **Operating history**

- 20. The current premises licence in respect of the premises was issued in 28 August 2015.
- 21. On 6 October 2016 Brick House Artisan Bread and Pastry Ltd applied under section 34 of the Licensing Act 2003 to this council to vary the premises licence issued in respect of the premises known as Brick House Artisan Bread and Pastry Ltd, 1 Zenoria Street, London SE22 8HP.
- 22. No complaints have been received by the licensing unit in regards to the premises.
- 23. A list of all Temporary Event Notices submitted in respect of the premises is attached in Appendix E.

#### Мар

- 24. A map of the area is attached to this report as appendix F. The premises are identified at the centre of the map. For purposes of scale the circle on the map has a 100 metre radius. The following premises are within the 100 metre radius shown on the map and are permitted to sell alcohol between the hours stated:
  - Mirash Tandoori, 94 Grove Vale, London SE22 8DY (Monday to Saturday from 11:00 to 00:30 and Sunday from 12:00 to 00:00)
  - EDT, 1 Lordship Lane, London SE22 8EW (Monday to Thursday from 08:00 to 00:30, Friday and Saturday from 08:00 to 01:30 and Sunday from 09:00 to 00:30)
  - Organic Village Market, 18 Lordship Lane, London SE22 8HN (Monday to Saturday from 08:00 to 23:00 and Sunday from 10:00 to 22:30)
  - Payless Food & Wine / Costcutter, 24 Lordship Lane, London SE22 8HN (24 hours, 7 days a week)
  - Kebab & Wine, 19 Lordship Lane, London SE22 8EW (Monday to Thursday from 10:00 to 03:00, Friday and Saturday from 10:00 to 05:00 and Sunday from 10:00 to 02:00)
  - Franco Manca, 21 Lordship Lane, London SE22 8EW (Sunday to Wednesday from 07:00 to 00:30 and Thursday to Saturday from 07:00 to 01:30)
  - The Bishop, 27 Lordship Lane, London SE22 8EW (Monday to Thursday from 11:00 to 01:30, Friday and Saturday from 11:00 to 02:30 and Sunday from 12:00 to 01:30)
  - Toast E. D., 38 Lordship Lane, London SE22 8HJ (Monday to Saturday from 07:00 to 00:00 and Sunday from 07:00 to 23:00).

#### Southwark council statement of licensing policy

- 25. Council Assembly approved Southwark's statement of licensing policy 2016 -2020 on 25 November 2015. The policy came into effect on 1 January 2016. Sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
  - Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this Authority relies in determining licence applications
  - Section 5 Determining applications for premises licences and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
  - Section 6 Local cumulative impact policies. This sets out this Authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy
  - Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this Authority might consider appropriate by type of premises and (planning) area classification.
  - Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective
  - Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective
  - Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective
  - Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective.
- 26. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.

#### **Resource implications**

27. A fee of £190.00 being the statutory fee payable for premises within non-domestic rateable value band A has been paid by the applicant company in respect of this application.

#### Consultation

28. Consultation has been carried out in respect of this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local

newspaper and a similar notice exhibited at the premises for a period of 28 consecutive days.

#### **Community impact statement**

29. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Director of Law and Democracy**

- 30. The sub-committee is asked to determine the application to vary the premises licence under Section 34 of the Licensing Act 2003.
- 31. The principles which sub-committee members must apply are set out below.

#### Principles for making the determination

- 32. Section 35 of the Licensing Act 2003 sets out the licensing authority's powers and duties in considering the determination of an application for variation.
- 33. The general principle is that applications for variation must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 34. Relevant representations are those which
  - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
  - Are made by an other party or responsible authority
  - Have not been withdrawn
  - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious.
- 35. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to
  - Add to, omit, and/or alter the conditions of the licence or,
  - Reject the whole or part of the application for variation.

#### **Conditions**

- 36. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the variation, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.
- 37. The four licensing objectives are:
  - The prevention of crime and disorder
  - Public safety;

- The prevention of nuisance
- The protection of children from harm.
- 38. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 39. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to late night refreshment and take away aspect of the licence must relate to the night time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 40. The Licensing Act requires mandatory conditions in respect of supply of alcohol, the exhibition of films and in respect of door supervisors. The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2003 introduced 3 new conditions in respect of irresponsible promotions, the oral dispensing of alcohol and free tap water. In October 2010 an additional 2 conditions will come into force age verification policy and smaller measures for alcoholic drinks.
- 41. Members are also referred to the Home Office guidance on conditions.

#### Reasons

42. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for to vary the premises licence, it must give reasons for its decision.

### **Hearing procedures**

- 43. Subject to the Licensing Hearing Regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
  - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
  - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
  - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
    - Address the authority
    - o If given permission by the committee, question any other party.
    - o In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
  - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
  - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.

- In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 44. This matter relates to the determination of an application to vary a premises licence under section 34 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

#### The council's multiple roles and the role of the licensing sub-committee

- 45. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 46. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.
- 47. As a quasi-judicial body, the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 48. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 49. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 50. Under the Human Rights Act 1998, the sub committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.

51. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the Magistrates' Court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

#### Guidance

52. Members are required to have regard to the Home Office guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

#### **Strategic Director of Finance and Governance**

53. The head of regulatory services has confirmed that the costs of this process over and above the application fee are borne by the service.

#### **Annex 1 - Mandatory conditions**

- 100 No supply of alcohol may be made under the Premises Licence -
- (a). At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
- (b). At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- **101** Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence.
- **485** (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
- (a) games or other activities which require or encourage, or are designed to require, encourage, individuals to -
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional poster or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; and
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- **487** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- **488** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either

If the below issues can;t be resolved we request a full licence review.

#### The Prevention of Nuisance

Talking to residents the bakery has single glazed windows often left open through which, whether closed or open, allow significant noise disturbance for neighbouring properties. However, if the applicant were to commit to keep Bakery sound levels 10dB(A) below the ambient noise levels without the bakers in operation this would solve this problem. TO do this the wondiwos would need to remain shut and be as a minimum double glazed and fixed and unable to be opened. The roof may need sound proofing achieve this.

A voluntary agreement between neighbours and the bakery was agreed by email which the bakery within a fortnight reneged upon.

Ihefront doors should be kept closed and ideally a lobby created. The front door is located on a very residential street and the front doors being left open when fully operational has caused noise disturbance.

The bakery also places benches on the street outside where customers sit, smoke and drink. This isn;t acceptable and should specifically have a licence condition to stop.

I'd very much like to attend any licensing committee deciding this application.variation.

#### **Dear Sirs**

We would like to object to the above licensing application on the grounds of 'Prevention of Nuisance' noise disturbance and 'Protection of Children from Harm' noise disturbance. We also request a review of existing noise levels at the Brick House premises. Our family home is adjacent to the Brick House kitchen.

#### Current issues:

- staff and cleaners are in the premises daily (including weekends) from as early as 3am to as late as 11pm operating machinery, playing loud music, clattering pans and making general kitchen noise. We have numerous videos as evidence that we can provide, for example of loud music blaring through open windows at 3:38am. Such noise levels may well be normal for a commercial kitchen, however, Brick House has situated itself in what is otherwise a residential street flanked by family homes to the front, back and side. The current noise levels encroach on the enjoyment of our home and, we fear, would only be further aggravated should this application be granted. Despite repeated pleas from multiple neighbours to reduce existing noise and to be considerate when opening windows to the kitchen, the duration and levels of noise persist.
- single-glazed, cracked windows left open throughout the day and night which, whether closed or open, allow significant noise disturbance for neighbouring properties (both personally as well as professionally I am a lawyer who works from home and daily hear Brick House noise during my various conference calls, such that I cannot leave any windows in my home office open).
- window permanently smashed open to allow for an extractor fan, blowing air directly into our property and also allowing further noise
- windows open outwards into our garden, i.e. across our property boundary line Proposed solutions.
- windows to be as a minimum double-glazed and fixed (i.e. unable to be opened). They are currently too small to be useful in the event of a fire (no person could fit through them) and, until the last few months ago, were not opened due to ivy growing over them so cannot be necessary for the ventilation of the bakery
- windows to remain shut (else double glazing would be redundant) a voluntary agreement has already been reached between ourselves and the bakery via email (we can provide copies), which the bakery within a fortnight reneged upon.
- music levels to be lowered these are wholly unreasonable and unnecessary to the success of the business, yet significantly negatively impact our ability to enjoy our home.

#### Conclusion:

Brick House is already an extremely busy licenced café, shop and commercial bakery. It now also advertises itself for evening parties, and its latest application is for longer licensing hours to serve

alcohol - effectively operating as an off-licence as well (moving further away from its primary business as a bakery). We have real concerns that approval of this application would exacerbate the already significant noise levels from this busy venue, and constitute a slippery slope for applications for even longer alcohol licencing hours and loud evening events down the line.

We have no wish to curb the evident success of Brick House but simply hope that, as its business continues to thrive, this success is not at the cost to local residents' enjoyment of their homes.
