## RECOMMENDATION

- That the licensing sub-committee considers an application made by Martin Ekeocha-Kamara to vary the premises licence granted under the Licensing Act 2003 in respect of the premises known as L'Attitude,18 Choumert Road, London SE15 4SE.
- 2. Notes:
  - a) The application seeks to vary the premises licence held in respect of the premises known as L'Attitude, 18 Choumert Road, London, SE15 4SE under section 34 of the Licensing Act 2003. Existing permitted licensable activities are not under consideration at this meeting. The variation application is subject to representations submitted by three responsible authorities and 10 'other persons' and is therefore referred to the licensing sub-committee for determination.
  - b) Paragraph 8 of this report provides a summary of the current premises licence issued in respect of the premises. A copy of the current premises licence is attached as Appendix A.
  - c) Paragraphs 10 to 12 of this report provide a summary of the application. A copy of the application is attached to this report as Appendix B.
  - d) Paragraphs 12 to 28 of this report deal with the representations submitted in respect of the application. Copies of the representations are attached to this report as Appendices C and D. A map showing the location of the premises is attached to this report as Appendix G.
  - e) A copy of the council's approved procedure for hearings of the sub-committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing procedure, has been circulated to all parties to the meeting.

## **BACKGROUND INFORMATION**

## The Licensing Act 2003

- 3. The Licensing Act 2003 provides a licensing regime for:
  - The sale of and supply of alcohol
  - The provision of regulated entertainment
  - The provision of late night refreshment.
- 4. Within Southwark, the licensing responsibility is wholly administered by this council.
- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:
  - The prevention of crime and disorder
  - The promotion of public safety
  - The prevention of nuisance
  - The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to:
  - The Act itself
  - The guidance to the act issued under Section 182 of the Act
  - Secondary regulations issued under the Act
  - The licensing authority's own statement of licensing policy
  - The application, including the operating schedule submitted as part of the application
  - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.

## **KEY ISSUES FOR CONSIDERATION**

## The current premises licence

- 8. The current premises licence issued in respect of the premises known as the L'Attutude, 18 Choumert Road, London, SE15 4SE was issued on 29 September 2022 and allows the following licensable activities:
  - The sale of alcohol to be consumed on the premises:
    - Monday to Sunday: 11:00 to 22:30

## Opening hours:

- Monday to Sunday: 11:00 to 23:00.
- 9. A copy of the existing premises licence is attached as Appendix A.

## The variation application

- 10. On 17 January 2023 Martin Ekeocha-Kamara applied to this council to vary the premises licence granted under the Licensing Act 2003 in respect of the premises known as L'Attutude, 18 Choumert Road, London, SE15 4SE. The premises purpose and nature of the variation is described within the application as follows:
  - '...To change the opening times (on weekends) to reach up to 3am on Fridays and Saturdays. It is a ground floor cocktail bar. The variation would include the sale of alcohol and refreshment up until the time stated'.
- 11. The application is summarised as follows:
  - To add recorded music (indoors):
    - Monday to Thursday: 17:00 to 23:00,
    - Friday: 17:00 to 03:00,
    - Saturday: 12:00 to 03:00
    - Sunday: 12:00 to 23:00
  - To change the sale by retail of alcohol (on the premises) to:
    - Monday to Thursday: 17:00 to 23:00
    - Friday: 17:00 to 02:30
    - Saturday: 12:00 to 02:30
    - Sunday: 12:00 to 23:00
  - To amend the opening hours to:
    - Monday to Thursday: 17:00 to 23:00
    - Friday: 17:00 to 03:00
    - Saturday: 12:00 to 03:00
    - Sunday: 12:00 to 23:00
  - The premises is now described as a cocktail bar.
- 12. A copy of the application is attached to this report as Appendix B.

## **Representations from responsible authorities**

- 13. Representations have been submitted by the Metropolitan Police Service, the council's environmental protection team (EPT) and the council's licensing team as responsible authorities.
- 14. The police representation is concerned with all four of the licensing objectives, and in particular the prevention of crime and disorder and objects to the application in full.

- 15. The police representation states that the premises is within the Peckham major town centre area and also falls within the Peckham cumulative impact area and that the hours applied for are outside of that recommended for a bar in the Southwark statement of licensing policy.
- 16. The police further contend that the area of the premises has been subject over a number of years to alcohol related anti-social behaviour and to extend the hours to that of a nightclub would only add to the problems in this area. The applicant has offered some control measures in the operating schedule however they are vague and in current guise not in an enforceable form.
- 17. The EPT representation is concerned with the prevention of public nuisance licensing objective and contends that the proposed licensable activities for Fridays into Saturdays/Saturdays into Sundays are outside of suggested closing times for licensed premises of this type within this area as stated within Southwark statement of licensing policy 2021-2026. No reasons have been provided for deviation from this policy.
- 18. The EPT has raised concerns that the applicant has not explained how they would comply with condition 344 of the existing licence that limits alcohol to only be served in conjunction with table meals; "344 That intoxicating liquor shall not be sold or supplied for consumption on the premises otherwise than to persons taking table meals there and as an ancillary to that persons meal."
- 19. The EPT further add an advisory note regarding planning permission and hours granted and invites the applicant to discuss the condition.
- 20. The licensing representation is concerned with the prevention of public nuisance and the prevention of crime and disorder licensing objectives.
- 21. The licensing representation states that the premises is within the Peckham major town centre and also falls within the Peckham cumulative impact area (CIA) and that the CIA does not apply to restaurants in this area.
- 22. The representation asks for clarification of the premises accommodation limit, seeks further conditions to promote the licensing objectives and that the closing times of the premises are amended to match those recommended in the licensing policy for restaurants and cafes located in Peckham major town centre area.
- 23. Copies of the representations submitted by the responsible authorities are attached as Appendix C.

## **Representations from other persons**

- 24. Representations have been submitted by 10 other persons, including a local ward councillor.
- 25. The other person's representations are concerned with the prevention of crime and disorder, prevention of public nuisance and public safety licensing objectives.

- 26. The other persons contend that the premises is a frequent source of noise and disturbance due to loud music and people noise in a street that has existing problems with anti-social behaviour.
- 27. That the premises regularly plays extremely loud, bass heavy music that reverberates into residential properties, as the premises backs directly onto the residential houses, with allegations that there is inadequate sound insulation installed in the premises.
- 28. Allegations that the premises is breaching its licensed hours and conditions.
- 29. Copies of the representations submitted by the other persons are attached to this report as Appendix D.

#### Conciliation

- 30. The representations were provided to the applicant. The applicant was advised that they could provide a reply to the representations if they so wished.
- 31. At the time of the writing of this report all of the representations remain outstanding and so must be considered by the licensing sub-committee in their determination of the application.
- 32. The licensing sub-committee will be apprised as to any conciliation, whether partial or full, of the responsible authorities and / or the other persons.

#### Premises licensing history

- 33. The original premises licence in respect of the premises was issued to Bar Om Limited on 24 December 2018. At this time the premises was described as a restaurant.
- 34. The premises licence was transferred to Martin Ekeocha-Kamara on 16 September 2022.
- 35. Martin Ekeocha-Kamara was specified as the designated premises supervisor in respect of the premises on 29 September 2022.

#### **Temporary Event Notices**

36. There have been 13 temporary event notices (TENs) submitted in respect of the premises within the last year. A Table of TENs is attached to this report as Appendix E.

#### Complaints

- 37. There have been eight complaints received to the licensing unit in the past year mainly regarding noise from the premises, but also ASB and alleged unlicensed activity.
- 38. A table of complaints is attached to this report as Appendix F.

#### Мар

- 39. A map showing the location of the premises is attached to this report as Appendix G.
- 40. At the time of writing this report the information of other premises shown on the map is not available and will be updated to all parties prior to the licensing sub-committee meeting.

#### Southwark Council statement of licensing policy

- 41. Council assembly approved Southwark's statement of licensing policy 2021-2026 on 25 November 2020 and came into effect on 1 January 2021.
- 42. Sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
  - Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this Authority relies in determining licence applications.
  - Section 5 Determining applications for premises licences and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
  - Section 6 Local cumulative impact policies. This sets out this authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy.
  - Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this Authority might consider appropriate by type of premises and (planning) area classification.
  - Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective.
  - Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective.
  - Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective.
  - Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective.
- 43. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.

44. Members should take into consideration both the Southwark statement of licensing policy and the Section 182 Guidance when making decisions. The inks are below:

#### Cumulative impact area (CIA)

- 45. The premises falls within the Peckham cumulative impact area (CIA).
- 46. The types of premises that the CIA applies to are:
  - Night clubs, public houses and bars, off-licences, supermarkets, grocers, convenience stores and similar premises
- 47. The premises are also situated in the Peckham major town centre area.
- 48. Under the Southwark's statement of licensing policy 2021 2026 the following closing times are recommended as appropriate within Peckham major town centrearea:
  - Restaurants and cafes:
    - Sunday to Thursday: 00:00
    - Friday and Saturday: 01:00
  - Public houses, wine bars or other drinking establishments:
    - Sunday to Thursday: 23:00
    - Friday and Saturday: 00:00

#### Climate change implications

- 49. Following council assembly on 14 July 2021, the council is committed to considering the climate change implications of any decisions.
- 50. Climate change is not a legal factor in the consideration of a grant of a premises license under the current licensing objectives, however members can make enquiries and request an agreement from applicants to promote the reduction of the impact of climate change that may be caused by the operation of the premises.

- 51. Examples of such agreements may be:
  - Not use single use plastics, such as disposable plastic glasses, when selling alcohol at the premises.
  - Encourage patrons not to drive to venues by providing details of public transport on their webpages/tickets.

## Community, equalities (including socio-economic) and health impacts

#### **Community impact statement**

53. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

#### Equalities (including socio-economic) impact statement

- 54. This report does not result in a policy decision and each application is required to be considered upon its own individual merits with all relevant matters taken into account. In considering the recommendations of this report, due regard must be given to the public sector equality duty set out in section 149 of the Equality Act 2010. This requires the Council to consider all individuals when carrying out its functions.
- 55. Importantly, the council must have due regard to the need to eliminate discrimination, harassment, victimisation, or other prohibited conduct; advance equality of opportunity and foster good relations between people who have protected characteristics and those who do not. The relevant protected characteristics are age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation. The public sector equality duty also applies to marriage and civil partnership, but only in relation to the need to eliminate discrimination, harassment, victimisation, or other prohibited conduct.

#### Health impact statement

58. Health impacts cannot be considered by law when making decisions under the Licensing Act 2003.

## **Resource implications**

59. A fee of £190.00 has been paid by the applicant in respect of this application being the statutory fee payable for premises within non-domestic ratable value B.

## Consultation

60. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local newspaper and similar notices were exhibited outside of the premises for a period of 28 consecutive days.

## Community impact statement

61. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

## SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### Assistant Chief Executive – Governance and Assurance

- 62. The sub-committee is asked to determine the application for a premises licence under Section 17 of the Licensing Act 2003.
- 63. The principles which sub-committee members must apply are set out below.

#### Principles for making the determination

- 64. The sub-committee is asked to determine the application for a premises licence under section 17 of the Licensing Act 2003.
- 65. The principles which sub-committee members must apply are set out below.
- 66. The general principle is that applications for premises licence applications must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 67. Relevant representations are those which:
  - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
  - Are made by an interested party or responsible authority
  - Have not been withdrawn
  - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious.
- 68. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to:

- To grant the licence subject to:
  - The conditions mentioned in section 18 (2)(a) modified to such extent as the licensing authority considers necessary for the promotion of the licensing objectives
  - Any condition which must under section 19, 20 or 21 be included in the licence.
- To exclude from the scope of the licence any of the licensable activities to which the application relates.
- To refuse to specify a person in the licence as the premises supervisor.
- To reject the application.

## Conditions

- 69. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the application, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.
- 70. The four licensing objectives are:
  - The prevention of crime and disorder
  - Public safety
  - The prevention of nuisance
  - The protection of children from harm.
- 71. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 72. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to night café and take away aspect of the license must relate to the night time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 73. Members are also referred to the Home Office Revised Guidance issued under section 182 of the Licensing Act 2003 on conditions, specifically section 10.

## Reasons

74. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for a premises licence application, it must give reasons for its decision.

## Hearing procedures

- 75. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
  - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
  - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
  - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
    - Address the authority
    - If given permission by the committee, question any other party.
    - In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
  - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
  - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.
  - In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 76. This matter relates to the determination of an application for a premises licence under Section 17 of the Licensing Act 2003. Regulation 26(1) (a) requires the sub-committee to make its determination at the conclusion of the hearing.

## Council's multiple roles and the role of the licensing sub-committee

- 77. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 78. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.

- 79. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 80. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 81. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 82. The sub-committee can only consider matters within the application that have been raised through representations from other persons and responsible authorities. Interested parties must live in the vicinity of the premises. This will be decided on a case to case basis.
- 83. Under the Human Rights Act 1998, the sub-committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.
- 84. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

## Guidance

85. Members are required to have regard to the Home Office guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

#### Strategic Director of Finance and Governance

86. The head of regulatory services has confirmed that the costs of this process over and above the application fee are borne by the service.

100 No supply of alcohol may be made under the Premises Licence -

(a). At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or

(b). At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.

**101** Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence.

**485** (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –

(a) games or other activities which require or encourage, or are designed to require, encourage, individuals to -

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional poster or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any

favourable manner; and

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

**487** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

**488** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either

(a) a holographic mark; or

(b) an ultraviolet feature.

489 The responsible person shall ensure that -

(a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) Beer or cider: 1/2 pint;

(ii) Gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) Still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available,

**491** 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purpose of the condition set out in paragraph (1):

(a) "duty" is to be construed in accordance with the Alcoholic Liquor

Duties Act 1979;

(b) "permitted price" is the price found by applying the formula

 $\mathsf{P} = \mathsf{D} + (\mathsf{D} \times \mathsf{V}),$ 

where-

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale

or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence – (i) the holder of the premises licence:

(ii) the designated premises supervisor (if any) in respect of such a licence; or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(iv) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(v)"value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax;

(2) the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 2 - Conditions consistent with the operating Schedule

**340** That a CCTV system shall be installed at the premises, be maintained in good working order and be continually recording at all times that the premises are in use. The CCTV system must be capable of capturing a clear facial image of every person who enters the premises.

**341** That all CCTV footage shall be kept for a period of 31 days and shall be made immediately available to officers of the police and / or council on request.

**342** That a member of staff shall be on duty at all times that the premises are open who is trained in the use of the CCTV system and who is able to view, and download to a removable device, CCTV footage at the request of police and / or council officers.

**343** All staff shall be trained in their responsibilities under the Licensing Act 2003 and trained in respect of the terms and conditions of this licence. Records pertaining to such training shall be kept and updated every 6 months. The training records shall be made immediately available to officers of the police and the council on request.

**344** That intoxicating liquor shall not be sold or supplied for consumption on the premises otherwise than to persons taking table meals there and as an ancillary to that person's meal.

**345** That clearly legible signage shall be prominently displayed both internally and externally where it can easily be seen and read by customers requesting to the effect that customers behave in a quiet and orderly manner with respect to local residents.

**346** That customers shall not be permitted to take any alcohol from the premises outside of the premises at any time.

**347** That customers shall not be permitted to take open containers of food from the premises at any time.

348 That children can only enter the premises when accompanied by a responsible adult.

**349** That customers who are leaving the premises temporarily to smoke will be advised by staff to smoke in the area designated for smokers at the premises.

**350** That a proof of age scheme shall be maintained at the premises requiring that staff selling alcohol request that any customer who looks under 18 years old, and who is attempting to purchase alcohol, provides valid photographic identification proving that the customer is at least 18 years old. Valid

photographic identification is composed of a driving licence, passport, UK armed services ID card, any Proof of Age Standards Scheme (PASS) accredited card or any identification card validated by the Secretary of State.

**351** That all staff involved in the sale of alcohol shall be trained in the prevention of sales of alcohol to underage persons (including the prevention of 'proxy sales'), and trained in the proof of age scheme in operation at the premises. A record of such training shall be kept / be accessible at the premises at all times and be made immediately available for inspection at the premises to council or police officers on request.

**352** That clearly legible signs shall be prominently displayed where they can easily be seen and read by customers stating to the effect that a proof of age scheme is in operation at the premises, that customers may be asked to provide proof of age and stating what the acceptable forms of proof of age are.

**353** That a register of refused sales of alcohol shall be maintained at the premises. The register shall be clearly and legibly marked on the front cover as a register of refused sales and with the address of the premises and the name of the licence holder. The register shall be kept / be accessible at the premises at all times.

**354** That a first aider shall be readily available at the premises at all times that the premises are in operation.

#### Annex 3 - Conditions attached after a hearing by the licensing authority

**840** That a direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents in the vicinity.

841 That no more than five customers are permitted outside at any one time for the purposes of smoking.

**842** That outside tables and chairs are permitted for a maximum of 10 patrons. These tables and chairs shall be rendered unusable by 22:00 hours each day.

The High Court approval of Cumulative impact policies came in Westminster City Council v Middlesex Crown Court. In brief, it stated 'A licence could be refused on the sole ground that the area was already saturated with licensed premises"

The area of the premises has been subject over a number of years to alcohol related Anti-Social Behaviour and to extend the hours to that of a nightclub would only add to the problems in this area

My representations are made with regard to the venue being situated in the cumulative impact zone and that all four of the licensing objectives in particular the Prevention of crime and disorder, in my opinion has not been addressed sufficiently. A major variation of licence application seeks to change the opening times (on weekends) to reach up to 3am on Fridays and Saturdays for Recorded music and Sale of Alcohol.

The premises currently trades as Public House (ground floor cocktail bar). The variation would include the sale of alcohol and refreshment up until the time stated.

I wish to make a representation on behalf of Southwark Environmental Protection Team (EPT) in our capacity as Environmental Health Responsible Authority, about the likely effect of the sought licence if granted on the promotion of the 'prevention of public nuisance' licensing objective:

- a) The proposed licensable activities for Fridays into Saturdays and Saturdays into Sundays are outside of suggested closing times for licensed premises of this type within this area as stated within Southwark Statement of Licensing Policy 2021-2026. No reasons have been provided for deviation from this policy.
- b) Applicants have not explained how they would comply with condition 344 of the existing licence that limits alcohol to only be served in conjunction with table meals; "344 That intoxicating liquor shall not be sold or supplied for consumption on the premises otherwise than to persons taking table meals there and as an ancillary to that persons meal."

In addition (<u>informative</u>): A planning application 18/AP/0422 was granted on 05/04/2018 for Change of use of the ground and first floor from A1 Retail to A3 Restaurant, alterations to the shopfront and installation of a flue and dumb waiter to the rear elevation. The decision notice included condition restricting opening times: for details on noise and odour arrestment details:

4. The use hereby permitted for A3 Use Class purposes shall not be carried on outside of the hours 12:00 to 23:00 on Monday to Saturday and on Sunday and Public Holidays. Reason:

Our objection relates to the prevention of public nuisance, and the prevention of crime and disorder, licensing objectives.

According to this council's Statement of Licensing Policy (hereafter referred to as the **SoLP**), the premises fall within the Peckham Cumulative Impact Area (Peckham CIA). The premises are also located within Peckham Major Town Centre Area.

Paragraph 156 of the statement of licensing policy stipulates that - "*The classes of premises to which the policy applies is defined as follows – night clubs; pubs and bars; off-licences, grocers, supermarkets, convenience stores; and similar premises.*"

Condition 344 of the existing premises licence means that the premises operate as a restaurant and that the premises are therefore not subject to the Peckham CIA.

The following closing times are recommended for the listed types of licensed premises located in Peckham Major Town Centre Area –

We seek that the closing times of the premises are amended to match those recommended in the SoLP for restaurants and cafes located in Peckham Major Town Centre Area.

We would like to be informed what the maximum number of people permitted on the premises at any one time (excluding staff) is (known as the 'accommodation limit').

We seek clarity as to the seasonal variations and non-standard timings sought by the applicant. Exact days, times and dates should be provided. You should contact your case officer (Jayne Tear) if you require an explanation as to how seasonal variations and non-standard timings should be shown in an application.

In the operating schedule of the application the applicant has offered various control measures relating to the promotion of the licensing objectives. If a premise licence is issued subsequent to the application then these control measures would form the basis of enforceable licence conditions, in addition to the existing licence conditions.

On receiving the information required above, we would seek preferred wordings for the additional control measures proposed in the application. This is to ensure that any subsequent licence conditions are practicable and enforceable. It is possible that we would also seek further conditions to ensure that the premises will be operated in a suitable manner regarding the licensing objectives.

I'm a long-term resident of Choumert Square. Thank you for alerting me to this application. Sadly, I wish to log an objection for these two reasons: LATE NIGHT /EARY MORNING DRINKING. At Police Liaison meetings, officers have identified this area of Choumert Road as a trouble `bot spot' for anti-social

have identified this area of Choumert Road as a trouble `hot spot' for anti-social behaviour - especially in the warmer months. While I think the efforts to improve the quality and range of independent businesses along this stretch of the road is laudable, I worry that any facility offering such late-night/early-morning drinking could contribute to increasing problems and put extra stress on over-stretched police resources.

SOUND TRANSFER. Over the years, the rear of many Choumert Road premises have been expanded right up to the rear of Choumert Square properties by incorporating what were formerly the Choumert Road open backyards. These new 'indoor' areas abut the rear walls of Choumert Square cottages which are only single-brick depth. Unless commercial properties undertake work on sound insulation, the transfer of sound from their premises comes straight into the living rooms and bedrooms of Choumert Square residents. As we all know, this road, specially since Covid, has become one of the areas in Rye Lane ward with the high level of crime and disorder, public nuisance, and low level of public safety. Facts supported by the number of security/surveillance cameras (CCTV) that had to be added to the road, in the last couple of months, and innumerable meetings with Metropolitan Police officers and Southwark office representatives.

Allowing a business property (Bar) to be open until that late (23:00, from Sunday until Thursday, and 3:00 on Friday and Saturday) will not only increase that level of criminality, but will make Choumert Road a gathering place for people to come and stay until late at night (well beyond 23:00/3:00) causing disturbance and nuisance to the residents.

During Covid (2020 and 2021) it was recurrent the presence of people consuming alcohol on the road and with loud music coming out from their cars until the early hours of the morning. The residents on Choumert Square (and I suspect other neighbours near Choumert Road) have had to deal with late night parties on Choumert Road for years now that get rowdy, are seemingly impossible to police and keep everyone awake. We live on a quiet pedestrian street and 18 Choumert Road backs directly onto the residential houses, with from what I understand no adequate sound proofing installed in the commercial premise. I am a resident at the Choumert Road, SE15 - Very near to L'Atitude, 18 Choumert Road, SE15 4SE.

I am emailing regarding their proposed extended license (until 3am). Firstly, I already thought they had a late night license - I am often kept awake until 3am with the noise of the music at the weekend as they leave two large doors at the front of the building open and the bass reverberates across the whole street. Additionally there are no controls on the amount or volume of the customers they allow onto the street. There is often large numbers of people (15-20) outside at once - they have to shout loudly to hear over the music which is audible outside and are often singing/ chanting.

Choumert Road is an extremely volatile and noisey Street - a lot of the businesses (shops, restaurants) on this street play music until 5am during the summer and use their business premises as a place to host their friends. It's an absolute nightmare to try and exist peacefully on this street already without granting an extended licence to a club.

I am not usually one to interfere, however I run a pub in South London and feel I'd be happy with a controlled and reasonable amount of noise, but given my experience I don't feel it is reasonable at all and if they are not doing anything to control it now when they don't have a licence I am worried what it may look like when they do have permission granted.

I hope you can understand my concerns.

I writing to you with concern over the proposed extension of opening hours for the bar L'Attitude located at 18 Choumert Road, SE15 4RE.

My address is SE15 SE15 The side of my flat looks down directly over CAllitude.

My concerns are:

- 1. The bar already has no regard for it's registered opening times, regularly staying open 30+ minutes past it's listed closing time.
- 2. The bar regularly plays extremely loud, bass heavy music that reverberates up to my premises and many others in the vicinity. The front of their premises is not sound proofed, and they regularly leave their front door wide open. This noise prevents us from sleeping and forces us to use ear plugs.
- 3. They provide a doorman who does not keep the door closed or tell people to be quiet when exiting or entering the premises.
- 4. In an attempt to make the owner aware of the noise issue I went to speak to him towards the end of last year. He stated that he could 'stay open until whenever he liked and had unlimited late licenses'. He also stated he believed 'only 12 people lived in the street, so it did not matter how loud they were'.
- 5. Myself and my partner are registered paramedics working for the London Ambulance Service. We regularly have to get to sleep at 9pm in order to wake up at 5am for shift work. The bar has affected our ability to be properly prepared for our job.

I am sure you are aware of the long-standing issues with excess noise, drug use and anti-social behaviour on Choumert Road. The installation of a security camera appeared to sort the issue to the relief of residents, but they are now in despair again knowing their evenings will be constantly ruined by the noise emanating from L'Attitude.

I am writing to object to **Licensing Application no. 879353** on the grounds of Prevention of Public Nuisance and concern for Public Safety. L'Attitude bar is a ground floor cocktail bar at 18 Choumert Road wishing to significantly extend its opening hours.

The shops and other businesses of Choumert Road have over the years extended their internal space to cover what used to be open yards. As a result, all their rear walls, including that of l'Attitude, have become shared, party walls with the homes on Choumert Square, a street of residential terraced houses that is part of the Holly Grove Conservation Area. This party wall is one brick's thickness, and the result is considerable noise transference. There has been no sound proofing put in place at L'Attitude and their operations are already causing a considerable nuisance even within the existing opening hours, but extending them until 3am will cause profound disturbance to the residents of the homes in the vicinity of the bar.

There have been a series of problems with late night noise from premises on Choumert Road and Rye Lane, often in complete disregard of their various licensing conditions. For example, regarding 18 Choumert Road, a late party just before Christmas resulted in people gathering in the street, creating noise and aggressive confrontations until the small hours, despite having a set condition that the doors should close at 10 pm. Repeated requests for more enforcement of existing regulations have proved unsuccessful; officials find it difficult to patrol all late-night activity in the area, so enforcement fails.

In conversations with local police, residents have been made aware that Choumert Road is regarded by police as an area `hot spot' especially in the summer. It has become a road to avoid walking through late at night because of public drunkenness, drug culture and frequent aggression, so I would also suggest that it is unhelpful to be encouraging more people to drink until late, exacerbating the already existing noise and nuisance.

Further to your email, I have spoken to Jayne Tear who has clarified the procedures.

I would like to represent a resident who lives on Choumert Road in her objection to this licensing application as she does not want her name and address to be made public.

She is objecting on the grounds of prevention of public nuisance in terms of noise and litter. She reports that there is already considerable obstruction to rights of local residents to enjoy peace and sleep on weekend nights. For example they are regularly woken up by people on their way home from other bars shouting and screaming in the street and leaving litter. Her child who sleeps in the front of the house regularly complains that she cannot sleep or is woken up by noise from the street. She reports that the noise usually reduces by 1am and that it would be intolerable if this were to continue until 3am and beyond.

I don't believe the extension of this licence would be in compliance with our current policy.


