#### RECOMMENDATION

 That the licensing sub-committee considers an application made by Los Arrieros De Pito Ltd for a premises licence to be granted under the Licensing Act 2003 in respect of the premises known as Los Arrieros De Pito, Arch 144, Eagle Yard Ground Floor, 10 Hampton Street, London SE1 6SP.

#### 2. Notes:

- a) This application forms a new application for a premises licence, submitted under Section 17 of the Licensing Act 2003. The application was subject to representations from three responsible authorities, namely the Metropolitan Police Service, trading standards and licensing as a responsible authority. Whilst the responsible authority representations have since been conciliated, at the time of writing this report, thirteen objections from members of the public remain outstanding. Therefore, the application has been referred to the subcommittee for determination.
- b) Paragraphs 8 to 13 of this report provide a summary of the application under consideration by the sub-committee. A copy of the original application form can be found at Appendix A.
- c) Paragraphs 14 to 25 of this report deal with the representations submitted in respect of the application. Copies of the representations submitted are attached in Appendixes B to E. A map showing the location of the proposed premises is attached to this report as Appendix F.
- d) A copy of the council's approved procedure for hearings of the Sub-Committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing procedure, has been circulated to all parties to the meeting.

## **BACKGROUND INFORMATION**

#### The Licensing Act 2003

- 3. The Licensing Act 2003 provides a licensing regime for:
  - The sale of and supply of alcohol
  - The provision of regulated entertainment
  - The provision of late night refreshment.

- 4. Within Southwark, the licensing responsibility is wholly administered by this council.
- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:
  - The prevention of crime and disorder
  - The promotion of public safety
  - The prevention of nuisance
  - The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to:
  - The Act itself
  - The guidance to the act issued under Section 182 of the Act
  - Secondary regulations issued under the Act
  - The licensing authority's own statement of licensing policy
  - The application, including the operating schedule submitted as part of the application
  - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.

#### **KEY ISSUES FOR CONSIDERATION**

#### The premises licence application

- On 27 October 2023, Los Arrieros De Pito Ltd applied for a premises licence to be granted under the Licensing Act 2003 in respect of the premises known as Los Arrieros De Pito, Arch 144, Eagle Yard Ground Floor, 10 Hampton Street, London SE1 6SP
- 9. The nature of the application, as shown in the original application form (which can be found at Appendix A) is that the premises would operate as an "eat in or take away food shop".
- 10. The application form shows that the applicant was originally seeking to be granted the following hours and activities:
  - The supply of alcohol to be consumed on the premises:

Monday to Friday: 09:00 to 21:00

Saturday: 09:00 to 23:00Sunday: 10:00 to 23:00

#### Opening hours:

Monday to Friday: 09:00 to 21:00

Saturday and Sunday: 09:00 to 23:00.

- 11. Following discussions with the Metropolitan Police Service, however, the applicant has since revised down their requested hours of operation and activity, as follows:
  - The supply of alcohol to be consumed on the premises:

o Monday to Saturday: 09:00 to 21:00

o Sunday: 10:00 to 21:00

- Opening hours:
  - Monday to Sunday: 09:00 to 21:00.
- 12. Therefore, it is these hours that the sub-committee are required to make a decision on.

## **Designated premises supervisor**

13. The proposed designated premises supervisor is Ginna Viviana Farjardo Agudelo, who holds a personal licence issued by the London Borough of Southwark.

## Representations from responsible authorities

- 14. The police representation mainly referred to the applicant not providing enough control measures as part of their application (in light of there being numerous historic complaints about alcohol-fueled anti-social behaviour in the locale), or showing clearly how they might uphold the licensing objectives. The applicant and the police have since able to reach agreement and conciliate matters. This was not just as a result of the applicant agreeing a reduced terminal hour of operations (Paragraph 11), but also to a significant number of conditions to help support the licensing objectives.
- 15. The original representation from the police, subsequent conciliation and agreed conditions can be found at Appendix B.
- 16. The representation from licensing as a responsible authority also shared the concerns raised by the police, about the measures initially proposed in relation to the licensing objectives and argued that these should be more robust. The applicant and licensing have since come to an agreement over the adoption of conditions to help mitigate this and this has allowed licensing to withdraw their objection.
- 17. The original representation from licenisng, subsequent conciliation and agreed conditions, can be found in Appendix C.
- 18. The representation from trading standards related to concerns about underage sales of alcohol and the lack of many proposals to safeguard against this. Within their submission, trading standards put forward some suggested conditions that would help address this issue. Following receipt of this suggestion, the Applicant has agreed to adopt these conditions, thereby leading the Trading Standards to withdraw their objection.
- 19. The representation from trading standards, including their suggested conditions, can be found in Appendix D.

#### Representations from other persons

- 20. During the consultation period, thirteen representations were received from members of the public. Since Objector K and L are the same person, commenting in their capacity as a director of a charity in the locality and as a local resident, Members may wish to combine the two or disregard one.
- 21. The majority of comments made relate to anti-social behaviour and crime and disorder that has historically taken place within the local area and concern about granting another premises licence that would make matters worse for residents in this regard. Regarding the specific issue of hours, the objectors have also raised significant concerns about another later night venue operating in the area.
- 22. Despite the comments about hours, members should note that these objections were made in response to the hours proposed in the original application (Paragraph 10), rather than the revised hours proposed by the applicant (Paragraph 11). This was because it was not until after the consultation ended on 1 December 2023 that the Applicant formally agreed to reduce the proposed terminal hour to 21:00 hours (6 December 2023).
- 23. In addition, some of the objectors have called for the application to be refused by the sub-committee entirely. However, some of the objectors have put forward some suggested conditions in the event a premises licence were to be granted.
- 24. Ultimately, it would be for the sub-committee to decide whether the application should be rejected. If not, they would need to decide whether the conditions already volunteered by the applicant thus far (in their original application or by agreement with the responsible authorities) mitigate all the concerns raised by the members of the public or not.

#### Conciliation

25. As mentioned, the applicant has resolved and conciliated all of the representations received from the three responsible authorities in this case (Paragraphs 14 to 19). However, at the time of writing this report, the thirteen objections from the public remain in place, thus triggering the need for a sub-committee to consider the application. Should any members of the public choose to withdraw their representations, members will be updated accordingly in advance or, or at the start, of the sub-committee hearing.

## **Southwark Council statement of licensing policy**

- 29. Council assembly approved Southwark's statement of licensing policy 2021-2026 on 25 November 2020 and it came into effect on 1 January 2021.
- 30. Sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
  - Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this authority relies in determining licence applications.
  - Section 5 Determining applications for premises licenses and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
  - Section 6 Local cumulative impact policies. This sets out this authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy.
  - Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this authority might consider appropriate by type of premises and (planning) area classification.
  - Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective.

- Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective.
- Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective.
- Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective.
- 31. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.
- 32. Members should take into consideration both the Southwark statement of licensing policy and the Section 182 Guidance when making decisions. The links for these are below.

## Climate change implications

- 35. Following council assembly on 14 July 2021, the council is committed to considering the climate change implications of any decisions.
- 36. Climate change is not a legal factor in the consideration of a grant of a premises license under the current licensing objectives, however members can make enquiries and request an agreement from applicants to promote the reduction of the impact of climate change that may be caused by the operation of the premises.
- 37. Examples of such an agreement may be:
  - Not to use single use plastics, such as disposable plastic glasses, when selling alcohol at the premises.
  - Encourage patrons not to drive to venues by providing details of public transport on their webpages/tickets.

## Community, equalities (including socio-economic) and health impacts

## **Community impact statement**

39. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

#### Equalities (including socio-economic) impact statement

40. This report does not result in a policy decision and each application is required to be considered upon its own individual merits with all relevant matters taken into account. In considering the recommendations of this report, due regard must be given to the public sector equality duty set out in section 149 of the Equality Act 2010. This requires the council to consider all individuals when carrying out its functions.

- 41. Importantly, the council must have due regard to the need to eliminate discrimination, harassment, victimisation, or other prohibited conduct; advance equality of opportunity and foster good relations between people who have protected characteristics and those who do not. The relevant protected characteristics are age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation. The public sector equality duty also applies to marriage and civil partnership, but only in relation to the need to eliminate discrimination, harassment, victimisation, or other prohibited conduct.

#### **Health impact statement**

44. Health impacts cannot be considered by law when making decisions under the Licensing Act 2003.

## **Resource implications**

45. A fee of £190 has been paid by the applicant in respect of this application, being the statutory fee payable for premises within non-domestic rateable value B.

#### Consultation

46. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local newspaper and a similar notice was exhibited outside of the premises for a period of 28 consecutive days.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Assistant Chief Executive – Governance and Assurance**

- 47. The sub-committee is asked to determine the application for a premises licence under Section 17 of the Licensing Act 2003.
- 48. The principles which sub-committee members must apply are set out below.

#### Principles for making the determination

- 49. The sub-committee is asked to determine the application for a premises licence under Section 17 of the Licensing Act 2003.
- 50. The principles which sub-committee members must apply are set out below.

- 51. The general principle is that applications for premises licence applications must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 52. Relevant representations are those which:
  - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
  - Are made by an interested party or responsible authority
  - Have not been withdrawn
  - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious.
- 53. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to:
  - To grant the licence subject to:
    - The conditions mentioned in section 18 (2)(a) modified to such extent as the licensing authority considers necessary for the promotion of the licensing objectives
    - Any condition which must under section 19, 20 or 21 be included in the licence.
  - To exclude from the scope of the licence any of the licensable activities to which the application relates.
  - To refuse to specify a person in the licence as the premises supervisor.
  - To reject the application.

#### **Conditions**

- 54. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the application, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.
- 55. The four licensing objectives are:
  - The prevention of crime and disorder
  - Public safety
  - The prevention of nuisance
  - The protection of children from harm.
- 56. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 57. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to night café and take away aspect of the license must relate to the night

- time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 58. Members are also referred to the Home Office Revised Guidance issued under section 182 of the Licensing Act 2003 on conditions, specifically section 10.

#### Reasons

59. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for a premises licence application, it must give reasons for its decision.

## **Hearing procedures**

- 60. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
  - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
  - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
  - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
    - Address the authority
    - o If given permission by the committee, question any other party.
    - o In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
  - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
  - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.
  - In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 61. This matter relates to the determination of an application for a premises licence under Section 17 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

## Council's multiple roles and the role of the licensing sub-committee

- 62. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 63. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.
- 64. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 65. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 66. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 67. The sub-committee can only consider matters within the application that have been raised through representations from other persons and responsible authorities. Interested parties must live in the vicinity of the premises. This will be decided on a case to case basis.
- 68. Under the Human Rights Act 1998, the sub-committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.

69. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

#### Guidance

70. Members are required to have regard to the Home Office guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

## **Strategic Director, Finance**

71. The head of regulatory services has confirmed that the costs of this process over and above the application fee are borne by the service.

In view of the applicant and police agreeing to the below conditions in red and the terminal hour being reduced to 2100hrs daily to be placed upon the licence should it be granted ,police would like to withdraw their objection to the granting of the New Premises licence for LOS ARRIEROS DE PITO 144 EAGLE YARD ARCH, GROUND FLOOR SE1 6SP,

- 1. That a digital CCTV system shall be installed at the premises, shall be maintained in full working order and shall be continually recording at all times that the premises are in use. The CCTV system must be capable of capturing a clear facial image of every person who enters the premises in all lighting conditions. The CCTV system shall be correctly time and date stamped at all times. The CCTV system shall cover all interior and exterior areas of the premises, including the frontage of the premises, and shall collect clearly defined / focused footage.
- 2. All CCTV footage shall be kept for a period of thirty one (31) days and shall be made immediately available for inspection to officers of the Police and the Council on request.
- 3. That at least one member of staff should be on duty at all times the premises is open that is trained in the use of the CCTV and able to view and download images to a removable device on request of Police or council officer.
- 4 . That clearly legible signs shall be prominently displayed where they can easily be seen and read by customers at all exits from the premises, requesting to the effect that customers leave the premises and area in a quiet and orderly manner. Such signs shall be maintained free from obstruction when the premises are in use in accordance with this licence and shall be written in English and multilingual according to the client base at the venue.
- 5. That a dispersal policy to assist with patrons leaving the premises in an orderly and safe manner shall be devised and maintained regarding the premises. A copy of the dispersal policy shall be accessible at the premises at all times that the premises are in operation. The policy should include (but not necessarily be limited to) the following:
- i. Details as to how customer / staff egress at the premises shall be managed to minimise causing nuisance.

- ii. Details of public transport in the vicinity and how customers will be advised in respect of it.
- iii. Details of the management of taxis to and from the premises.
- iv. Details of the management of any 'winding down' period at the premises.
- vi. Details of the use of security and stewarding in respect of managing customer dispersal from the premises.
- vii. Details of road safety in respect of customers leaving the premises.
- viii. Details of the management of ejections from the premises.

- 6 . All relevant staff employed at the premises shall be trained in the latest version of the dispersal policy. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises. If the dispersal policy is a paper document then the signature of the trainees shall also be included. The dispersal policy shall be made immediately available to responsible authority officers on request.
- 7. That an incident log shall be kept at the premises to record details of any of the following occurrences at the premises:
- I. Instances of anti-social or disorderly behaviour
- II. Calls to the police or other emergency services
- III. Any complaints received
- IV. Ejections of people from the premises
- V. Visits to the premises by the local authority or emergency services
- VI. Any malfunction in respect of the CCTV system
- VII. All crimes reported by customers, or observed by staff
- VIII. Any other relevant incidents
- 8. The incident log shall record the time, date, location in the premises and description of each incident, details of any action taken in respect of the incident and the printed name of the person reporting the incident and. The incident log shall be available / be accessible at the premises at all times that the premises are in use, and shall be made immediately available to responsible authority officers on request. Details of incidents shall be recorded contemporaneously. If the incident log is a paper hardcopy then the signature of the person reporting the incident in the log shall also be included. All relevant staff employed at the premises shall be trained in the use of the incident log. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- 9. The Premises must have a welfare and vulnerability policy and all staff must receive this training. All new staff must receive this training before starting their role and all staff must have refresher training every 12 months. All training must be recorded and these

records must be available on immediate request by the police or authorised council officers.

- 10 . That 'Ask for Angela' posters (or posters relating to whatever similar scheme may be recommended by the council and / or the police at any time) shall be displayed in the female toilet facilities and kept free from obstructions at all times. All staff shall be trained in the 'Ask for Angela' scheme (or similar scheme) and shall perform the appropriate course of action in the event of a customer requesting assistance. Details of such training, including the printed name of the trainee and the date of the training, shall be recorded in the staff training logs at the premises.
- 11. That all relevant staff shall be trained in their responsibilities under the Licensing Act 2003, the promotion of the licensing objectives and the terms and conditions of this licence. Records pertaining to such training ('the staff training logs') shall be kept at the premises, shall be updated every 6 months and shall be made immediately available to responsible authority officers on request. The training logs shall include the trainee's name (in block capitals), the trainer's name (in block capitals), the date(s) of training and a declaration that the training has been received and understood by the trainee. If the staff training logs are a paper hardcopy then the signature of the trainee, the signature of the trainer shall be included.
- 12. That customers shall use no outside area other than those who temporarily leave the premises to smoke a cigarette with no more than four people permitted to smoke at one any time. The area should be clearly marked by rope/post barrier system and shall not encroach the car park area. The Staff or/and SIA registered door supervisors shall instruct customers to stay within the designated area. The area will be controlled by Staff or/and SIA registered door supervisors to prevent any disturbance to their neighbours.
- 13. No alcoholic drinks or glassware will be removed from the premises.
- 14. That clearly legible signage shall be prominently displayed where it can easily be seen and read by customers advising that no alcoholic drinks are permitted outside of the premises. Such signage shall be kept free from obstructions at all times and shall be written in English and multilingual according to the client base at the venue.
- 15. That the supply of alcohol on the premises shall only be to a person seated taking a hot table meal there and for consumption by such a person as ancillary to their meal only.

- 16. That all licensable activities shall cease 30 mins before the terminal hour.
- 17. There shall be no vertical drinking in the premises.
- 18. That if a Pubwatch scheme exists in respect of the local area, the licensee / management will join and participate in the Pubwatch scheme.
- 19. There shall be no third party hire of the venue.
- 20. That all drinks shall be sold in cans or plastic bottles, or will be decanted into recyclable polycarbonate (or a similar recyclable material), or recyclable cardboard drinking receptacles. Glass drinking receptacles will not be used at the premises at any time.
- 21. That clearly legible notices will be prominently displayed where they can easily be seen and read by customers stating the premises' drugs and weapons policy (zero tolerance). Such signage shall be kept free from obstructions at all times and written in English and multilingual according to the client base at the venue.
- 22. That if and when required, staff and/or SIA registered door supervisors shall interact with customers to ensure that customers behave at the premises in a quiet and orderly manner and also leave the premises and locale in a quiet and orderly manner. Customers deemed by staff to be engaging in anti-social behaviour shall be asked to leave the premises. Staff shall be trained in this and details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given and shall be recorded in the staff training logs at the premises. These records shall be made immediately available for inspection to responsible authority officers on request.
- 23. That when licensable activities cease and until all patrons have vacated the venue, Staff and/or SIA registered door supervisors shall take a proactive role by politely encouraging customers to leave the venue in an orderly manner and not to loiter in Maldanado Walk or the adjacent car park area.
- 24. That staff and/or SIA registered door supervisors shall proactively monitor outside the premises and take all necessary steps to ensure that noise from their patrons or premises operation does not cause disturbance or public nuisance. A log of such

monitoring including the printed name of the person who undertook the monitoring, the date & time of the monitoring and any observations or actions taken subsequent to the monitoring shall be kept at the premises and be made immediately available to council or police officers on request.

Police are in possession of an application for a new Premises Licence for, Supply of Alcohol on sales. The venue describes itself as "eat in and takeaway food venue". The applicant has requested the following hours which are within those recommended in the Southwark Council Statement of Licensing Policy for a venue in The Elephant and Castle Major Town Centre area

Open hours to public

Mon-Fri-0900hrs-2100hrs Sat-0900hrs-2300hrs Sun-0900hrs-2300hrs

Supply of Alcohol on sales

Mon-Fri-0900hrs-2100hrs Sat-0900hrs-2300hrs Sun-1000hrs-2300hrs

The premises is situated in a row of railway arches to which there is already a saturation of venues purporting to be "eat in and takeaway food venues", however they are alcohol led and this operation appears to be no different as within the

applications it states "the only reason for the alcohol license is to able to serve our customers who want alcohol before they eat their food"

It should be noted that the area is shrouded by residential buildings, and has for a number of years been subject of numerous complaints in regards to alcohol fuelled anti-social behaviour and disorder caused by patrons attending and leaving venues particular at weekends and this continues to this day.

The applicant should have some knowledge of the area to which they wish to operate and the control measures they offer should reflect how the venue would ensure they do not add to the alcohol related problems that already exist, this application does not show this. The measures offered are not only vague but also not enforceable, there is mention of a policy to deter public nuisance and measures to prevent crime and disorder however we cannot comment on this as no documentation detailing the policy and measures has been produced? There is no mention of how they will control the sale of alcohol or prevent over intoxication of patrons. The application does not address any of the licensing objectives in particular that of prevention of crime and disorder.

The Home office guidance issued under Sec 182 of the licensing Act 2003 'General principles' state that it is important in setting the parameters within which the premises may operate. Conditions must be precise and enforceable.

Police would expect to see more robust conditions that are clear, concise and address the local issues that are associated with venues supplying alcohol particular at busy periods such as weekends.

The metropolitan police object to the granting of the Premises Licence as the applicant has not addressed the licensing objectives in particular that of prevention of crime and disorder. There are also serious concerns that another late night weekend venue at the location will only add to crime and disorder in the area and have a detrimental effect on local residents.

We object to the grant of an application for a premises licence, submitted by Los Arrieros De Pito Ltd under The Licensing Act 2003 (the Act), in respect of the premises known as Los Arrieros De Pito Ltd, Ground Floor, Arch 144, Eagle Yard, Hampton Street, SE1 6SP\*.

\*NB: Eagle Yard was renamed Maldonado Walk in February 2018. Maldonado Walk is separate to Hampton Street. We believe the premises' correct address to be 'Ground floor, Arch 144, Maldonado Walk, SE1 6SP and advise the applicant to attend to this matter urgently, however the address need not be discussed by the licensing sub-committee as we are aware of what premises is being referred to in the application.

### 1. The application

The application seeks to allow the following -

### The sale of alcohol to be consumed on the premises:

Monday - Friday: 09:00 - 21:00 Saturday: 09:00 - 23:00 Sunday: 10:00 - 23:00

### The opening hours of the premises are:

Monday - Friday: 09:00 - 21:00 Saturday: 09:00 - 23:00 Sunday: 10:00 - 23:00

In the application the premises, and the intended operation of the premises, are described as (verbatim) -

• "Eat in or take away food shop."

### 2. The Locale

The premises are located on Maldonado Walk, which leads directly from the very north of Walworth Road and is in close proximity to the traffic system at the south of Elephant and Castle. Walworth Road and Elephant and Castle are extremely busy thoroughfares, primarily containing commercial premises and high volume residential blocks. Elephant and Castle is a major transport hub. The premises are in very close proximity to Strata Tower and Draper House, which are high-rise residential blocks.

A map showing the location of the premises, and its proximity to residential dwellings, is attached as appendix 1. Photo's showing the premises and residential dwellings close to the premises are attached as appendix 2.

Maldonado Walk as whole has been subject to many complaints from local residents regarding the conduct of existing licensed premises on Maldonado Walk, and in relation to crime and disorder, anti-social behaviour and nuisance over the past 12 months. The area is currently regarded as a 'hotspot' in respect of these matters.

### 3. Our objection

According to section 7 of this council's statement of licensing policy 2021 – 2026 (the SoLP), the premises fall within The Elephant and Castle Major Town Centre.

The following closing times are recommended in our SoLP in respect of various types of licensed premises located in the Elephant and Castle Major Town Centre as stated -

<u>Public houses, wine bars or other drinking establishments and bars in other types of premises</u>

Sunday – Thursday: 23:00 Friday – Saturday: 00:00

Restaurants, cafes & 'Event premises / spaces' where the sale of alcohol is included in, and ancillary to, a range of activities including meals —

Sunday – Thursday: 00:00 Friday – Saturday: 01:00

Our objection relates to the promotion of the prevention of crime and disorder, the public safety and the prevention of public nuisance licensing objectives.

In part 'M' of the application, the applicant has proposed various measures to address the licensing objectives. We welcome these measures, but do not feel that they sufficiently address the licensing objectives.

To ensure that any licensing conditions derived from part 'M' of the form are *appropriate*, *practicable and enforceable* we recommend that the measures stated in part 'M' of the application are replaced *in their entirety* by the following proposed licence conditions:

## A. General – all four licensing objectives:

- 1. That all relevant staff shall be trained in their responsibilities under the Licensing Act 2003, the promotion of the licensing objectives and the terms and conditions of this licence. Records pertaining to such training ('the staff training logs') shall be kept at the premises, shall be updated every 6 months and shall be made immediately available to responsible authority officers on request. The training logs shall include the trainee's name (in block capitals), the trainer's name (in block capitals), the date(s) of training and a declaration that the training has been received and understood by the trainee. If the staff training logs are a paper hardcopy then the signature of the trainee and the signature of the trainer shall be included.
- 2. That a written record of all staff authorised to sell alcohol at the premises shall be kept at the premises and will be made available to responsible authority officers immediately on request. The authorisation record shall include the name and address of the premises, the name of the licensee, the name of the DPS and the names, addresses and dates of birth of all staff authorised to sell alcohol at the premises.

# B. The prevention of crime and disorder:

- 3. That a digital CCTV system shall be installed at the premises, shall be maintained in full working order and shall be continually recording at all times that the premises are in use. The CCTV system must be capable of capturing a clear facial image of every person who enters the premises. The CCTV system shall be correctly time and date stamped. The CCTV system shall cover all interior and exterior areas of the premises, including the frontage of the premises, and shall collect clearly defined / focused footage.
- 4. That all CCTV footage shall be kept for a period of thirty one (31) days and shall be made immediately available to council and / or police officers on request.
- 5. That a member of staff shall be on duty at all times that the premises are in use, who is trained in the use of the CCTV system and who is able to view, and download to a removable storage device, CCTV footage at the immediate request of police and / or council officers.

- 6. That clearly legible signage (written in both English and Spanish) shall be prominently displayed where it can easily be seen and read by customers in the toilets advising to the effect that the taking of illegal drugs will not be tolerated at the premises. These notices shall be kept free from obstructions at all times.
- 7. That an incident log shall be kept at the premises to record details of any of the following occurrences at the premises:
  - Instances of anti-social or disorderly behaviour
  - Calls to the police or other emergency services
  - · Any complaints received
  - Ejections of people from the premises
  - Visits to the premises by the local authority or emergency services
  - Any malfunction in respect of the CCTV system
  - All crimes reported by customers, or observed by staff
  - Any other relevant incidents

The incident log shall record the time, date, location in the premises and description of each incident, details of any action taken in respect of the incident and the printed name of the person reporting the incident and. The incident log shall be available / be accessible at the premises at all times that the premises are in use, and shall be made immediately available to responsible authority officers on request. Details of incidents shall be recorded contemporaneously. If the incident log is a paper hardcopy then the signature of the person reporting the incident in the log shall also be included. All relevant staff employed at the premises shall be trained in the use of the incident log. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.

8. That all drinks shall be sold in cans or plastic bottles, or will be decanted into recyclable polycarbonate (or a similar material), or cardboard drinking receptacles. Glass drinking receptacles will not be used at the premises at any time.

### C. Public Safety

9. That the maximum number of people permitted on the premises at any one time (the 'accommodation limit') is **X** people (excluding staff). The accommodation limit shall be known by all staff and shall not be exceeded at any time.

### << The applicant should provide the accommodation limit – WM>>

10. That clearly legible signage shall be displayed where it can easily be seen and read by customers and staff identifying all emergency escape routes and emergency exits at the premises. Such signage shall be kept free from obstructions at all times.

- 11. That all emergency exits, emergency escape routes and entry / exit doors at the premises shall be kept free from obstructions at all times that the premises are in use.
- 12. That any spills of liquid onto the floor at the premises' shall be cleared away as soon as possible on a continuous basis whilst the premises are in use. Any wet floors will be clearly demarcated to prevent slips being caused by the wet floors. Relevant staff shall be trained in this, and details of such training including the printed name(s) of the trainee(s), and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- 13. That broken or waste glass / earthenware shall be cleared away as soon as possible on a continuous basis whilst the premises are in use to minimise risk of injury. Relevant staff shall be trained in this, and details of such training including the printed name(s) of the trainee(s), and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- 14. That appropriate first aid equipment / materials shall be kept at the premises in a dedicated first aid box / boxes. The first aid box(es) shall be kept easily accessible and unobstructed at all times. All staff shall be made aware of where the first aid boxes are located.
- 15. That 'Ask for Angela' posters (or posters relating to whatever similar scheme may be recommended at any time) shall be displayed in the female toilet facilities and kept free from obstructions at all times. All staff shall be trained in the 'Ask for Angela' scheme (or similar scheme) and shall perform the appropriate course of action in the event of a customer requesting assistance. Details of such training, including the printed name of the trainee and the date of the training, shall be recorded in the staff training logs at the premises.

### D. The prevention of public nuisance

- 16. That a dispersal policy to assist with patrons leaving the premises in an orderly and safe manner shall be devised and maintained regarding the premises. A copy of the dispersal policy shall be accessible at the premises at all times that the premises are in operation. The policy should include (but not necessarily be limited to) the following:
  - I. Details as to how customer / staff egress at the premises shall be managed to minimise causing nuisance.
  - II. Details of public transport in the vicinity and how customers will be advised in respect of it.
  - III. Details of the management of taxis to and from the premises.
  - IV. Details of the management of any 'winding down' period at the premises.
  - V. Details of the use of security and stewarding in respect of managing customer dispersal from the premises.
  - VI. Details of any cloakroom facility at the premises and how it is managed.

- VII. Details of road safety in respect of customers leaving the premises.
- VIII. Details of the management of ejections from the premises.
- IX. Details of how refuse / waste in the local vicinity arising through the operation of the premises will be cleared up (e.g. flyer clean up, post event clean up).

All relevant staff employed at the premises shall be trained in the latest version of the dispersal policy. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises. The dispersal policy shall be made immediately available to responsible authority officers on request.

- 17. That any litter caused by the operation of the premises shall be cleared away from the immediate vicinity of the premises periodically throughout operating hours, and at the end of trade, on each day that the premises are in operation. Relevant staff shall be trained in this, and details of such training including the printed name(s) of the trainee(s), and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- 18. That staff shall be trained to arrive at, conduct themselves at the premises at all times, and leave the premises in an orderly manner, with particular care taken when staff close the premises at the end of trade on each day. The details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- 19. That clearly legible signage (written in both English and Spanish) shall be prominently displayed where it can easily be seen and read by customers, at all exits from the premises and in any external areas, requesting to the effect that customers leave the premises and locale in a quiet and orderly manner with respect to local residents. Such signage shall be kept free from obstructions at all times.
- 20. That external waste handling, collections of goods from the premises, deliveries of goods to the premises and the cleaning of external areas shall only occur between the 08:00 hours and 22:00 hours.
- 21. That clearly legible signage stating a dedicated contact telephone number for the premises shall be prominently displayed where it can easily be seen and read by passers-by. The signage shall state to the effect that the phone number shown can be used to contact the premises in respect of any complaints regarding the operation of the premises. If the telephone number relates to a mobile phone, then the duty manager / supervisor on duty shall have the mobile phone on their person at all times. Such signage shall be kept free from obstructions at all times.
- 22. That if and when required, staff shall interact with customers to ensure that customers behave at the premises in a quiet and orderly manner and also leave the premises and locale in a quiet and orderly manner. Customers deemed by staff

to be engaging in anti-social behaviour shall be asked to leave the premises. All relevant staff shall be trained in this, and details of such training including the printed name(s) of the trainee(s), and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.

23. That any external areas of the premises will be closed to customers between 22:00 hours and 09:00 hours the following day except for up to a maximum of 10 people at any one time using the external areas after 22:00 hours to smoke only. All outdoor furniture must be rendered unusable by 22:15 hours each day.

### E. The protection of children from harm:

 It is noted that the applicant has already agreed to conditions with this council's trading standards service to address this licensing objective.

We also recommend that the sale of alcohol ceases at the following hours to allow customers sufficient time to finish their drinks prior to the premises closing on each day:

Monday - Friday: 20:30 Saturday: 22:30 Sunday: 22:30

We welcome discussion regarding any of the above, however should the applicant agree to all of the above conditions then we will withdraw this application.



Trading Standards as a responsible authority are in receipt of a new premises license application from Los Arrieros De Pita Ltd, in respect of a premises at Arch 144, Eagle Yard, Hampton Street, London, SE1 6SP. Trading Standards as a responsible authority are making representation in respect of this application under all the licensing objectives, but primarily the protection of children from harm.

In the general description this is:-

"Eat in or take away food shop"

The opening hours are to be:-

Monday to Friday 09:00hrs to 21:00hrs and Saturday / Sunday 09:00hrs to 23:00hrs

The hours for alcohol sales are to be (on sales only):-

The same.

Under the licensing objectives it states the following under the protection of children from harm:-

"We do not promote anything which give rise to harm children. Our environment we operate in is welcoming to the extent that some families bring their children to enjoy our meal.."

There needs to be an age verification system to prevent under age sales. Trading Standards therefore simply asks that the following conditions be put forward to cover all these matters.

4AA - The premises shall operate an age check 'Challenge 25' policy whereby customers purchasing alcohol who look or appear to be under 25 years of age will be asked for an approved form of proof of age to verify their age. Approved forms shall include a driving licence, passport or a PASS approved proof of age card such as the Southwark Proof of Age (SPA) card.

4AB - All staff involved in the sale of alcohol shall be trained in the age check 'Challenge 25' policy. A record of their training, including the dates that each member of staff is trained, shall be available for inspection at the premises on request by the Council's authorised officers or the Police.

4AC - Age check or 'Challenge 25' signage shall be displayed at entrances to the premises, areas where alcohol is displayed for sale and at points of sale to inform

customers that an age check 'Challenge 25' policy applies and proof of age may be required.

4AI - A register of refused sales of alcohol shall be maintained in order to demonstrate effective operation of the policy. The register shall be available for inspection at the premises on request by Council authorised officers or the Police.

No unaccompanied minors under the age of 16

I attach electronic documents of training materials and a refusals register which can be used to meet the above conditions in terms of staff training and use of a refusal register. This effectively saves the business the cost of paying a consultant to undertake such activities. There is no reason why a person in the business who holds a personal license cannot undertake such training for staff and this can form part of a defence for the business should a member of staff supply alcohol to a minor.

If you are happy to accept these conditions then trading standards, as a responsible authority, will be happy to lift the representations made in respect of the application.



# Re: licence application 881493

I write in connection with the application by Los Arrieros de Pito Ltd for a new premises licence for Arch 144 in Maldonado Walk (also known as Eagle Yard) at the Elephant & Castle.

I object to the application in its current form but I think that with careful use of conditions – to protect the amenity of neighbouring residents – my concerns can be overcome.

Residents of the Draper Estate and the Strata SE1 tower have been in correspondence with councillors, council officers and the local policing team for several years about noise and nuisance arising from the venues on Maldonado Walk (and their customers).

The premises that is the subject of this application - Arch 144 - was once the most problematic venue (Corporación Ponce). At present, it is Arch 145 (Carolina Bar & Lounge) that generates most of the nuisance experienced by local residents.

As residents, we are keen to have a good relationship with the neighbouring businesses on Maldonado Walk, but this has been difficult when some venues have shown disregard for their impact on nearby homes.

I believe that with suitable give and take on both sides there need not be any conflict between the food and drink venues in the arches, and the residents living in close proximity.

The licensed hours proposed by Los Arrieros de Pito seem reasonable, and to date it seems to have been a food-led operation, in contrast to previous drinks-led operations in the same arch.

This representation is primarily made in connection with the third licensing objective: the prevention of public nuisance.

I am concerned that if this became more clearly a bar rather than a restaurant, then there would be significant concerns under the licensing objective relating to crime and disorder.

I live in a live in a live in a lived at this address for more than eight years. Our flat is on the floor, directly opposite the premises which is on the other side of the servicing yard at the rear of the Strata SE1 tower.

In recent years – especially during the summer months – we have been disturbed on multiple occasions by noise associated with late night activity at this premises and the nearby venues on Maldonado Walk.

The noise sometimes comes from patrons gathered outside having loud conversations and disputes with raised voices, and sometimes from staff dealing with rubbish - including bottles - after the premises has closed.

The acoustic qualities of the space mean that even when customers are standing directly next to the railway arches, noise travels across the yard and causes a disturbance to neighbouring residents.

Whereas some of the other premises on Maldonado Walk are shielded from nearby residents by Crossway Church, Arch 144 opens directly onto the servicing yard, so the impact of the behaviour of people leaving the venue is felt directly by residents in Draper House and Wollaston Close (both part of the Draper Estate) and the Strata tower.


There are eight full-size railway arches between Walworth Road and Maldonado Walk. Currently there are five licensed premises in this parade, all concentrated in the southern 50 metres of the alleyway. The current application will add a sixth licenced premises.

The existing situation already results in significant detriment to neighbouring residents, so it is understandable that we are concerned about the impact of further intensification of the cluster of bars and restaurants.

I would ask that consideration is given to adding conditions to address the following:

- That the character of the operation remains food-led (eg no alcohol without a substantial table meal) in line with the application's description of the premises as "eat in or take away food shop"
- 2. That the premises should have a dispersal policy specifically adapted to the circumstances in Maldonado Walk, including the cumulative impact of patrons leaving multiple venues and spilling out into the yard
- 3. That the times during which rubbish (including glass) can be placed outside the premises be limited to prevent nuisance to neighbours
- 4. That the premises should display contact details for an English-speaking staff member who can liaise with nearby residents in case problems arise
- 5. That arrangements for smokers outside the premises be governed by condition

### **Background to situation in Maldonado walk**

In the last 2 years since licences premises were agreed at Maldonado walk we have had one murder, 2 stabbings.

More recently in 4 September 2023 an attempted glassing of another person while leaving premises when a mass fight broke out ( Video available for committee to see ) and on 02/10/23 one was left unconscious on our estate after a fight related to premises at Maldonado walk ( photos for committee to see )

We have become so concerned with the situation at Maldonado a group of residents from draper estate and strata have set up a WhatsApp group where we share concerns and videos of incidents. I urge the committee to look at some of these videos to see what the we are experiencing on both draper and strata estates. And to consider if it is any way appropriate to have another licensed.

Police and local councillor Martin Seaton have witnessed some of problems we are experiencing.

### Crime and disorder

On so many numerous occasions, I have seen people taking drugs outside various establishment.

I have witnessed on numerous occasions people leaving the establishments and having verbal arguments while extremely drunk.

I have witnessed on numerous coassions, people completely drunk and completely incapable of walking because of the amount of alcohol they have consumed.

### Anti social behaviour

On so many numerous coassions I have been woken up by people, shouting and arguing with each other while leaving the premises.

On numerous occasions, I have seen the door man stand by, while people were standing outside smoking and shouting and laughing creating nuisance and anti social behaviour. The door men never intervene to stop this.

On numerous occasions, I have seen men urinating after leaving the club. Sometimes up to a dozen at a time right outside the church in view of the whole estate where children live.

I was told by another witness that the chef came out of club and urinated outside.

On numerous occasions, I have seen and heard, music emanating from persons cars who have left premises and getting into their cars parked outside of club. Then, sitting for long periods of time with music on high volume.

### Health and safety

On numerous occasions, I have seen men urinating after leaving the club. The area stinks of urine behind Crossways church.

People on the estate fear for their safety when certain establishments are open because the area has become a centre for crime and anti social behaviour, since licensed premises were opened.

### Protection of children from harm

The constant noise and anti social behaviour from ponce, is making difficult for children to sleep at night on our estate. They are witnessing fights, people urinating and high amounts of anti social behaviour.

Children from all these premises are seen regularly playing football in car park where cars are moving around.

We are completely overwhelmed with licensed premises in a small area which are attracting criminals including drugs dealers.

I also urge the committee, to see photos of area which show the very close proximity of

to residential areas, and consider a saturation policy for immediate area. Strictly limiting licensing hours for this area of Eagle Yard.

I urge the committee if minded to agree another licenced premises should put in the following conditions.

As local resident we have concerns that some Licensing premises in Maldonado walk were very regularly over legal capacity therefore we request-

That they have CCTV inside to monitor numbers/capacity.

Local residents have experienced regular noise and anti social behaviour from premises in Maldonado walk therefore we request-

That all patrons leaving premises should be assisted by staff stationed outside to leave quietly and in good order without disturbing local residents in anyway way by shouting, urinating in public places near establishment, disturbing people or in by passenger vehicles leaving premises. Hooting horns, slamming doors or making any intrusive engine noise.

I am writing to object to the current licence application for the following:

The reasons are as follows:

### prevention of crime and disorder and public safety

At present, the 100m pedestrian walk has already four or five premises licensed to sell alcohol with live and or recorded music. Similar premises next to the applicant's venue have been attracting considerable amount of people, causing nuisance (for example shouting outside my window) and when this venue was operating last time under the name Ponce, many residents had to endure spontaneous parties outside their windows or at worst, loud fights. These gatherings often happened and still happen after closing hours, with the knowledge of the premises' management and despite conditions that should prevent this from happening. Several reports have been filed by local residents to the noise team as well as the police and anti-social behaviour team.

I notice that the licence does not mention any conditions with regards to drinking and smoking outside. In the past, this venue allowed punters to regularly leave premises with drinks in cups (I have several videos and photographs documenting this), further encouraging anti-social behaviour.

### prevention of public nuisance

Vandalism has been noted in the immediate adjacent area, including the Crossway Church; I often witness people freely urinating outside my window. There is now widespread of littering and food waste along Maldonado Walk/ Eagle Yard and often see broken bottles on the ground in the morning. I feel there is a cumulative effect that is taking place, by granting licences to so many premises all selling alcohol which is making the area unsafe and perpetrates anti-social behaviour.

This particular venue had a full brass band playing on a weekday back in July (something which I have raised then and still waiting for a follow-up from the council).

Looking at the licence, I noticed no condition is set to a limit of people smoking outside, no condition of limiting the amount of people inside the premises, no condition of having security at the door (only two doors down, there was a stabbing recently) and no condition asking the premised to keep a record of complaints and incidents. There is also a complete lack of dispersal policy.. The posters advising people to leave considerably are just not enough as historically this venue has caused many incidents of public nuisance in the past. I'm also concerned about the late opening on a Sunday: people have a right to rest and be ready to function on a Monday morning (I have to get up at 6 am, for example). Closing at 11 pm on a Sunday means people dispersing loudly until 11:30/midnight and that is not good enough. All these venues in Eagle Yard/ Maldonado Walk regularly apply for TENs with really late closures (4am for instance), which are automatically granted, then we residents have to deal with the nuisance of more anti-social and we are burdened with having to call the noise team and wait for them to turn up or having to write letters to the licensing team which get usually dismissed. I cannot also see any mention of disposing of glasses and rubbish in a sensible way that does not disturb the neighbours. (At the moment, I have to deal with this too from other the venues in the area).

The local residents are already suffering due to the nuisance caused by current venues. Additional licences further worsen the frankly current intolerable conditions in what is largely a residential area.

In the last 2 years since licences premises were agreed at Maldonado walk we have had one murder, 2 stabbings.

More recently in 4 September 2023 an attempted glassing of another person while leaving premises when a mass fight broke out (Video available for committee to see ) and on 02/10/23 one was left unconscious on our estate after a fight related to premises at Maldonado walk (photos for committee to see )

We have become so concerned with the situation at Maldonado a group of residents from draper estate and strata have set up a WhatsApp group where we share concerns and videos of incidents. I urge the committee to look at some of these videos to see what the we are experiencing on both draper and strata estates. And to consider if it is any way appropriate to have another licensed.

Police and local councillor Martin Seaton have witnessed some of problems we are experiencing.

Crime and disorder

On so many numerous occasions, I have seen people taking drugs outside various establishment.

I have witnessed on numerous occasions people leaving the establishments and having verbal arguments while extremely drunk.

I have witnessed on numerous coassions, people completely drunk and completely incapable of walking because of the amount of alcohol they have consumed.

Anti social behaviour

On so many numerous coassions I have been woken up by people, shouting and arguing with each other while leaving the premises.

On numerous occasions, I have seen the door man stand by, while people were standing outside smoking and shouting and laughing creating nuisance and anti social behaviour. The door men never intervene to stop this.

On numerous occasions, I have seen men urinating after leaving the club. Sometimes up to a dozen at a time right outside the church in view of the whole estate where children live.

I was told by another witness that the chef came out of club and urinated outside.

On numerous occasions, I have seen and heard, music emanating from persons cars who have left premises and getting into their cars parked outside of club. Then, sitting for long periods of time with music on high volume.

### Health and safety

On numerous occasions, I have seen men urinating after leaving the club. The area stinks of urine behind Crossways church.

People on the estate fear for their safety when certain establishments are open because the area has become a centre for crime and anti social behaviour, since licensed premises were opened.

### Protection of children from harm

The constant noise and anti social behaviour from ponce, is making difficult for children to sleep at night on our estate. They are witnessing fights, people urinating and high amounts of anti social behaviour.

Children from all these premises are seen regularly playing football in car park where cars are moving around.

We are completely overwhelmed with licensed premises in a small area which are attracting criminals including drugs dealers.

I also urge the committee, to see photos of area which show the very close proximity of to residential areas, and consider a saturation policy for immediate area. Strictly limiting licensing hours for this area of Eagle Yard.

I urge the committee if minded to agree another licenced premises should put in the following conditions.

As local resident we have concerns that some Licensing premises in Maldonado walk were very regularly over legal capacity therefore we request-

That they have CCTV inside to monitor numbers/capacity.

I am writing to object to the license application for license number 881493 at Los Arrieros De Pito Ltd, Arch 144, Eagle Yard / Hampton Street. SE1 6SP.

I am a resident at whose residence overlooks the premises at Arch 144. Over recent years local residents have experienced a number of serious issues with licenses issued to businesses at this address. The location is problematic for a licensed premises as the sale of alcohol creates numerous anti-social problems such as drunkenness, fighting and shouting late at night which prevents residents from sleeping. The problems created by the previous business at this location severely affected my mental health due to sleep deprivation and additionally prevented me from working from home due to noise in daytime hours.

The cumulative effect of adding yet another licensed premise to Eagle Yard is significant - customers often wander from one establishment to another, loitering in the street being rowdy and chatting to door staff. Neighbouring premises have created a lot of crime in the area over the last few years including two stabbings and a machete attack. All venues have the common issues of overcrowding venues, playing loud recorded music without adequate sound proofing, staying open later than the licensed hours and have no adequate dispersal policies. I strongly oppose adding yet another similar venue to the area as experience shows that it will most likely exhibit the same behaviour. I particularly oppose the Sunday night opening until 23:00 as the real time that customers leave the streets will likely be after midnight which is too late for people who need to work on Monday mornings.

To whom it may concern,

I am objecting to this licensing application on the following grounds:

prevention of crime and disorder / public safety

As you are well aware, and as the police will hopefully have indicated in their own representations, this application is in an area that has seen criminal activity linked to licensed properties over the years - from illicit activity inside venues, to chaotic spillouts and assaults in the street, and even a murder.

This causes distress to local residents, and is an unnecessary draw on police resources, further contributing to crime and disorder elsewhere in the borough. While this is a 9pm licensing application, no one I know believes that the applications won't come for later hours in due course. And that they will be granted if an existing license is in place. Further - we know that TENS are increasingly used by the businesses in this quarter, which can result in late night disturbances on many weekends, and establishing more of a habit of later drinking here can only increase TENs temptation.

# • prevention of public nuisance

As mentioned above, the licensed premises contribute to antisocial behaviour with unenforced/unenforceable dispersion policies for their customers. You will be aware of the concerns this has caused. If not, please ask Cole Martin Seaton (copied)

I know that many of my neighbours find it difficult to believe that this venue won't morph into something more like that already owned by the director making this application. I trust you are aware of the other interests.

It would be extremely disappointing if the committee were to again ignore the views of residents and the police, if I understand their position correctly. If you do choose to ignore the views of those who have to live and work with the consequences of committee licensing decisions, then I would ask that any new license applies the same variations recently discussed with other license holders in this row. In particular, please require that:

- A) noise monitoring is installed from day 1 we anticipate TENS applications and noise nuisances and the council does not have the resources to attend in a timely manner. This would help to get ahead of the lack of council resources to supervise licensee behaviour.
- B) cameras are installed from day 1, so that police and licensing staff can monitor for compliance with licensing conditions after the fact. This would help to get ahead of the lack of council resources to supervise licensee behaviour. Ideally this would also

cover the yard, with audio, so you can see when employees of one or more venues rev up their scooters every Monday night at around midnight.

- C) detailed dispersal policy, which can be overseen by internal CCTV
- D) minimal use of outside space perhaps limited to 9pm if it must be granted.

Further - in any event, please do not proceed without getting input from Cllr Seaton, who has spent significant time on this issue and witnessed a small sample of the difficulties we are all living with as a result of the councils licensing decisions and the inability of the council and police to bring multiple venues into line with the best practice behaviours we see from other night time economy venues such as Pineapple and Theo's.

I also urge the committee to consider a saturation policy for immediate area. Strictly limiting licensing hours for this area of Eagle Yard. This yard was previously a quiet courtyard overlooked by hundreds of bedrooms. The council has enabled its transformation into a source of noise, anxiety, and physical violence. A policy to reverse this consequence - surely not the committee's intention - can be the only ethical response if Southwark still considers wellbeing a guiding principle for policy.

To reiterate my position - I welcome a healthy mixed town centre economy. And we have had some excellent night time economy neighbours over the years. But the committee and the council has demonstrably failed to deliver for the wellbeing of residents overlooking this yard for over half a decade, and I live in hope that I will see a change in policy direction one way or another.





Dear licencing Committee,

I am writing to express my objection to the proposed licence mentioned above.

In the short time since I moved to \_\_\_\_\_\_, I have witnessed and endured various disturbances associated with the aforementioned premises. These incidents include patrons leaving the premises in an intoxicated state, disruptive shouting during late-night hours (10pm to 6am), physical altercations, public urination against nearby structures such as the church and the East facade of Sherston Court, and even late-night brass band performances directly under my windows at 11pm.

As a result, I am regularly woken up at night, and I avoid the area when returning home in the evening because I don't feel safe. Many neighbours have the same experience.

Neighbours that have lived in the estate for longer said that the conditions that are imposed with the licence are not respected by the establishment. Based on this and my experiences, I object to the licence as we all know it will create anti-social behaviour.

If the licence is granted, I kindly request that the Licensing Committee consider the following measures:

- Limiting the number of patrons allowed inside.
- Prohibiting the installation of tables outside.
- Prohibiting musical instruments to be played outside the premises.
- Requiring designated staff to monitor the exterior to prevent disruptive behaviour such as shouting and public urination.

I urge the Committee to not only consider these suggestions but also implement effective monitoring and enforcement mechanisms to ensure compliance with any imposed restrictions.

I trust that the Licensing Committee will take these concerns into serious consideration during the review process, and prioritise the safety and well-being of the neighbours.

### NOTICE OF DECISION

#### LICENSING SUB-COMMITTEE - 26 AUGUST 2021

SECTION 17 LICENSING ACT 2003 PONCE'S CORPORATION, ARCH 144 EAGLE YARD, HAMPTON STREET, LONDON, SE1 6SP

#### 1. Decision

That the application made by Ponce's Corporation Limited for a premises licence to be granted under Section 17 of the Licensing Act 2003 in respect of the premises known as Ponce's Corporation, Arch 144 Eagle Yard, Hampton Street, London SE1 6SP be refused.

#### 2. Reasons

The licensing sub-committee heard from the licensing officer. He stated that trading standards had withdrawn their objections to this application. Their objections were not considered at this meeting. He stated that the premises had previously held a licence under a company that went into liquidation. As the licence was not transferred within the time limits, the licence had lapsed. The applicant was the designated premises supervisor of the liquidated company and that the premises had operated under a number of temporary event notices (TENs) in the interim.

The licensing officer stated that the Metropolitan Police Service and the licensing responsible authority objected to the application on the grounds that it undermined the prevention of crime and disorder and the prevention of public nuisance licensing objectives. He went on to say that seven objections were raised by other persons namely, residents and their associations. Their objections also pertained to the prevention of crime and disorder and the prevention of public nuisance. He stated that conciliation had not be achieved. He directed the licensing sub-committee to the relevant pages of his report. The licensing officer confirmed that the applicant had provided a dispersal policy that morning and had confirmed an accommodation limit of 80.

The licensing sub-committee heard from the applicant. He stated that he was the manager and owner of Ponce's Corporation and said that his business is like a family. He said that he employed 8 to 10 people and, if the licence application were refused, they would become unemployed.

He explained that he had to close the business for one year due to Covid-19, but he managed to keep things afloat. He said that the problems with the residents and noise concerned other businesses and not his. He said that he would be happy to speak with the residents and would be happy for residents to approach him with any problems they may have.

The applicant said that his security staff also had to address issues relating to patrons from other establishments who would congregate, make noise and drink outside his premises. He stated that the police attended his premises as there had been 100

people or so, in the car park and he asked the police for help to remove them. He denied that his premises was responsible for the noise nuisance and said that those people in the car park were not his patrons as he only allowed 30 customers in his premises during covid. He went on to say that, he had no objection to the police attending his premises. He said that if the police pointed out mistakes he had made, those mistakes would be rectified

The applicant stated that he does not use the patio area, which could be seen on the premises plan submitted with his application. He said that up to five people could go outside to smoke. The applicant stated that usually he would have up to 60 people inside the premises and that presently, he seats 40 people to make allowances for the Covid-19 provisions.

The licensing sub-committee queried whether 80 people could be seated within the premises and estimated from the scaled plans that approximately 40 or so people could be seated within the premises.

In relation to the Covid-19 breaches that had taken place at his restaurant, the applicant stated that the council gave advice which he subsequently followed. He confirmed that presently, he was operating as a restaurant and that the kitchen closes at 23:00. In relation to breaches of his previous licence condition to serve alcohol with food, he stated that his patrons ordered food with their drink but then would order another glass or bottle of alcohol that would outlast the food. The applicant confirmed that he would not use single use plastics wherever possible.

The licensing sub-committee heard from the licensing responsible authority officer. The licensing officer stated that that she had concerns around this application due to previous complaints. The licensing officer compared the previous license with the current licence and noted that the applicant did not agree the conditions for food to be served with alcoholic drinks nor did he specify in good time the accommodation limit or dispersal policy in this application. The licensing officer had concerns around the restaurant's lack of condition to serve alcohol with a meal. It was noted by the licensing officer that this was the same condition that had been previously breached under the old licence. She also stated that the majority of the complaints surrounding this application concerned the allegation that the applicant was running the restaurant as a bar.

The licensing sub-committee heard from the Metropolitan Police Service. The police were of the view that the premises was not operating as a bona fide restaurant. The police took the view that a bona fide restaurant would not have attracted as many complaints as this premises had. The police stated that the premises had a dual role in that it would start as a food led establishment and then at some point during the evening/night would turn into an alcohol led establishment. The police officer explained that on 11 July 2020, police and other responsible authorities attended the premises to find amplified music being played, people dancing, drinking and that no social distancing being exercised. On that occasion, the police witnessed Covid-19 and licence breaches as food was not being served with meals to persons seated.

On 21 May, 25 June and 19 September 2020, the police and other responsible authorities attended the premises and witnessed further breaches of the licence and Covid-19 Regulations. The police went on to submit that it was their belief that the Ponce's Corporation would not adhere to any conditions on their licence given its

conduct under the previous premises licence and breaches that occurred whilst the premises was operating under TENs.

The licensing sub-committee heard from three of the residents. They were concerned that the granting of a licence would result in nuisance. Resident 1 disputed that only five people were allowed to smoke outside the premises as suggested by the applicant. The resident stated that the restaurant routinely opened later than the time on the licence and that his patrons would fight and argue outside the premises.

Resident 2 explained that the premises is situated a long way from the nearest public highway, that it is accessed by a private alleyway that runs parallel to the railway arches and that the venue directly opens out to the yard behind the Strada Tower. He said the restaurant is bounded by Drapers Yard and Crossways Church. He stated that the location provided a natural space for patrons to congregate and that the acoustics in that area meant that the noise is amplified disproportionately and, heard by the residents on the other side of the yard.

He pointed out to the licensing sub-committee that the licence application says café and restaurant, however the new signage outside the premises says bar and restaurant. He stated that the two terms gave different impressions. He said theoretically, the premises comfortably seated 40 people as per the submitted application plan, but could not hold 80 people in restaurant conditions. He went on to say that 80 people could be accommodated if they were standing; but those conditions would not make the premises a restaurant. Resident 2 pointed out that the social media marketing of the premises showed a DJ in bar/club like setting. He stated that the advert did not look like a restaurant.

Resident 3 stated that she attended the premises on two occasions asking them to close the fire doors to stop the music emanating from the premises. She believed the music systems had been upgraded as the noise levels had significantly increased as she could now hear the DJ speaking. She said that she had witnessed fighting by patrons and that patrons and staff urinated outside the premises. She said the premises is known for throwing a good party. She accepted that it was a restaurant up to approximately 8 pm but after that, it was a club.

The applicant said that he did not ordinarily have a DJ but would hire one on special occasions such as weddings and birthdays. He said that his patrons would not dance to the music and that he would hire a DJ once or twice a month.

The licensing sub-committee formed the view that the objections put before it could not be allayed by the applicant being made subject to any conditions. The licensing sub-committee were not confident that the applicant would adhere to any conditions placed on his licence due to the way the applicant had conducted himself and the premises whilst previously holding a licence and more recently, the way he conducted himself and the premises under TENs.

In reaching this decision, the licensing sub-committee had regard to all the relevant considerations, the four licensing objectives and; considered that its decision was appropriate and proportionate in all the circumstances.

### 3. Appeal rights

The applicant may appeal against any decision:

- a. To impose conditions on the licence
- b. To exclude a licensable activity or refuse to specify a person as premises supervisor.

Any person who made relevant representations in relation to the application who desire to contend that:


- a. The licence ought not to be been granted; or
- b. That on granting the licence, the licensing authority ought to have imposed different or additional conditions to the licence, or ought to have modified them in a different way

may appeal against the decision.

Any appeal must be made to the Magistrates' Court for the area in which the premises are situated. Any appeal must be commenced by notice of appeal given by the appellant to the justices' clerk for the Magistrates' Court within the period of 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision appealed against
