RECOMMENDATION

1. That council assembly considers and agrees the nominations for the awards of Freedom of the Borough as set out in the closed report.

BACKGROUND INFORMATION

2. The council has power under Section 249 (5) of the Local Government Act 1972 to confer the title of “Freeman of the Borough” on persons who have, in the opinion of the council, rendered eminent services to the borough. For the purposes of the Act ‘person’ includes organisations. The constitution (3A.21) provides for council assembly to confer the title of Freedom of the Borough.
3. The council must agree such conferment by resolution passed by not less than two thirds of the members present at a meeting specially convened for that purpose with notice of the purpose being set out in the summons for the meeting.
4. The council has power under Section 249(4) to spend a reasonable sum as thought fit for the purpose of presenting an address or a casket containing an address to such Honorary Freeman (including those conferred on organisations).
5. The Honorary Freedom of the Borough is the highest award the council can bestow. The council has always considered nominations based on individual merit.
6. Council Assembly agreed on 30 October 2002 the following criteria for conferment of the Freedom of the Borough.
 - That nominations may be received from councillors, officers, MPs, outside organisations and members of the public who are on the council’s Electoral Register.

- That nominations be limited to one per person/organisation and that they must show by example that the nominee is a “person of distinction who has rendered eminent services to the borough”.
 - That there be no restriction as to how often this award may be conferred.
7. Nominations are initially considered by the Constitutional Steering Panel which then makes recommendations to a specially convened meeting of the Council Assembly.
 8. If Council Assembly agrees to confer the honour, then a ceremony for presentation of the Honorary Freedom of the Borough is arranged. As previously agreed, this ceremony will take place to coincide with Annual Meeting of the Council (incorporating Mayor Making) and the presentation of the Southwark Civic Awards at Southwark Cathedral on Wednesday 20 May 2026.
 9. A framed ornate scroll of honour is presented to honorands. Individuals (but not organisations) are also entitled to wear a Free Citizen’s ceremonial robe at civic ceremonial events.
 10. The office of Honorary Freedom of the Borough does not convey with it any legal rights or responsibilities other than a ceremonial role at civic functions. Conditions apply to an award conferred on an organisation (see Appendix A).
 11. Nominations for the Freedom of the Borough listed below have been received, and any additional late nominations will be circulated. All nominations received need to be considered by this meeting of the Constitutional Steering Panel.

KEY FACTORS FOR CONSIDERATION

12. Three nominations for the Freedom of the Borough listed have been received and are recommended to the Constitutional Steering Panel. These are listed in the closed report.

Community, equalities (including socio-economic) and health impacts

Community impact statement

13. This report is not considered to contain any proposals that would have a significant impact on any particular community or group. The Freedoms of the Borough are intended to be a demonstration of the council’s respect for persons of distinction who have rendered eminent services to the borough.

Equalities (including socio-economic) impact statement

14. This report is not considered to contain any proposals that would have a significant equalities impact.

Health impact statement

15. This report is not considered to contain any proposals that would have a significant health impact.

Climate change implications

16. This report is not considered to contain any proposals that would have a significant impact on climate change.

Resource implications

17. Occasional Honorary Freedom of the Borough ceremonies can be managed within existing staff and financial resources. Combining the presentation ceremony with Annual Council, Mayor Making, and the Southwark Civic Awards will greatly reduce the costs that would otherwise be incurred as heretofore the Freedom of the Borough has been a specially organised event.
18. The cost of the framed ornate scroll which each honorand will receive is currently in the region of £200. The purchase of a ceremonial robe will not be required as these are only worn by individual honorands and the council already has an adequate supply.
19. Additional costs may be incurred should there be a civic reception following the presentation ceremony, to which honorands and their guests are invited. In recent years these receptions have significantly reduced in cost due to the serving of a more modest selection of food and drinks.

CONDITIONS APPLYING TO AN AWARD CONFERRED ON AN ORGANISATION**

- A. The award does not provide any rights or privileges to the recipient.
- B. The award is not of itself an endorsement of any services or goods provided by the organisation.
- C. The granting of the award does not entitle the recipient to use the official logo of the council or the borough's coat of arms.
- D. Use of or reference to the award in any advertising or promotional activity is subject to the prior approval of the council. The council reserves the right to withdraw the award in the event of unauthorised use or reference to the award.
- E. When an award is granted to an organisation it may not be used in any way to suggest that individuals associated with the organisation are themselves in receipt of the award.
- F. Where an organisation ceases to exist or ceases to operate in the activity recognised by the award it is automatically withdrawn. The award is not transferrable.
- G. The award does not signal that the council will act as a referee for the organisation or the individual honoured.
- H. All recipients, including organisations, are expected to uphold the principles of the civic functions of the authority and to encompass the diversity of our communities.
