The £89,840 will be sourced from the support grant that the Ministry of Housing, Communities and Local Government (MHCLG) provided: for those Clinically Extremely Vulnerable (CEV) residents. There are measures in place to ensure that support for these residents who need it can still be provided at the end of the period covered.


