Seven representations were received regarding this scheme:

- One part objection related to the cycle lane preventing deliveries and access to homes alongside the cycle route.
- One was supportive of the scheme and wants for it to be made permanent.
- One objected to the suspension of the parking bay for solo motorcycles on Southwark Bridge Road.
- One objected to part of the scheme due to limited access to Lant St, Bittern St, Weller St, Trundle St and Mint St.
- One objected to the removal of the motorcycle bay on Southwark Bridge Road and that Southwark has not followed the correct procedures.
- One objected to the removal of the motorcycle bay on Southwark Bridge Road.
- One local organization (a faith based group and place of worship) asked for the segregated cycle lane to be removed to accommodate loading and unloading outside of their building.

The Council will work with all those who made the representations to provide further provision of a motorcycle bay nearby Southwark Bridge Road. Officers will work with those who require access to their premises to make amendments to the design where safe to do so. Additional places to safely unload/ load and access to premises will also be explored to support local groups and the needs of local organisations.
