I am writing regarding the application for extended late night refreshments via Nine Food Group at 35 Vestry Road.

I object to the application based on the following concerns related to the licensing objectives:

## (i) The prevention of crime and disorder:

In this heavily residential area, I am concerned at the potential for disorderly behaviour if numbers of people congregate around the premises. Many customers would be purchasing food when returning from local bars and clubs - where alcohol is involved, the possibility for inappropriate behaviour is increased, leading to an increase in anti social behaviour and risk of crime – shouting, swearing, urinating in the street, fighting and aggression.

### (ii) Public safety:

The same concerns apply to this objective as for objective (i). In addition, increased late night traffic will cause both risk to public safety and nuisance.

### (iii) The prevention of public nuisance:

We have already seen disturbance associated with this takeaway venue; increasing road traffic, mopeds and taxis on these quiet streets, plus groups of clientele walking from Camberwell and Peckham to the site, increasing footfall at night, often with loud discussions or purchasing takeaway to consume on the street, with associated rubbish. Pizza boxes are left on the street, in front gardens, or in residents own rubbish or recycling facilities. Delivery drivers add to pollution, rubbish and noise on the street.

There must be a real concern that residents will be caused a serious noise nuisance in the early hours of the morning from delivery drivers and customers. Many of the flats over the premises and opposite the premises are occupied and stand to suffer especially from the noise and rubbish.

# (iv) The protection of children from harm

This is a particular concern in a family area. Families for all ages live here and many have young children who need to have established sleep patterns, uninterrupted by noise in the small hours, regardless of days of the week, not just school days.

The location is in the middle of densely populated, quiet residential housing. A business whose hours of business are late at night is not compatible with this location.

Thank you for your letter dated 14 April 2023, explaining the position.

Accordingly, I wish to object to the extension of Pizza Hut's operating hours based at 35 Vestry Road, London SE5 8PG on the following grounds:

- Public safety: increased traffic to the quiet residential area until late at night (2 am on weekends); increased number of people on the street late at night, potential drunk and disorderly conduct.
- The prevention of public nuisance: increased noise pollution from idling motorcycles and scooters in direct breach of night time permitted noise levels.
- The protection of children from harm: increased level of pollution and harmful toxic chemicals emitting from idling motorcycles and scooters directly under the residents' open windows.

I received a note in the post detailing the application Pizza Hut have made to extend their late night refreshments to midnight during the week and 2am on the weekends.

The premises is already open till 11pm everyday of the week. This has already ldt to an increase in noise pollution and rubbish on the streets compared to when the establishment was a Fish and Chips takeaway.

I have serious concerns about the further increase to opening times for the following reasons,

- 1. Traffic on our road would increase during the early hours of the morning, specially on the weekends.
- 2. Noise pollution and disturbing the peace from:
  - a. people waiting for their delivery and motor vehicles (the premises is on a hill so motor bikes would need to rev which is very loud)
  - b. the premises is very small so there is a strong likelihood of spillage into the road and corners of neighbouring roads (mine)
- 3. Again, premises does not have indoor facilities so would further increase rubbish being left on the road and street as no catering for this inside, this also applies to urination etc.
- 4. Unreasonable hours this is a residential area so most of the neighbours are young families with full time working parents, sleep will therefore be impacted
- 5. Uncommon for this area, as it is a residential area it has very few establishments and none are open this late.

I'm writing regarding the license application 879784 made by Nine food group Ltd, relating to the Pizza Hut premise at 35 Vestry Road, London, SE5 8PG.

The license concerns the extension of opening hours to 00:00 on Monday - Friday and 02:00 on Saturday & Sunday.

As a local resident, living very close by to the premises, I am making representation relating to prevention of public nuisance.

The licensed premises is in an overwhelmingly residential area, and is not suitable for a late night pizza takeaway/delivery business.

The proposed extension to opening hours will result in an increase in noise to nearby residential properties (due to delivery drivers coming/going later in the evening) and potential antisocial behaviour (resulting from customers coming to pick up food late at night). Since the opening of the premises a few months ago, we've seen a significant increase in littering and associated noise from customers and delivery drivers.

The only other commercial premises in the vicinity is a convenience store, which closes at 10.30pm each evening, and a cafe/restaurant which closes at 9.30pm on Friday & Saturday.



I have been notified that Pizza Hut at 35 Vestry Road is looking to extend its operating licence to midnight in the week and 2AM at the weekend, from an already very late 11PM.

Since Pizza Hut has established itself at 35 Vestry Road, the mopeds which deliver the pizzas resulted in a significant amount of noise down Linnell Road, often while my wife and I are trying to sleep given current closing times. Allowing a licence extension beyond 11PM would add noise and nuisance. I must at this point also note that drivers often tend to take breaks down on Linnell Road, making even more noise once they receive an order.

Pizza hut has knowingly opened its premise in a very quiet and residential area. 

I'm getting in touch about an application by Pizza Hut/Nine Food Group to extend opening hours at their Vestry Road store.

I understand they plan to extend their opening hours throughout the week and weekend, so that they will be open till midnight on weekdays and till later on weekends.

My concerns are that this will:

- Worsen through traffic by delivery drivers throughout the weeknights (and weekends)
- Add to the increasing challenge of finding parking on weekends during unrestricted hours on Vestry and Linnell Rd.
- Significantly increase the likelihood of antisocial behaviour in a primarily residential area
- Increased rubbish on the street. Waste from the restaurant being dumped on Linnell rd/Vestry rd is already rife, and this will worsen the problem.
- Make it difficult for families during weeknights (as a parent of two little ones the noise issues are definitely a concern and have become more noticeable since the store opened).

While I understand the wish to maximise revenue from the Vestry Road unit, I'd suggest it's unlikely to be a popular decision and will inconvenience and frustrate a lot of local residents. It also appears that Pizza Hut's Kennington store is only open until midnight on weekends, so am unclear why their Camberwell store should be open later.

Dear Southwark Licencing.

I write to object to the granting of a licence extension in respect of extended hours on weekdays (midnight) and weekends (2 a.m.).

In addition to the complaints you will already have received concerning flytipping related to the Pizza Hut on Vestry Road, extended opening hours for an establishment in a primarily residential area should not be allowed. None of the other businesses in this area operate extended hours and the risk of increased noise, and the potential for anti social behaviour linked to a sole focal point is unacceptably high.

For the residents of the facing flats, the flats above the establishment and the roads, including Linnell Road on which I live, this creates unnecessary risks as outlined above.

If Pizza Hut is arguing for the extension because of some alleged unmet demand, it should be required to show that the hours are necessary. Pizza Hut already has hubs which can meet the demand if any can be shown for late night delivery. The Kennington hub already has advertised opening hours to midnight, but not beyond, every night.

I hope that you will take account of the strength of feeling about this. Largely residents did not object to having Pizza Hut opening, but that was with sensible opening hours which maintained the residential nature of the area at night. Pizza Hut's application, if granted will undermine the residential nature of the area.

Dear licencing team,

I have been notified that Pizza Hut at 35 Vestry Road is looking to extend its operating licence to midnight in the week and 2AM at the weekend, from an already very late 11PM.

Since Pizza Hut has established itself at 35 Vestry Road, the mopeds which deliver the pizzas resulted in a significant amount of noise down Linnell Road, often while my wife and I are trying to sleep given current closing times. Allowing a licence extension beyond 11PM would add noise and nuisance. I must at this point also note that drivers often tend to take breaks down on Linnell Road, making even more noise once they receive an order.

Pizza hut has knowingly opened its premise in a very quiet and residential area. In doing so, both Pizza Hut and the council licencing team must consider the surroundings they have decide to operate within. Should they have wished to operate longer hours, a premise could have been found in an already noisy location -ei Camberwell Church Road, where public transport and other traffic continues in high volumes throughout the night.
