## **DETAILS OF THE REPORT**

Title and brief description of the nature of the business to be considered: Urgent Approval to Sign & Engross Settlement Agreement between the Council and Circet Itd (formerly known as KN Networks Services Ltd) for completion of works on Blenheim Grove building: PC 14 August 2023

- A. The Employer entered into a contract with the Contractor (formerly called KN Network Services Limited) dated 12 September 2019 (the "Contract") for the refurbishment and two storey extension and commercial/retail fit-out of 1-8 Blenheim Grove, railway arches and limited hard landscaping works and all associated works at Peckham Rye Station Square (the "Works").
- B. A dispute has arisen between the parties pertaining to project delays, claims for extensions of time or loss and expense, and the alleged occurrence of defective work.
- C. The parties have agreed to settle matters in relation to the above as set out in a settlement deed.
- D. The deed provides that the new Practical Completion date (Works are completed and site vacated) of 14 August 2023.
- E. Works are currently continuing on site but at a gradual pace. Now that an agreement has been reached, both parties are to sign the deed and engross as soon as possible for works to continue in earnest to achieve the new Practical Completion date.
- F. Any further delays will put the PC date at risk thereby triggering contract mechanisms for penalties.
