	<p>For quite some time now, Planet Nollywood have been causing considerable disturbances through excessive noise, which is not only disturbing the peace but also impacting the quality of life for the residents in the surrounding area. The noise emanates primarily during late hours of the night and frequently continues into the early morning, making it difficult for residents to sleep or enjoy their homes in a peace.</p> <p>This complaint is therefore, being submitted on the ground of preventing public nuisance.</p>

	<p>Planet Nollywood is a nightclub and their current license permits them to play music until the early hours of the morning. The issue is that the music and bass penetrates the surrounding residential homes. Despite having double glazing and wearing earplugs, the sound cannot be dampened.</p> <p>This is not a one off issue but is something that is happening regularly. Myself, and other residents have called the council and police on multiple occasions in order to get support in dealing with this. We have had zero success and guidance as to how this issue can be rectified.</p> <p>Not only is the music very loud, but after the club is closed the streets becomes full of people who continue to make a noise and to play music.</p> <p>According to Planet Nollywood's license agreement, the premise is required to adhere to specific regulations and restrictions concerning noise levels, operating hours, and the well-being of the neighborhood. Unfortunately, these stipulations have been blatantly disregarded, causing severe inconvenience to those residing nearby.</p> <p>The disturbances caused by the premises have resulted in increased levels of stress, sleep deprivation, and a general deterioration in the quality of life for the residents. This situation is untenable and demands immediate attention and corrective action from the council.</p> <p>I kindly request that the council investigate this matter thoroughly, conduct noise level measurements, and take the necessary steps to ensure that residents of Southward Council are able to enjoy their homes. As concerned residents, we have the right to enjoy a peaceful and quiet environment within our community, and it is crucial that the council upholds these rights.</p>
