We support the application for the review of the premises licence, submitted by an 'other person' (that being a local resident) under The Licensing Act 2003 (the Act), in respect of the premises known as The Planet Nollywood (t/a The Bike), 319 Camberwell Road, Camberwell, London, SE5 0HQ.

### **1. The application**

The application has been submitted in respect of the prevention of public nuisance licensing objective and states the following grounds for the review (verbatim):

*"For quite some time now, Planet Nollywood have been causing considerable disturbances through excessive noise, which is not only disturbing the peace but also impacting the quality of life for the residents in the surrounding area. The noise emanates primarily during late hours of the night and frequently continues into the early morning, making it difficult for residents to sleep or enjoy their homes in a peace. This complaint is therefore, being submitted on the ground of preventing public nuisance.*

*Planet Nollywood is a nightclub and their current license permits them to play music until the early hours of the morning. The issue is that the music and bass penetrates the surrounding residential homes.*

*Despite having double glazing and wearing earplugs, the sound cannot be dampened. This is not a one off issue but is something that is happening regularly. Myself, and other residents have called the council and police on multiple occasions in order to get support in dealing with this. We have had zero success and guidance as to how this issue can be rectified.*

*Not only is the music very loud, but after the club is closed the streets becomes full of people who continue to make a noise and to play music. According to Planet Nollywood's license agreement, the premise is required to adhere to specific regulations and restrictions concerning noise levels, operating hours, and the well-being of the neighborhood. Unfortunately, these stipulations have been blatantly disregarded, causing severe inconvenience to those residing nearby.*

*The disturbances caused by the premises have resulted in increased levels of stress, sleep deprivation, and a general deterioration in the quality of life for the residents. This situation is untenable and demands immediate attention and corrective action from the council.*

*I kindly request that the council investigate this matter thoroughly, conduct noise level measurements, and take the necessary steps to ensure that residents of Southward Council are able to enjoy their homes. As concerned residents, we have the right to enjoy a peaceful and quiet environment within our community, and it is crucial that the council upholds these rights.”*

## **2. The extant premises licence**

### **2. The Locale**

The premises are located at the north eastern corner of Camberwell Green. Camberwell Green is a busy town centre, major vehicular thoroughfare and major bus transport hub. There are a typical variety of town centre shops in the locale, many licensed premises and a high density of residential dwellings. Photographs showing the premises and its immediate surroundings (including residential dwellings adjacent to, and in close proximity to, the premises) are attached as appendix 2. A map of the local area is attached as appendix 3. The map shows the proximity of high-density residential blocks / housing estates in the locale.

### **3. This council's Statement of Licensing Policy**

According to sections 6 & 7 of this council's statement of licensing policy 2021 – 2026 (the SoLP), the premises fall within the Camberwell District Town Centre.

#### **4. Our comments in support of the review application**

Our comments relate to the promotion of the all of the licensing objectives.

Since 2019 the Licensing Unit has received 12 complaints from 9 different local residents regarding noise nuisance, anti-social behaviour and disorder arising as a result of the premises' operation. Although these complaints comprise allegations that have not been substantiated, they indicate that local residents do perceive that problems arise directly as a result of the premises' operation. Details of the complaints are attached in appendix 4.

In addition to the statement provided by the review applicant in their application, we have also received a Computer Aided Dispatch (CAD) report, and Crime Report Investigating System (CRIS) reports from Southwark Police Licensing Unit relating to allegations / instances of crime and disorder regarding the premises, and in the immediate vicinity of the premises. The reports are dated as follows as set out in appendix 5 –

Our position is that many of the existing licence conditions require amending to make them more robust and enforceable, and that such amendments may address the concerns of review applicant and also ensure the orderly operation of the premises.

We recommend that the licensing sub-committee considers the amendments to existing licence conditions, and the inclusion of additional licence conditions, as set out in appendix 6.

We further recommend that the premises' closing time is amended to 22:30 hours on Sunday (with licensable activities finishing at the same time except for the on sale of alcohol as detailed below).

We suggest that the hours permitted for the on sale of alcohol should be amended to:

## **Annex 1 - Mandatory conditions**

**100** No supply of alcohol may be made under the Premises Licence -

- a. At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
- b. At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.

**101** Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence.

**102** The admission of children to films given under this licence must be restricted in accordance with the recommendations of the British Board of Film Classification or of the licensing authority itself.

**107** Any individual carrying out security activities at the premises must be licensed by the Security Industry Authority. This does not apply where the premises are being used primarily as a Qualifying Club under a Club Premises Certificate, under a Temporary E vent Notice, or primarily as a cinema, restaurant or theatre.

**485** (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -

(a) games or other activities which require or encourage, or are designed to require, encourage, individuals to -

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined

by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional poster or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; and

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

**487** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

**488** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either

(a) a holographic mark; or

(b) an ultraviolet feature.

**489** The responsible person shall ensure that -

(a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) Beer or cider: 1/2 pint;

(ii) Gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) Still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available,

**491** 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purpose of the condition set out in paragraph (1):

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula

$$P = D + (D \times V),$$

where-

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence;

(ii) the designated premises supervisor (if any) in respect of such a licence; or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(iv) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(v) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax; (2) the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

## **Annex 2 - Conditions consistent with the operating Schedule**

**110** No statutory regulations for music and dancing shall apply so as to require any licence for the provision in the premises of public entertainment by the reproduction of wireless (including television) broadcasts or of programmes included in any programme service (within the meaning of the Broadcasting Act 1990) other than a sound or television broadcasting service, or of public entertainment by way of music and singing only which is produced solely by the reproduction of recorded sound is permitted.

**111** This licence provides for the provision of private music and dancing entertainment that is promoted for private gain;

**112** This licence allows for the premises to remain open for non standard timings as stated on the days below. Christmas eve, Christmas day, new years eve, New years day and August bank holidays 06.00 finish.

**113** This licence allows for the premises to remain open for the sale or supply of alcohol for non standard timings as stated below on the following days: Christmas eve, Christmas day, new years eve, New years day and August bank holidays 05.30 finish.

**114** This licence allows for the premises to extend the following licensable activities for non standard timings as stated below on the following days: Provision of regulated entertainment Plays, Films, Indoor Sporting Events, Live Music, Recorded Music, Performances of Dance, Anything of a similar description. Provision of Entertainment Facilities Making Music, Dancing: on Christmas eve, Christmas day, new years eve, New years day and August bank holidays 05.30 finish.

**115** This licence allows for the premises for the provision of late night refreshment for non standard timings stated below on the following days: Christmas eve, Christmas day, new years eve, New years day and August bank holidays 05.30 finish.

**178 a.**The emergency lighting battery shall be fully charged before the admission of the public.

b.The emergency lighting battery shall be fully charged before the admission of the public

c.In the event of failure of the normal lighting

(i)If the emergency lighting battery has a one hour capacity the public shall leave the premises within 20 minutes unless within that time the normal lighting has been restored and the battery is being re-charged; or

(ii)If the emergency lighting battery has a 3 hour capacity the public shall leave the premises within one hour unless within that time the normal lighting has been restored and the battery is being re-charged.

d.The public shall not be re-admitted to the premises until the normal lighting has been fully restored and the battery fully recharged except

(i)Where the emergency lighting battery has a one hour capacity and if the failure of the normal lighting was fully rectified within 20 minutes of failure and the battery is being re-charged; or

(ii)Where the emergency lighting battery has a 3 hour capacity and if the failure of the normal lighting was fully rectified within one hour of failure and the battery is being re-charged.

**180 a.**The premises shall be effectively ventilated.

b.Where the ventilation system is designed to maintain a positive air pressure within that part of the premises, that pressure shall be maintained whenever the public are present in that part of the premises.

**288** That CCTV system be installed upon the premises and be maintained in good working condition and be continually recording at all times the premises are in use under the licence. The CCTV system must be capable of capturing an image of every persons who enters the premises.

**289** That all CCTV system footage shall be kept for a period of thirty-one (31)days and shall, upon request, be made immediately available to Officers of the police and the council.

**290** That SIA registered door supervisors, at least one of whom shall be female, shall be employed at all times after 22:00 on Friday, Saturday and Sunday Nights until the terminal hour as detailed on the premises licence. They must be provided with hand held metal detection units in order to ensure searches are carried out in respect of all admissions to the premises, whether members of the public or performers and their assistants. One door supervisor will be supplied with a mechanical counting device to ensure the maximum accommodation limit is not exceeded and to monitor the number of persons on the premises at any one time.

**293** All bar staff shall be trained in the prevention of incidents and accidents and a record of the dates and names of the staff trained kept.

**298** That signs shall be displayed in the entrance foyer to the premises that state 'Drugs Free Zone' and "NO SEARCH - NO ENTRY"; Management reserve the right to refuse entry'.

**302** That all matters relating to drugs shall be in accordance with the Metropolitan Police Best Practice Guide on the handling of drugs in pubs and clubs;

**303** That the Licensee shall require any outside promoter hiring the premises to complete the 'Hire Venue Agreement' provided by Southwark Council, and provide a copy of the completed agreement to the Police and the Licensing Unit a minimum of 14 days prior to the date of hire

**307** That the total number of persons that may be accommodated at any one time within the premises shall not exceed a maximum of four hundred & sixty (460) persons; comprising of a maximum of three hundred & Fifty (350) persons in the ground floor and one hundred & ten (110) persons in the first floor.

**311** That notices shall be displayed and announcements made requesting that customers leave the premises in a quiet and orderly manner

**312** Customers shall used no outside area after 22:00hrs other than those who temporarily leave the premises to smoke a cigarette. Those who do temporarily leave for this reason shall be subjected to the requirement of a further search.

**313** That there shall be no movement of musical or amplification equipment, to or from the premises, between the hours of midnight and 08.00

**319** That the entrances are lobbied and windows are to be kept closed at all times while the premises are in use under the licence.

**324** Maintain contact with a local taxi firm on condition they are able to respond quickly to remove customers from the premises quickly and quietly.

**325** That after 00.00 children under 16 shall not be admitted in any area where alcohol is sold and consumed

**326** That all appropriate staff shall be trained in the age identification scheme required at the premises and

records of training shall be kept and made available for inspection by authorised officers of the Council

**327** That signs shall be displayed informing customers and staff that sales of alcohol will not be made to under 18s and that age identification will be required

**328** That all staff employed to sell or supply alcohol shall be 18 years of age or over

**329** That "Retailer Alert Bulletins" issued by the Portman Group under the Group's Code of Practice on the Naming, Packaging and Promotion of Alcoholic Drinks shall be complied with

**330** That a soft drinks pricing policy shall be compiled intended to ensure that consumption of soft drinks by young people is not discouraged. The policy and revisions to the policy shall be provided to the Council's Trading Standards Service

**332** All children on the premises under 18 will be accompanied by a parent or responsible adult at all times

**333** That an age identification scheme shall be established and maintained. The scheme shall

a. Require the production of evidence of age (comprising any PASS accredited card or passport or driving licence) from any person appearing to responsible staff to be under the age of 16 who is attempting to gain admission to any area where alcohol is sold or consumed after 21.00

b. Require the production of evidence of age (comprising any PASS accredited card or passport or driving licence) from any person appearing to staff engaged in selling or supplying alcohol to be under the age of 18 and who is attempting to buy alcohol

**336** A personal licence holder shall be on the premises at all times that intoxicating liquor is supplied

**340** Recorded music will be reduced to background level during the wind down period to create a mood change to help with the dispersal of patrons.

**341** That the premises licence holder and/or designated premises supervisor join and support a local pub watch scheme should there be one in existence for the area in which the premises is located.

**343** Additional waiter/waitress will be employed to collect empty bottles immediately

**344** That an ID scanning system to the reasonable satisfaction of police be installed and maintained. The system should be capable of sharing information about banned customers with other venues, identify the hologram of an ID and read both passports and ID cards, able to identify fake or forged ID documents to a reasonable standard. The system will be in operation at all times whilst the ground floor of the premises are in operation under the premises licence. All persons that enter the premises including all SIA registered door supervisors, patrons, DJs and associated staff will be scanned and have their details recorded on the system. The details shall be stored and made available on request for a period of no less than 31 days. That the ID scanning system will be in operation for all events on the ground floor from 22:00hrs save for those events where 7 days notice has been given to the police Licensing Unit and Police consent is obtained. A copy should be made available on request by authorised officers from the council or police.

### **Annex 3 - Conditions attached after a hearing by the licensing authority**

**8AB** All staff involved in the sale of alcohol shall be trained in the agecheck 'Challenge 25' policy. **809** A sound limiter shall be installed at the premises with levels set in conjunction with the council's environmental protection team.

**840** Drinks shall not be allowed outside the premises at any time.

**8AD** That at least two SIA registered door supervisors, at least one of whom shall be female, shall be employed at all times after 22:00hrs on Friday, Saturday and Sunday nights until the terminal hour as detailed on the premises licence. They must be provided with hand held metal detection units in order to ensure searches are carried out in respect of all admissions to the premises, whether members of the public or performers and their assistants. One door supervisor will be supplied with a mechanical counting device to ensure the maximum accommodation limit is not exceeded and to monitor the number of persons on the premises at any one time

**841** That the premises will serve all beverages in polycarbonate or plastic containers with the exception of bottles of still or sparkling wine which shall be allowed in the restaurant area only.

On Monday 22 November 2021 police were called to Nollywood on Camberwell Road SE5 male stating he has been assaulted by the security.

Officers attended and spoke to all parties involved. The security stated both males were at the venue and left. Both came back after a short time again trying to get back in. The security stated they have a timing of 02:30 and after this no one is allowed into the venue. The security stated the door to the venue was closed and one of the males has yanked the door open. The security has told both males that they are not allowed back in as the venue is closed now.

Both males were still trying to get in and one of the male thrown a punch but did not hit him. The security guard stated he has then pushed the male away. The security guard stated the only yer shorter male was holding a drink and thrown it over him. The male has then said he is going to call the police to the security guard and called police.

Officers spoke to both males who had been drinking and did not speak English. Officers get on the phone to language line and the male stated they were at the venue and left. Shortly after they went back because they had left something

behind and the security would not let them in. The male stated he was then punched by the security guard. When asked if there was any other altercation and the male stated no and when asked about the drink he stated he did not have any drink. The male did not have any visible injuries and did not require LAS.

There is CCTV at the location however this can

only be accessed by the boss who was not at work so officers were unable to view the CCTV. [REDACTED] who is also the security witnessed this incident. [REDACTED] stated both males were trying to get into the venue after refused entry and VIW1 has thrown a punch at the security guard and there was a little tussle after. Both males then walked away.

There was counter allegation and officers could not view the CCTV at the time to confirmed what s happened and who started the fight. VIW1 was told this will be reported and CCTV will be checked and officers will update him. Both parties does not know each other or where they live. Both parties left in different direction so there is no risk. This can now be dealt with in slow time by MIST team.

No statement was taken from the victim as both were drunk and did not speak English.

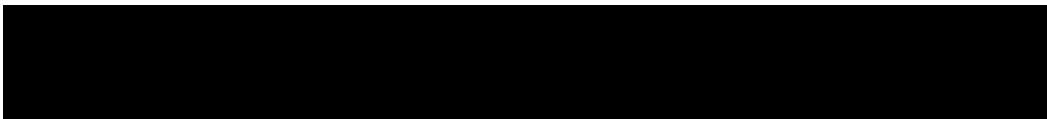

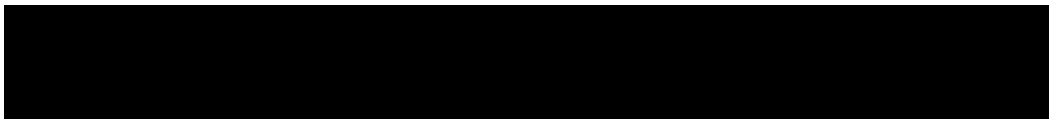

Most if not all people on scene were intoxicated.

[REDACTED] was walking away from the scene and there were lots of members of the public were pointing at [REDACTED] and then pointing at their injuries. Based on this it was believed [REDACTED] was involved in the incident in some way.

Officers then went to stop [REDACTED] from leaving but he kept trying to move past officers and then when officers when to place [REDACTED] in

handcuffs he fought against officers and had to be PAVA d and taken to the ground. [REDACTED] was then arrested on suspicion of GBH and violent disorder due to the number of walking wounded and people in the area.

One other male [REDACTED] was also pointed out by members of the public who were present during incident to have been involved in assaulting people. He was also arrested on suspicion of GBH and violent disorder.

Officers then tried to speak to the other members of the public but only one or two of them could speak English and there were no Spanish speaking officers available. From what could be ascertained [REDACTED] had assaulted various people and there was also mention of two phones being taken. Due to the language barrier it was difficult to get one clear account of what had happened and it was unknown if each person spoken was an independent witness.

Alleged stolen phone descriptions were recorded and they did not match the phones of the arrested suspects and suspects were able to unlock phones in custody and it would be unlikely that in that time phone password/pins could have been changed.

After suspects were arrested and victims triaged and made their way to hospital a member of the public approached police and showed them video footage taken from her phone which showed part of the incident. This footage has been uploaded onto the cris.

He stated that he had been at a club in Camberwell called NOLLYWOOD. He was there with a number of friends and was there until it closed, around 4am. He walked into CAMBERWELL GREEN with his female friends and saw that a fight was taking place. He did not know the person who was fighting however he knows his friends as they are all Spanish speakers. One of [REDACTED] female friends ran towards the fight as she knew the people and she wanted to separate them. [REDACTED] followed her to make sure she was ok and to also try to split up the fight. Once

he got there someone threw the contents of a glass at him and grabbed him by the front of his shirt. He punched the person in self-defence before being dragged away by his friend. He then saw that another one of his friends was being sick so he went and helped her, that s when he was arrested. He denied ever being in possession of a glass bottle or hitting anyone with a bottle.

He was asked to provide the names of the other people involved however he declined to provide any details.

He was then shown the footage of the fight and he identified himself in the footage. He stated that the fight started inside the park, and it was inside the park that he punched the male in self-defence. He was asked why he did not extract himself from the fight and he stated that he does not know. It was put to him that he was not acting in self-defence and that he was willing getting involved in the fight. He state that there was no reason for him to keep getting involved in the fight. As a group they had drunk several bottles together, he declined to state whether he had taken any drugs.

He stated that if he were to see these people again then they would probably ask him about what happened and then they would have a laugh about it.

### **Existing premises licence conditions 288 & 289 to be replaced with the following:**

- That a digital CCTV system shall be installed at the premises, shall be maintained in full working order and shall be continually recording at all times that the premises are in use. The CCTV system must be capable of capturing a clear facial image of every person who enters the premises. The CCTV system shall be correctly time and date stamped. The CCTV system shall cover all interior and exterior areas of the premises, including the frontage of the premises, and shall collect clearly defined / focused footage.
- That all CCTV footage shall be kept for a period of thirty one (31) days and shall be made immediately available to responsible authority officers on request.
- That a member of staff shall be on duty at all times that the premises are in use, who is trained in the use of the CCTV system and who is able to view, and download to a removable storage device, CCTV footage at the immediate request of responsible authority officers.
- That clearly legible signage shall be prominently displayed where it can easily be seen and read by customers advising to the effect that CCTV is in operation at the premises. Such signage shall be kept free from obstructions at all times.

### **To add the following new condition to the premises licence:**

- That all relevant staff shall be trained in their responsibilities under the Licensing Act 2003, the promotion of the licensing objectives and the terms and conditions of this licence. Records pertaining to such training ('the staff training logs') shall be kept at the premises, shall be updated every 6 months and shall be made immediately available to responsible authority officers on request. The training logs shall include the trainee's name (in block capitals), the trainer's name (in block capitals), the signature of the trainee, the signature of the trainer, the date(s) of training and a declaration that the training has been received and understood by the trainee.

### **Licence conditions 290 & 8AD to be replaced with the following:**

- That a minimum of three (3) SIA registered door supervisors will be employed at the premises at all times after 22:00 hours on Friday and Saturday. They will be employed to control entry to the premises, to deal with the searching / scanning of customers, to deal with any anti-social or disorderly behaviour at the premises, to de-escalate confrontations, to assist with emergency escape from the premises, to deal with the ejection of people from the premises, to assist management in liaising with the police regarding instances of crime and to assist with ensuring that the premises' dispersal policy is adhered to. When deployed, they shall remain at the premises at least until the premises close and all patrons have vacated the premises. The door supervisors shall be easily identifiable.

- That all security and management / supervisory staff shall be supplied with, shall be trained in the use of, and shall use at all times the premises are in operation, 2-way radios ('walkie-talkies') to aid in the safe operation of the premises.
- That counting devices shall be used by the security staff who are controlling customer entry to the premises to keep an accurate count of the number of people at the premises and to ensure that the premises' accommodation limit is never exceeded. Staff using the counting devices should be able to determine the number of people at the premises immediately on the request of responsible authority officers.
- That metal detectors shall be used by the security staff who are controlling customer entry to the premises regarding all entries or re-entries to the premises. Any person refusing a metal detection search shall not be permitted entry / re-entry to the premises.

Licence condition 293 to be replaced with the following:

- That an incident log shall be kept at the premises to record details of any of the following occurrences at the premises:
  - i. Instances of anti-social or disorderly behaviour
  - ii. Calls to the police by the premises' staff
  - iii. Any complaints received
  - iv. Ejections of people from the premises
  - v. Visits to the premises by the local authority or emergency services
  - vi. Any malfunction in respect of the CCTV system
  - vii. All crimes reported to the venue
  - viii. All seizures of drugs or offensive weapons
  - ix. Any other relevant incidents

The incident log shall contemporaneously record the time, date, location in the premises and description of each incident, the printed and, if possible, signed name of the person reporting the incident and any action taken in respect of the incident. The incident log shall be available / be accessible at the premises at all times that the premises are in use, and shall be made immediately available to responsible authority officers on request. All relevant staff employed at the premises shall be trained in the use of the incident log. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.

Licence condition 298 to be replaced with the following:

That clearly legible signage shall be prominently displayed at the entrance to the premises where it can easily be seen and read by customers stating: 'Drugs Free Zone', 'NO SEARCH - NO ENTRY' and 'The management reserve the right to refuse entry'. Such signage shall be kept free from obstructions at all times.

Licence condition 302 to be replaced with the following:

- That clearly legible signage shall be prominently displayed where it can easily be seen and read by customers in the premises' main floor areas and toilets advising to the effect that the taking of illegal drugs will not be tolerated at the premises. These notices shall be kept free from obstructions at all times.
- That a zero tolerance policy to illegal drug use will be implemented and maintained at the premises. All staff shall be trained in respect of the premises' drug policy. A record of such training shall be kept in the staff training logs at the premises which shall include the printed name of the trainee and the date that the training was received.

Licence condition 303 to be replaced with the following:

- That any 3<sup>rd</sup> parties / members of the public using the premises for a promoted or private event must complete a venue hire agreement with the premises licence holder. The venue hire agreement shall include the full name and address of the hirer, copy of valid photo identification of the hirer (kept on file in accordance with data protection requirements), the hirer's signature and the date that the venue hire agreement has been signed. The venue hire agreement shall include all of the licensee's terms of hire. Such agreements shall be kept on file for 6 months from the date of the event and be made immediately available to responsible authority officers on request.

(Please note that there is no longer a 'Hire Venue Agreement' provided by Southwark Council as required by current licence condition 303).

Licence condition 307 be amended to read:

- That the total number of persons that may be accommodated at any one time within the premises excluding staff (the 'accommodation limit') shall not exceed a maximum of four hundred & sixty (460) persons in total; comprising of a maximum of three hundred & fifty (350) persons in the ground floor and one hundred & ten (110) persons in the first floor.

Licence condition 311 to be replaced with the following:

- That clearly legible signage shall be prominently displayed where it can easily be seen and read by customers, at all exits from the premises and in any external areas, requesting to the effect that customers leave the premises and locale in a quiet and orderly manner with respect to local residents. Such signage shall be kept free from obstructions at all times.
- That staff shall be trained to, and shall request if and when required, that customers behave at, and / or leave, the premises and locale in a quiet and orderly manner. Customers deemed by staff to be engaging in anti-social behaviour shall be asked to leave the premises. The details of such training,

including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.

Licence condition 312 to be replaced with the following:

- That any external areas of the premises will be closed to customers between 22:00 hours and 10:00 hours the following day except for up to a maximum of 5 people at any one time using the external areas after 22:00 hours to smoke only. All outdoor furniture must be rendered unusable by 22:15 hours each day.

Licence condition 313 be amended to read:

- That there shall be no movement of speakers, amplification or stage equipment, to or from the premises, between 21:00 hours and 07:00 hours the following day.

Licence condition 319 to be replaced with the following:

- That external doors at the premises shall be kept closed except to allow immediate, and emergency, access and egress to and from the premises.
- That windows at the premises shall be kept closed at all times that the premise are in use.

Licence condition 324 to be replaced with the following:

- That the telephone number / contact details for a local taxi service shall be available at the premises and provided to customers on request. Taxis shall be asked to park in an area that will minimise disturbance to local residents. Drivers of taxis that have been ordered to the premises will be instructed not to sound their horns in the vicinity of the premises to alert customers to their presence, or to idle their engines whilst waiting for customers.

Licence conditions 325 & 332 to be replaced with the following:

- That after 22:00 hours children under the age of eighteen shall not be permitted on the premises.
- That children under the age of 18 must be accompanied on the premises by a responsible adult at all times.

Licence conditions 326 – 329, 333, 8AB, 8AC & 8AI to be replaced with the following:

- That a challenge 25 scheme shall be maintained requiring that staff selling or delivering alcohol request that any customer who looks under 25 years old, and who is attempting to purchase or take receipt of alcohol, provides valid photographic identification proving that the customer is at least 18 years old. Valid photographic identification is composed of a photo driving licence, passport, UK armed services photo ID card, any Proof of Age Standards



Scheme (PASS) accredited card (such as the Proof of Age London (PAL) card) or any age verification card accredited by the Secretary of State.

- That all staff involved in the sale of alcohol shall be trained in the prevention of sales of alcohol to underage persons (including the prevention of 'proxy sales') and the challenge 25 scheme in operation at the premises. The details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- That clearly legible signs shall be prominently displayed where they can easily be seen and read by customers stating to the effect that a challenge 25 policy is in operation at the premises, that customers may be asked to provide proof of age and stating what the acceptable forms of proof of age are. Such signage shall be displayed at all entrances, points of sale and in all areas where alcohol is displayed for sale. The signage shall be kept free from obstructions at all times.
- That a register of refused sales of alcohol shall be maintained in order to demonstrate effective operation of the challenge 25 policy. The register shall be clearly and legibly marked on the front cover as a register of refused alcohol sales, with the address of the premises and the name of the licence holder. The register shall be used to record details of all refused sales of alcohol. The register shall be kept / be accessible at the premises at all times. The register shall be made immediately available for inspection at the premises to responsible authority officers on request.

Licence conditions 340 to be replaced with the following:

- That the sound level of any entertainment shall be attenuated to a quiet 'background' level at least 30 minutes prior to the premises closing on each day to create a 'winding down' period that will encourage customers to leave the premises.

Licence conditions 343 to be replaced with the following:

- That glassware and broken or waste glass / earthenware shall be cleared away as soon as possible on a continuous basis whilst the premises are in use. Staff shall be trained in this condition and the details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.

Licence condition 809 to be replaced with the following:

- That a sound limiting device (or similar equipment) shall be installed at the premises, be maintained in full working order and be in use at all times that the premises are in operation under this licence. All amplification equipment, entertainment devices and amplified instruments shall be routed through the sound limiting device (or similar equipment) which shall be calibrated so that the level of amplified sound at the premises does not cause a statutory or public nuisance. Particular regard must be given to the attenuation of bass

frequencies. Only management staff shall have access to the sound limiting device (or similar equipment) and shall be able to demonstrate that it is in use at the immediate request of responsible authority officers.

(Please note that the council does not help to calibrate sound limiting devices as is required by current licence condition 809.)

- That only management staff shall have access to any amplification equipment at the premises.

Licence condition 841 to be replaced with the following:

- That drinks served for consumption on the premises shall be decanted into multi-use polycarbonate / plastic receptacles, or into recyclable paper / card receptacles.

We seek that the following conditions are to be added to the premises licence:

- That an entry policy will be devised and maintained at the premises. A copy of the entry policy shall be kept at the premises with the premises licence and shall be made immediately available for inspection to responsible authority officers on request. The entry policy shall cover (but not necessarily be limited to):

- I. Safe customer entry to the premises,
- II. If / when applicable, searching / scanning of attendees,
- III. The barring of customer entry to the premises for any reason,
- IV. Restricted items (e.g. weapons / drugs or any other items restricted by the licensee),
- V. Pre-opening safety checks of the premises,
- VI. Dealing with overcrowding and / or crowd surges
- VII. Dealing with suspect packages

All relevant staff shall be trained in the implementation of the latest version of the entry policy and the details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.

- That a dispersal policy to assist with patrons leaving the premises in an orderly and safe manner shall be devised and maintained regarding the premises. A copy of the dispersal policy shall be accessible at the premises at all times that the premises are in operation. The policy should include (but not necessarily be limited to) the following:
  - I. Details as to how customer / staff egress at the premises shall be managed to minimise causing nuisance.
  - II. Details of public transport in the vicinity and how customers will be advised in respect of it.
  - III. Details of the management of taxis to and from the premises.
  - IV. Details of the management of any 'winding down' period at the premises.

- V. Details of the use of security and stewarding in respect of managing customer dispersal from the premises.
- VI. Details of any cloakroom facility at the premises and how it is managed.
- VII. Details of road safety in respect of customers leaving the premises.
- VIII. Details of the management of ejections from the premises.
- IX. Details of how refuse / waste in the local vicinity arising through the operation of the premises will be cleared up (e.g. flyer clean up, post event clean up).

All relevant staff employed at the premises shall be trained in the latest version of the dispersal policy. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises. The dispersal policy shall be made immediately available to responsible authority officers on request.

- That a comprehensive noise management plan (NMP) shall be undertaken. The NMP shall be kept at / be accessible at the premises and made available to responsible authority officers immediately on request. The NMP shall be reviewed at least annually, or when any substantive alterations are made to the premises, and the result of the review shall be recorded in the NMP. The review shall be dated and signed off by a member of management staff. All relevant staff employed at the premises shall be trained in the latest version of the NMP. Details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
- That a qualified professional acoustic consultant is employed to calibrate the sound limiter at the premises and to arrange the layout, installation and orientation of the speakers at the premises so that sound transmission to adjacent buildings is minimised. A signed and dated report from the acoustic consultant shall be devised regarding the calibration of the sound limiter and any amendments to the speaker installation at the premises. A copy of the report shall be kept at the premises and provided to responsible authority officers immediately on request. Once the sound limiter has been calibrated, its control settings shall not be altered at any time, except for when altered by a qualified professional acoustic consultant.
- That the premises' management shall regularly monitor any external areas of the premises and the immediate frontage of the premises on Camberwell Road and Camberwell Green and take all necessary steps to ensure that noise from patrons, or the premises' operation, does not cause disturbance or nuisance of any kind. A log of such monitoring including the printed name of the person who undertook the monitoring, the date & time of the monitoring and any observations or actions taken subsequent to the monitoring shall be kept at the premises and be made immediately available to responsible authority officers on request.
- That the operation of the premises shall not give rise to public, statutory or nuisance of any other kind at any time.

- That clearly legible signage stating a dedicated contact telephone number for the premises shall be prominently displayed where it can easily be seen read by passers-by. The signage shall state to the effect that the phone number shown can be used to contact the premises in respect of any complaints regarding the operation of the premises. Such signage shall be kept free from obstructions at all times. The telephone in respect of this number, if a mobile phone, must be on the duty manager's person at all times.
- That there shall be an identified duty manager on site at all times that the premises are in operation. They shall sign in at the beginning of their shift in a staff log. The log shall include their printed name and the time & date that they sign in. The log shall be kept at the premises and be made available to responsible officers immediately on request. 'Identified' in this condition means known to all members of staff.
- That all relevant staff will be trained in conflict resolution and incident de-escalation, and to deal with any disorderly incidents in a calm manner. The details of such training, including the printed name(s) of the trainee(s) and the date(s) that the training was given, shall be recorded in the staff training logs at the premises.
