Southwark Council recently consulted on improvements to the street environment and layout on Harper Road.

We aim to improve the environment of the street, providing better crossing facilities, improving the feeling of safety, and reducing traffic speeds.

Harper Road forms part of the route for Southwark Spine, a key strategic north to south route between Dulwich and Borough. We will improve facilities for those cycling, walking and wheeling along Harper Road.

The consultation opened on 24 April 2023 and closed on 21 May 2023.






Headline Results

We sent flyers to 3,824 addresses around Harper Road and received 103 responses. This is a 2.6 % response rate, which is low for this type of consultation.

In addition to the flyers sent out, officers hosted an on street drop in session to speak to passersby about the proposals. We spoke to over 50 people at this event and gave each a flyer about the proposals.




2. Do you support the measures we are proposing on this section of Harper Road, between Borough High Street and Newington Gardens?

The response to this question suggests that the majority of respondents support the changes on this section of the road, but many would like to see changes such as introducing a modal filter to reduce the vehicle movements and other interventions such as changing the type of speed humps and introducing parklets. All additional comments will be reviewed and changes will be incorporated into the next design stage.


Q3. Do you support the measures we are proposing on this section of Harper Road between Newington Gardens and the parade of shops?

The majority of respondents stated that they supported the changed at this section. Some of the additional comments included not removing the existing traffic island outside of the Mosque and put a crossing in, install cycle lanes, install more planting, check the width of the cycle bypass and install a modal filter. All additional comments will be reviewed and changes will be incorporated into the next design stage.
