Recommendation	That the Cabinet Member for Climate Emergency, Clean Air & Streets:	
	1. Approves the non-strategic traffic and highway improvements and complementary streetspace measures detailed in the appendices to this report and summarised in Table 1 implemented by way of powers under the Highways Act 1980 ("1980 Act"), the Road Traffic Regulation Act ("1984 Act"), and orders made under 1984 Act subject to the outcome of any necessary statutory consultation and procedures.	
	2. Instructs officers to make the necessary Traffic Management Orders ("TMO") in accordance with sections 6 and 124 of the 1984 Act subject to statutory consultation carried out pursuant to the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 ("1996 Regulations").	

3. Notes that in the event objections are received following statutory consultation, a further report will be presented to the Cabinet Member in order for him to determine whether to proceed with the making of the TMOs.
4. Authorises officers to exercise discretion as to whether or not to hold a public inquiry in the event objections are received related to any of the proposed TMOs following statutory consultation pursuant to Regulation 9(1) of the 1996 Regulations.
5. Authorises officers to carry out the necessary statutory notification in accordance with sections 90A to 90F of the 1980 Act and the Highways (Road Humps) Regulations 1999 ("1999 Regulations").
6. Authorises officers to exercise discretion as to whether or not to hold a public inquiry in the event objections are received in respect of the proposed traffic calming measures ("road humps") in accordance with section 90C(4) of the 1980 Act.

REPRESENTATIONS RECEIVED

A representation was received from a local resident requesting the two existing cycle hangars near the proposed Evelina Road crossing could be relocated to the opposite side of the road to reduce the impact of the loss of parking spaces. Also that the proposed loading bay could only be operational at certain times and at all other times to be available for resident parking.

A representation was also received expressing concern about the loss of seven parking spaces to accommodate the Evelina Road crossing. The local resident made a number of suggestions including:

- removing the drop kerb on Kimberley Avenue just after the loading bay, with the rationale that the carriageway will be raised to footway level, the drop kerb would not be required.
- relocating the cycle hangars to the other side of Kimberley Avenue. All of the proposed spaces will be lost on the west side of Kimberley and moving the bike sheds to the east side would balance out the impact.
- Relocating the hangars to the footway.
- Querying why the loading bay is required.
- Provision of a storage facility for refuse bins associated with businesses and residents adjacent to new zebra crossing.

ADDITIONAL ADVICE RECEIVED

Consideration will be given to relocating the two existing cycle hangars to the opposite side of the road but they will still need to be in the carriageway rather than reducing the available footway width. Consideration will also be given to the remaining representations.

The request for a refuse storage area has been passed to the Waste & Cleaning team.
