## STATUTORY OFFICERS AND PROPER OFFICER FUNCTIONS

#### 1. Statutory Officers

Legislation requires local authorities to appoint certain officers with statutory responsibilities. These appointments and the officer to whom the council has allocated responsibility are listed below.
