To take the opportunity that arises from the roll out to change the collection frequency for commingled recycling from street-based properties to fortnightly in order to make the service more efficient. 3. To introduce blue 240 litre wheeled bins in place of blue boxes for all suitable street-based properties to provide additional capacity for recycling.
