Most of its regular shoppers visit the market on a Saturday morning before the arrival of the hoards of tourists. These shoppers mostly use their vehicles and park on the streets in surrounding area. The amount of shopping they buy would not make it easy for them to use public transport.

In the past they have used the Jubilee Market area of the Borough Market off Winchester Walk, which acted as a small car park. However, in 2009 Network Rail took part of the Market to construct a bridge hence some traders were relocated to the former car park. Since the demise of this car parking facility the shoppers have had no alternative but to park in the surrounding streets. Due to the increased difficulty in parking some cases of these shoppers have decided not to shop at Borough Market. 


Last Saturday, I noticed a sign warning that you were contemplating changing the parking regulations around Borough Market, with the aim of preventing parking on single yellow lines on Saturday morning. I wish to object to such a proposal.

As you must be aware, there is almost no facility to park around the Market, and the single yellow lines are the only option. Borough Market is a fantastic bonus to London, which has provided me and my family with all our food for the last few years. I buy all my vegetables, fruit, meat, fish and bread between about 9 am and 10 am each Saturday. It is impossible for me to carry the shopping on public transport. I know from many years visiting the market that there are lots of people like me – I recognise the other shoppers and their cars.

What are to do? There is nowhere to pay, nowhere to park and public transport is not an option (unless for "boutique shopping").

And what is gained? There are very few residents, so it cannot be protecting them. There is no car park to pay, so Southwark get no money (except through tickets I suppose, but this proposed reform cannot be to encourage illegal parking). Some of the traders have said they will leave (they can pay £45 per day for a small private car park, but they worry that the customers who buy, as opposed to the tourists who take photographs, will simply stop coming)

So – you will damage Borough Market, one of London's great attractions, and a wonderful revival of an historic market. Please do not proceed with this misconceived and pointless plan.

I am the resident of Flat 11, 5B Bear Lane, SE1 0UH.

I was allocated this property by Southwark Council via the bidding system under the social tennant scheme.

I would like to categorically state that when the property was advertised by the council on their magazine/website for bidding, there was no mention of parking restrictions. Upon bidding, we viewed the property with a representative of Bromleigh Housing Association. During that visit, and subsequent contacts, there was no mention whatsoever of any off-street parking restriction. In fact it was mentioned by the representative that although we would not be entitled to the underground parking (reserved for private owners), we will be able to attain a resident permit from the council and park off-street.

We then moved in the property, have been living here as a social tennant for over two years and have been to attain the off-street parking permit from the council.

I have become aware per this notice (BANKSIDE "C1" CONTROLLED PARKING ZONE REVIEW), that I will not be entitled for resident permit in the future.

I would like to strongly object on the following grounds:

- 1. We were not made aware of any clause regarding off-street parking by the developer or the council when the property was advertised and shown to us and had we known at the time, our decision on whether to choose this property would have been different. This is negligent on the part of council when advertising the property for bidding.
- 2. There is no mention of any such restriction by my landlord (Bromleigh Housing Association) in the contract.
- 3. Since we are social tennants and were allocated this property by the council, we reserve the right to have entitlemnt to the council resident permit like every other council tennants living in the area.

In conclusion, I would like to re-iterate our entitlement for off-street parking and state strongly our objection to this ammendement basis that we were never informed of any clause mentioned in the

notice.

Please ensure this be noted in your records for any future action.
