6. DEVELOPMENT MANAGEMENT ITEMS

6.1 88 BERMONDSEY STREET, LONDON, SE1 3UB

PROPOSAL

Change of use of first and second floor of building from B1 (Office) non-residential language school (Use Class D1). Works include a roof level extension and outdoor roof top amenity area with balustrade.

RESOLVED:

That application 11-AP-1845 be deferred as the drawings in the report had discrepancies and would require amendment.

6.2 48-50 WESTON STREET LONDON SE1 3QJ

PROPOSAL

Retention of use as Class A2 (estate agent) on ground floor level.

The planning officer presented the application and councillors asked questions of the planning officer.

There was a statement from an objector and councillors asked questions

The applicant's agent made a statement and councillors asked questions.

There were no statements from local supporters of the application living within 100 metres of the site, or from ward councillors.

RESOLVED:

That application number 11-AP-3567 be approved subject to the conditions set out in the report and the following amendment and new condition:

1. That the reference to Sunday hours should be deleted.
2. That a condition be added, that the premises should not be a betting shop on the grounds of 3.2 Protection of Amenity and impact on the character of the conservation area.

Members asked that if appropriate separate advertising consent should be put before this committee.

Councillor Eliza Mann joined the committee.

7. TO RELEASE SECTION 106 MONIES TO DELIVER THE SHARD SOUTHWARK VOCATIONAL PROGRAMME

Members noted the report and recommended to Planning Committee:

1. That the £315,000 for workplace co-ordinators – Building London Creating Futures be released along with £100,000 for nursery and childcare facilities.
2. That a Grange Ward Councillor should be added to the project board.
3. That it is premature to release the £600,000 for training and employment without more information on which retailers and what courses would be available.
4. That youth groups from the Bermondsey Community Council area would benefit and that the available opportunities be communicated throughout the community council area.
