DECISION(S)

Decision taken as on paper with the exception of Southwark Refugee Project. Recommendation not to fund was overturned and an allocation of £30,000 to be made to the organisation for 2013/14

REASONS FOR DECISION

Impact of approval of the original recommendation would lead to closure of Southwark Refugee Project. In addition the impact on the client group is likely to be particularly detrimental. Award of £30,000 funding allows the organisation a period of transition whilst alternative sources of funding are sought

Since receiving the decision I have been informed that the figure referred to in Paragraph 24 of the report and in Appendix 1 has been revised, the new figure for the Blackfriars Settlement is £27,874. In addition, following the representation from Southwark Refugee project an allocation of £30,000 was agreed for 2013/14. The revised total figure is now £1,117,907.
