As the premises already holds a late night license and operates without incident, we do not currently feel additional general steps are required, but we would monitor the situation after any changes to see if there was anything that needed to be addressed

### **b) The prevention of crime and disorder**

As the premises already holds a late night license and operates without incident, we do not currently feel additional steps are required for the prevention of crime and disorder. We would monitor the situation after any changes to see if there was anything that needed to be addressed

### **c) Public safety**

As the premises already holds a late night license and operates without incident, we do not currently feel additional steps for public safety are required, but we would monitor the situation after any changes to see if there was anything that needed to be addressed.

### **d) The prevention of public nuisance**

There is the potential for off-sales to cause public nuisance, so we would limit sales to sealed bottles (not open containers). There is also the potential for later noise nuisance from later opening hours, but we have not received noise complaints in more than six years of operation with late hours to date, so would not expect this to be an issue.

### **e) The protection of children from harm**

As the premises already holds a late night license and operates without incident, we do not currently feel additional steps are required for the protection of children from harm. We would monitor the situation after any changes to see if there was anything that needed to be addressed.
