Police are in receipt of an application from the above for a variation to the Premises Licence to be granted under the licensing act 2003.

Some of the following conditions may have been already offered by the applicant as part of the operating schedule but the wording of each condition is vital to negate any ambiguity.

1. That a CCTV system be installed at the premises and be maintained in good working order and be continually recording at all times the premises are in use under the licence. The CCTV System must be capable of capturing a clear facial image of every person who enters the premises.
2. That all CCTV footage shall be kept for a period of thirty one (31) days and shall, upon request, be made immediately available to Officers of the Police and the Council.
3. That all staff are trained in their responsibilities under the licensing act 2003 and training records to be kept and updated every 6 months and shall, upon request, be made immediately available to Officers of the Police and the Council.
4. Suitable notices shall be displayed requesting people to leave the premises in a quiet and orderly manner so as not to disturb local residents.

5. Customers shall use no outside area after 23.00hrs other than those who temporarily leave the premises to smoke a cigarette and No more than 5 people at one any time.
6. No alcohol shall be consumed outside premises after 23.00hrs.
7. There shall be no new entry or re-entry to the premises after 01.00hrs.
8. That a Personal Licence holder is on the premises and on duty at all times that intoxicating liquor is supplied after 22.00hrs.
9. All licensable activities shall cease 30 minutes prior to the terminal hour.
10. A minimum of two (2) SIA registered Door Supervisors, shall be employed at all times after 20.00hrs till the terminal hour that the premises are in use under this licence.

The Following is submitted for your consideration, Police would welcome the opportunity to conciliate should the need arise.

Regarding your response to our Premises License Application (attached again for your reference), I was hoping to have a chance to talk to you regarding the conditions specified, but thought I would drop you an email as I haven't been able to reach you yet.

Most of the items specified are indeed already part of our Premises License, but one additional item is point 10, that door supervisors would be required after 20:00hrs.

We have tried door supervisors before, but found these actually lead to an increase in the frequency of incidents, which has fallen again since we have stopped (none of these were serious, but none would be preferable!).

Is this requirement essential for all premises opening past 2am? If so, we would gladly reduced the proposed hours to 2am at the latest if it would remove this condition and your representation.

If you could let us know your thoughts on door supervisors and hours, that would be great! If you have time for a call in the next few days, perhaps I could try you again so that we could discuss the variation submission?
