Annex 1 - Mandatory conditions

100 No supply of alcohol may be made under the Premises Licence -

a.At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or

b.At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended

101 Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence

Annex 2 - Conditions consistent with the operating Schedule

109 Alcohol shall not be sold or supplied except during permitted hours.

In this condition permitted hours means

a.On weekdays, other than Christmas Day: 08:00 - 23:00

b.On Sundays, other than Christmas Day 10:00 - 22:30

c.On Christmas Day, 12:00 - 15:00 hours, and 19:00 to 22:30hours

d.On Good friday, 08:00 - 22:30

The above restrictions do not prohibit;

i)During the first twenty minutes after the above hours the consumption of the alcohol on the premises;

ii)The ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;

iii)The sale of alcohol to a trader or club for the purposes of the trade or club; viThe sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces

127 Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied: a.With and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal; b.For consumption by a person residing in the premises or his guest and paid for together with his accommodation;

c.To a canteen or mess

340 Alcohol shall not be sold in an open container or be consumed in the licenced premises.

788 CCTV has to be installed and maintained and records kept for 30-31 days.

793 Recorded training scheme for staff that deal with alcohol sales.

834 Proof of age scheme to be put in place.

836 A personal licence holder shall be on the premises at all times that alcohol is sold
