### **RECOMMENDATION(S)**

1. That the Strategic Director of Environment & Leisure approves and awards the Peckham Pulse Healthy Living Centre Refurbishment contract to Vincent Stokes Ltd.

### **BACKGROUND INFORMATION**

- 2. The previously approved Gateway 1 report (18 August 2016), set out the procurement process for the appointment of Vincent Stokes to deliver the Peckham Pulse Healthy Living Centre building refurbishment project. The approved GW1 had recommended a single supplier negotiation with Vincent Stokes who is Sport and Leisure Management's (SLM) refurbishment contractor.
- 3. The works which will be undertaken at Peckham Pulse are summarised in the table below:

#### **KEY ISSUES FOR CONSIDERATION**

### **Description of procurement outcome**

5. As agreed in the approved GW1 the procurement route taken was a single supplier negotiation with Vincent Stokes who are SLM's refurbishment contractor.

## **Key/Non Key Decision**

6. This report deals with a key decision based on the value of the contract.

#### Policy implications

7. The contract provides continued support for the council's priority to improve the quality of leisure provision within the borough.

#### Tender process

8. As agreed in the approved GW1 the procurement route taken was a single supplier negotiation with Vincent Stokes who are SLM's refurbishment contractor.

#### Tender evaluation

- 9. Following the approval of the GW1 the council has worked with Vincent Stokes and SLM to develop detailed budgets and plans for the works which will be undertaken. The costings from SLM have been externally reviewed and validated by SLM's quantity surveyors.
- 10. As stated in the GW1, three procurement options were assessed based on the key objectives of the procurement strategy. The appointment of Vincent Stokes through single supplier negotiations was the most advantageous option to meet the procurement objectives. Those objectives were:
  - a. Best value for money ensuring the works are undertaken to a high standard
  - b. Minimising disruption and inconvenience to customers

- c. Experience in leisure centre refurbishments
- d. Time to mobilise the contract and complete works

### Plans for the transition from the old to the new contract

### Plans for monitoring and management of the contract

- 12. The contract will be managed by the Parks and Leisure Team who will ensure that the contractor complies with the specification of the contract. This will be achieved through regular site visits and site meetings, after which reports will be made back to the client.
- 13. A quantity surveyor will be appointed by the council as part of a separate, future procurement exercise.
- 14. Upon completion the new sports facility will be tested, and there will be a final site meeting with the contractor, project manager and the client representative to sign off the works.

# Identified risks and how they will be managed

15. The following risks, and management solutions have been identified:

Risk	Risk Level	How Mitigated
Procurement challenge due to not going out to competitive tender	Medium	The contract is below the EU threshold and legal advice has been sought which advises that the proposed procurement route is justifiable due to the strong business case and pretender estimate developed by Faithful and Gould.
Project delivery delayed	Low	A construction programme will be assessed to ensure that the project is delivered against the proposed programme. Project progress will be reported to the parks and leisure programme board on a monthly basis
Overrun of costs	Low	The works will be undertaken in accordance with a robust specification and a fixed price contract that will be aligned to the allocated Peckham Pulse budget. The quantity surveyor will provide regular financial reports and advice, and a value engineering exercise will be carried out if required.

# **Community impact statement**

16. Southwark leisure centres are primarily community leisure facilities that provide opportunities for local people to improve their health and well being by participating in sport and physical activity. Improvements to the environment within these facilities will have a positive impact on users as

they will have been refurbished and will be accessible to all. Reducing the carbon footprint of our facilities will have a positive impact on the environment as a whole.

#### **Economic considerations**

- 17. Vincent Stokes has the appropriate knowledge, experience and suitably qualified labour force.
- 18. A credit check has now been completed on Vincent Stokes to confirm that they are in a suitable financial position.

#### Social considerations

- 19. Pursuant to section 149 of the Equality Act 2010 the council has a duty to have due regard in its decision making processes to the need to:
  - (a) Eliminate discrimination, harassment, victimisation or other prohibited conduct;
  - (b) Advance equality of opportunity between persons who share a relevant protected characteristic and those who do not
  - (c) Foster good relations between those who share a relevant characteristic and those that do not share it.
- 20. The relevant protected characteristics are age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation. The Public Sector Equality Duty also applies to marriage and civil partnership, but only in relation to (a) above. The aims and objectives of this proposed procurement are intended to provide benefits for all sections of the community and it is not anticipated that any individual or group will be disadvantaged.
- 21. The council's intention is to include London Living Wage in this contract.

#### **Environmental considerations**

22. In accordance with the council's Corporate Plan objectives to increase recycling rates, and reduce carbon emissions, the contract arrangement will include sustainability requirements that would complement the sustainability performance measures that have been incorporated into the design of the building itself.

### **Market considerations**

- 23. Market considerations are as follows:
  - The successful tenderer is a private organisation
  - The successful tenderer has over 250 employees
  - The successful tenderer has a national area of activity

#### Staffing/procurement implications

24. There are no staffing implications as the client function will be funded from the parks and leisure team's revenue budget.

### Financial implications

- 25. The award of contract for refurbishment works at Peckham Pulse Healthy Living Centre will be funded from the leisure projects capital budget.
- 26. The total expenditure and sources of funding for the project will be monitored and reported on as part of the overall Capital Programme for 2016/17.
- 27. There are no additional revenue implications expected as a result of the proposed works. If any are incurred they will be contained within the existing maintenance budgets held by the leisure business unit in the environment and leisure department.

## Legal implications

28. The contract has been procured in line with the council's Contract Standing Orders and with all relevant statutory duties and powers.

### Consultation

29. Consultation for this contract has been undertaken between SLM and leisure services, departmental finance, legal and procurement. SLM will be the on-site co-ordinator with regard to all communications with the users and other visitors to the site. Customers to the centre will be advised that the works will be undertaken and the centre will remain open during the works.
