RECOMMENDATION

1. That overview & scrutiny committee considers a call-in request relating to the decision taken by the Executive on February 13 2007 in respect of the Community Support Voluntary Sector Commissioning Programme 2007/8.

BACKGROUND INFORMATION

- 2. On February 13 2007 the executive considered a report on the Community Support Voluntary Sector Commissioning Programme 2007/8 (attached as an appendix). The executive agreed that the funding recommendations for voluntary sector organisations delivering services under the Community Support Voluntary Sector Commissioning Programme for 2007/8 be agreed as set out in appendix 1 to the report.
- 3. On February 21 2007 the Chair of Overview & Scrutiny Committee Councillor Fiona Colley and three members of the Committee (Councillors Barrie Hargrove, Dominic Thorncroft and John Friary) requested call-in of the decision on the following grounds:
 - There was a failure of clarity of aims and desired outcomes. The Beormund Community Centre, the only community centre whose budget was cut, met all of the Council's stated criteria and provided a full service during the past financial year. It is not clear that it will be able to continue to provide such a comprehensive service as a consequence of the proposed budget cuts.
 - There was a failure to consult with those affected by the decision or to take advice from officers with regard to the decision. Centres affected by cuts had no opportunity to address the proposed cuts prior to the report being presented to the Executive by officers.

KEY ISSUES FOR CONSIDERATION

4. Requests for call-in should normally only be made if there is evidence that the decision was not taken in accordance with the principles of decision making as set out in the Constitution:

- Proportionality (i.e. the action must be proportionate to the outcome);
- Due consultation and the taking of professional advice from Officers;
- Respect for human rights;
- Presumption in favour of openness;
- Clarity of aims and desired outcomes;
- The link between strategy and implementation must be maintained;

Decision-making generally should have reference to the policy framework and be in accordance with the budget.

- 5. The Overview and Scrutiny Procedure Rules require the Committee to consider any call-in request and in particular whether or not the decision might be contrary to the policy framework or not wholly in accordance with the budget. Advice should be sought from appropriate Chief Officers including the Monitoring Officer and the Chief Finance Officer.
- 6. If, having considered the decision and all relevant advice, the Overview & Scrutiny Committee is still concerned about it, then it may either:
 - refer it back to the decision-making body [or officer to whom responsibility for that decision was delegated] for reconsideration, setting out in writing the nature of its concerns; or
 - refer the matter to Council Assembly if the decision is deemed to be outside the policy and budget framework.
- 7. The Executive Member with relevant portfolio responsibilities has been advised of this meeting.

LEGAL & FINANCIAL IMPLICATIONS

8. Rule 18.6 of the Overview and Scrutiny Procedure Rules requires a call-in to be requested by the Chair or Vice-Chair of the Overview and Scrutiny Committee plus three members of the Committee; the call-in request has been validly made in accordance with this rule.
